# BAGEL

SUPREME

It was mentioned that someone potentially had an allergic reaction at Bagel Supreme. Ms. Folco clarified the person had a personal reaction and wanted to know what was in the bagels and wanted them tested by a lab. She was told the town does not provide testing, but she could have the bagels tested herself. Ms. Folco clarified the State will soon be looking to adopt what the FDA has regarding allergens. For now, it's recommended food establishments have warnings labels and should keep a list of what's in the products they sell. There are no regulations on this now, but they are coming.

Mr. Tiffinger asked about the racoon complaint. Ms. Folco explained the County was informed there were racoons. TYCO went out to observe and found the racoons to be very docile. REHS sent a letter to the landlord. It was discovered that the open rooms that don't have doors, had food out. Ms. Folco mentioned these issues go back to DCA and local building code to determine why the property is in this condition and still operating.
