SALUTE TO THE FLAG AND MOMENT OF SILENCE:

MAYOR'S REPORT:

Mayor Kulmala Reported on the following items to the public:

- The Current water status is in compliance, the letter sent out last week was outdated information.
- A meeting was held with PSE&G and the Borough Engineer regarding the Road Paving Program. Bid Notices will go out next week, bid openings will be scheduled for the last week of April and work will start in May.
- The Seminole Avenue sidewalk project will be started soon.
- Bush Plaza Park work is progressing. The Flagpole and Clock are backordered and should arrive in approximately 5 months.
- Exit signs have been replaced for Exit 57 and Exit 58. Mayor Kulmala thanked the DPW for all the cleanup work.
- The NJ DOT is going to fix the guardrail on West Oakland Avenue and clean up all the garbage
- Mayor Kulmala advise the public that after the recent earthquake he ordered inspections of all of the Borough bridges, as well as the water and sewer systems.
- Mayor Kulmala advised the public that on April 4, 2024 he took a group of County Commissioners, Borough Professionals, Senator Schepisi, Commissioners Ortiz and Amoroso as well as the Mayor of Pompton Lakes on a tour of the area and sight where the Dump would be located.
- Mayor Kulmala advised the public that there will be monthly meetings on the progressions of the Patriot's Way Bridge Project.
- Kevin Boswell of Boswell Engineering explained the Consumer Confidence Report to the Public.

Mark Scanga 141 Lakeshore Drive, stated that the lakes are part of the Oakland Waterway and the residents around it need the Mayor and Councils help.

Liz Carletta 161 Lakeshore Drive, stated RML's fees are high, please help the residents with this cause, storm water runoff is a big part of the problem.

Trudi Derbyshire 181 Lakeshore Drive, RML will ruin us and destroy us. Please help.

Joseph Furio 24 Hiawatha Blvd, stated RML though money would solve the problem, we need cooler heads to make a reasonable agreement. He also stated there are Blue Heron Habitats that are protected by the DEP.

Greg Simon 99 Lakeshore Drive stated that there is a bald eagle family on the lake that is DEP protected as well.

Adam Elkin 147 Lakeside Drive stated taxes double, fees double, nothing goes to the infrastructure. He stated a storm water management plan for the lakes, dams, etc. as well as encumbered waterway, utilities all have a viable purpose and community needs assurances.

Chris Rosamond 127 Lakeshore Drive stated residents are willing to help, they are not asking for a favor, the group just needs help from the town.

Alexandria Evans 141 Lakeshore Drive stated Blue Heron live on the lake and there are fish spawning in a natural environment.

Telmo Bosi 14 Seminole Ave stated he supports the preservation of Mirror Lake.

Karen Nappi 29 Calumet Avenue stated that she loves the lakes and wants the towns help.

Andrey Klinchik 21 Calumet Ave stated that he loves the lake, the taxes and lake fees have doubled. Kid's fish there and it adds value to the town.

Liz Carletta 14 Rockaway Avenue, Can the Borough use Open Space funds to purchase the lake?
