MAYOR'S REPORT:

Mayor Kulmala reviewed the status of the Borough of Oakland's current projects:

- Mayor Kulmala informed the public that Well 5 came online on March 29, 2024 and Oakland water is in compliance with the Department of Environmental Protection
- Mayor Kulmala stated that Bush Plaza project started last week, this was one of the Mayors stated goals with regards to getting the project in motion within his first 60 days of office.
 Councilman Saliani will provide details during his report.
- Mayor Kulmala stated that a public meeting was held on March 28, 2024 with the residents
 of the Ramapo Reserve Community and surrounding neighborhood residents affected by
 the bridge replacement. There have been internal meetings to discuss issues from the
 residents.
- Mayor Kulmala informed the public that two Special Budget Meetings were held last week.
 This was done to provide transparency to the residents and to allow the Council to ensure that tax monies are designated with oversight.
- Mayor Kulmala stated he has asked for a meeting with PSE&G for next week to understand when work will be completed and to discuss paving the affected roads.
- There is a Styrofoam Drive on Saturday April 6, 2024 from 9-12 PM.
- Mayor Kulmala informed the residents that the Lennar project has gotten off on a bumpy start and a meeting is being held tomorrow to set expectations going forward.
- Mayor Kulmala reminded the public that the Easter Egg Hunt is on March 23, 2024 with a rain date on March 24.

Amy Eilert 318 Ramapo Valley Road, Ms. Eilert shared the history of Flow Follies and that they have raised over \$800,000.00 since 1985. This year's event raised \$10,000.00, but could be better. She thanked the Mayor for his participation and for bringing Councilman Talamini in to fill in as the

elephant poop expert. She hope the Mayor will join them again next year and volunteers are always welcome to join.

Sheila Boylan 16 Walnut Street, stated that she is still having water issues due to a neighbor's work and that the town is not helping her to get it resolved. She has lived here for 43 years with no water issues. Ms. Boylan brought picture to the council meeting and gave them to the Acting Borough Clerk Wendi Seelin to share with the Mayor, Council and Administrator. Mayor Kulmala asked Mr. Kunze to set up a meeting with Ms. Boylan and Mr. Yakimik. Mr. Kunze stated he would check on the status and the borough is using the tools at our disposal for remediation.

Kerri Sirinides 41 Sioux Avenue, stated that at the last meeting Ordinance 24-CODE-943 to amend the recreation ordinance was introduced with no real explanation just like the removal of the second public session. Where is the transparency? Ms. Sirinides suggested 2 Porta-Potties be put in place for unisex bathrooms. Ms. Sirinides believes this change creates a greater chance of issues. Asked that in the future that there be more transparency for their constituents. She hopes the Council will think long and hard before adopting this Ordinance tonight.

Tim Lally 4 Mountain Lakes Road, stated that he had brought up the Chapel Hill treatment plant at a meeting and thanked Mr. McCann and Mayor Kulmala for coming to the site to review the issues and appreciated them coming the very next day after stating the issue. There has been multiple meeting with Mr. Yakimik. He is following up on the status of a new more esthetically pleasing structure. Mr. Lally stated the site needs immediate attention, there is a weird green ooze going into the drain and that the fences are down and the doors are open and is a dangerous situation.

Discussion: Mayor Kulmala asked Attorney Matt Gilson to review and explain this Ordinance: Mr. Gilson stated The New Jersey Division of Civil Rights has come to us stating that the current ordinance is not in compliance with state statues. As a council we may not like it, but on its face the Ordinance does appear to conflict with state statute. This Ordinance is not adding any affirmative language it is only removing language. The Council has to comply with state statue. This does not mean that the Council can take a separate action to address the situation that a resolution can be

passed to explore options. It is his legal recommendation that the council remove the specific language to address the issue at hand. Councilman Saliani asked if the Borough has ever has an issue with the ordinance? Mr. Gilson stated there have been no issues. Mr. McCann asked what statue are we in violation of. Mr. Gilson replied the New Jersey State Law against discrimination. Mr. McCann asked if there is a fee shifting element attached to it. Mr. Gilson stated yes and Mr. McCann asked if the Attorney General have the authority to charge towns legal fees under civil rights lawsuit. Mr. Gilson stated yes. Councilman Pignatelli is against jeopardizing the safety of our children. He feels we can come up with a solution that can satisfy everyone's concerns and satisfy the state. We don't want them to start fining us and there are ways to protect the children. Councilman Talamini asked if we don't change it what the repercussions are, Mr. Gilson replied he can't really go into the details of what the state has proposed and the actions they would take, but its currently extensive fines. Councilman Talamini stated that we have reached out to the state for guidance, have we gotten any? Mr. Gilson stated they asked for a model ordinance and have not received one. At this point we are not adding to the Ordinance, Councilman Talamini asked I this will bring us into compliance. Mr. Gilson stated that so far this is the only statue. We will be doing a complete review of the ordinances. Councilman Saliani asked if this is the second contact with regards to our ordinances. Mr. Gilson stated yes the first was a DEP issue. This is a result of the State stating is must be done. Councilman McCann asked is it part of the process when we introduce ordinances that we ask the public to speak on any ordinances. Mr. Gilson stated yes it is required. Failure to hold a public open would be a violation of the ordinance and invalidate it. Mr. McCann stated so there is transparency. Councilman McCann stated before this council can take any action it has to be open for public comments.
