# DOG BITE FOLLOW-UP RESPONSIBILITIES & PROTOCOLS

It was reported that a dog involved in three biting incidents raised issues about responsibilities between the REHS staff and Tyco Animal Control. Inspector Caperino e-mailed Tyco after the second bite occurred and did so again after the third bite. Tyco claimed they had not been advised of the bite, but it was later determined e-mail had not been checked during a vacation. Tyco also said they are no longer being notified of all the biting incidents that occur in Oakland. Though the former health inspector did this as a matter of practice, the policy in Oakland was changed three years ago. No other towns that contract with the County for REHS Services and Tyco for animal control services ever received this information. Tyco was never notified of the policy change but never raised an issue with it until this bite occurred. There was also a dispute over responsibility for declaring dog potentially dangerous. Adding to this problem is the fact that police reports no longer seem to contain details surrounding how the bites occur which

makes it more difficult to determine whether a dog is potentially dangerous. Mr. Tiffinger said it is Tyco's responsibility to declare the dog potentially dangerous.

The details of the incident were discussed and the Board agreed that if Ms. Tyler wants to receive all the paperwork for each dog bite, she would become responsible for keeping track of how many bites a dog has been involved in.

A meeting to clarify protocols was requested by Carol Tyler from Tyco Animal Control. Ms. Tyler, Mr. Kunze, Principal REHS Marjorie Vanacore and Senior REHS Kristin Caperino, Mr. Tiffinger, Mr. LaForgia and Ms. Dubowick will attend the meeting scheduled for March 15<sup>th</sup> at 1:00 PM.

### EFFECTS OF MARIJUANA ON THE BRAIN

Mr. Pignatelli reported that he read a newspaper article about a vote coming up early next month on the taxation of marijuana. The bill proposes taxing the total weight of the product rather than taxing the individual.

Mr. Pignatelli said he is looking at holding a program about the effects of marijuana on adolescents at the Senior Center on Thursday, April 11<sup>th</sup> at about 12:30. The Senior Center Director said the program should not be any longer than 45 minutes to an hour.

The plan is to have Dr. Ryan Straseski talk for 15 minutes about the medical implications of marijuana on adolescents because of its known effects on cognitive ability. Next planned is talk for 15 minutes about the legal aspects, since the sale of marijuana is a violation of federal law. Businesses selling marijuana must only deal in cash and it cannot be put in the bank. Mr. Pignatelli said he will try to get an assemblyperson, either Holly Shepisi or Bob Auth, to talk for 15 minutes about the legal implications with the state. The final 15 minutes will be devoted to questions and answers. Mr. Pignatelli said you need to have a captive audience, so senior citizens will be there but others will be welcome to attend.
