## Oakland Environmental Commission June 5, 2018

- 1. Meeting called to order at 7:32 PM by Chair Nancy Krause. Alex Myer, Kevin Mauro, Carol Peterson and David Blanke attended. Lee Haymon, Erich Kamm, Gina Mayer-Costa, and Michael Kozak were excused. Councilman Pignatelli and Junior EC member Calli O'Neal also attended.
- **2. Meeting Announcement**: This meeting is being held in accordance with the open public meetings law, duly announced, advertised, and posted in the municipal building.
- **3. Open to public** Junior EC member Calli O'Neal spoke on her participation in the High School Ambassador program to grade schools. She speaks to younger students about creating sustainable practices in the schools town-wide. She also listed ways she hopes to help Indian Hills High School become more involved in conservation and practice more sustainability. She is trying to get Sustainable Jersey accreditation for Indian Hills High School. Calli asked members to review the website to help give her more direction.
- 4. Meeting Minutes Review from 3-6-18, 4-3-18, 5-1-18. June minutes were approved.

## 5. Old Business

- a. Potash Lake Recreation Area sign discussions is on-going.
- b. Stewart Woods Nature guide/map Grant application was not accepted by ANJEC.
- c. <u>Butterfly Garden</u> Carol Peterson has been tending the 2 new sites in Great Oak Park. David Blanke's daughter designed signs which were printed and installed at the locations of the recent plantings. Carol reported that there are more milk-weed plants growing randomly in the Park. She has also planted other small native plants, such as Lamb's Ears, as a border for the plantings. Maintenance will continue to be needed.
- d. Water Quality report DPW clarified that the one well with higher levels of 1,4 Dioxane was only monitoring well, not used for drinking water. Further discussion was tabled until Lee Haymon is present to lead the discussion.
- e. Town Carnival David Blanke is coordinating preparations for Commission display at the booth. He has a schedule for manning the booth during the 4 day event. Recycling barrels and gift cards to local businesses are planned. Alex is bringing reusable shopping bags from Bergen County for visitors to the booth
- f. Environmental review of Station Park report The report was distributed by Nancy Krause. Several Commissioners made comments that will be passed on to the Station Park Committee that is planning for a pocket park in Bush Plaza.
- g. <u>Dogwood Hills School plastic bag ban</u> Students from Dogwood Hills School have created a display which is being installed in the Stewart Woods Bulletin Board case. Scout Mom Dana will work on SJ points with the Green Team for the plastic bag ban project.
