- a) <u>Open space application for Sandy Beach</u> Application was submitted to the Bergen County Division of Open Space by the June 30th deadline for potential funding of a purchase of the historic open-space property. Public discussion will follow as per County grant application regulations. An appraisal is needed. The property is zoned industrial, but has potential for its passive and active values.
- b) <u>Open Space Plan</u> Nancy Krause has been discussing updating of the Borough Open Space & Recreation Plan with Borough officials. Completion of the update would earn Sustainable Jersey points. A proposed schedule is given below.

Also the Highlands status is being discussed as efforts to gain permission to sewer the downtown area progress. Highlands's conformance rules interfere with sewerage. The Council is voting on a PILOT resolution to support NJ open-space funding.
