ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Coira, Jensen, Kulmala, Pignatelli, Talamini, Visconti. Absent: None. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MAYOR'S REPORT: FLOW Follies raises money for Senior scholarships for Ramapo and Indian Hills High School. This year's show will be held March 5th to 8th at Ramapo High School. The first annual Green Fair sponsored by the FLOW Environmental Commissions will be held March 7th at Ramapo High School Cafeteria from 11 am to 4 pm. Bergen County K-9 Veterans Day will be held March 13th from 4 to 8 at the Law and Public Safety Institute in Mahwah. The Oakland Library will hold computer classes on Wednesdays from 1:30 to 2:30. There will be a Health and Wellness Fair at Bergen Towne Center on April 24th.

ROOSEVELT BLVD. PHASE II APPRAISAL PROPOSALS

Mr. Kunze advised that we applied for the second round of funding from Bergen County to purchase homes on Roosevelt Boulevard. One of the requirements for the grant process is to conduct certified Green Acres compliant appraisals on the seven lots under consideration for acquisition. The Land Conservancy has solicited proposals on our behalf. Mr. Kunze is recommending that the Borough retain Joshua Mackoff, LLC to conduct appraisals at a cost of \$ 4,025. A resolution will be listed on the next agenda.

NEW BUSINESS:

Mr. Kunze advised that bids were received for the 2015 Road Program. We got an excellent response and hope to award the bid at the first meeting in March.

COUNCIL REPORTS:

Councilman Talamini: The Borough received a NJDOT Safe Routes to Schools grant in the amount of \$ 200,000 for sidewalks. He attended the School Board meeting where they discussed the PARCC tests.

Councilman Kulmala: There was an OCC meeting on February 18th. They are working on improving communications with residents via social media. They hope to move forward next month with a Facebook page. The OEM held a meeting on February 18th. They worked on railroad response and the ice storm. Councilman Kulmala advised that a meeting was held with the Public Safety Committee to discuss Mr. Ahearn's concerns about speeding on Pawnee. The Police Chief put together an action plan and radar details are being done from 8:30 am to 9:30 am and from 2:30 pm to 3:30 pm. One summons was issued for a speed of 42 mph.

Councilman Visconti: The next Flood Commission meeting will be held March 8th at 7:30 pm at the Senior Center. Last month's meeting was cancelled due to the weather. The Park Committee will meet on March 8th at the Danny D'Elia building. There is a cleanup scheduled for April. He advised residents to check the website NewOaklandPark.com for news about the Park. The Library will hold computer classes on Wednesdays from March 18th through April 29th. The Library Board has hired a new Library Director, Peter Havel.

Councilman Pignatelli: No report.

Councilman Jensen: The Planning Board will meet March 12th. We will be ready shortly for budget meetings. He proposed the following dates: March 19th, 21st, 26th, 28th. Mr. Kunze advised he is targeting getting the budget books out by March 13th. He wants to meet with the Council to do a preliminary overview prior to introduction which will take place on March 25th.
