MEETING CALLED TO ORDER: By Mayor Schwager at 7:31 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Coira, Jensen, Kulmala, Pignatelli, Visconti. Absent: Councilwoman Stagg. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MOTION TO EXCUSE ABSENCE:

On motion of Councilman Pignatelli, seconded by Councilman Jensen, the absence of Councilwoman Stagg be excused.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Pignatelli, Visconti.

APPOINTMENT OF JUNIOR FIREFIGHTER

Mayor Schwager gave the Oath of Office to Junior Firefighter Paul Warga.

LIFESAVING AWARDS:

Mayor Schwager presented an award to Pompton Lakes 911 Telecommunicator Michael Finello for his role in the ice rescue on January 3, 2014. Michael Finello is a 9-1-1 Telecommunicator for the Borough of Pompton Lakes, which is a Public Safety Answering Point for Pompton Lakes, Bloomingdale, and Wanaque. The "PSAP" also receives many calls from out of town and from Interstate 287 when callers on cellular phones reach cellular radio towers that serve the PSAP.

On this particular day that Mike Finello was working, he received a cellular call from a female caller who reported a man through the ice on a lake but she was unsure of her exact whereabouts. Mike questioned her as to her surroundings and ascertained that in fact she was at Ramapo Lake in Oakland on the top of Skyline Drive. Mike proceeded to give pre-arrival instructions to the young lady, and also transferred the call to the Oakland Police Department. Mike informed the Oakland dispatcher of what was transpiring and Oakland's dispatcher proceeded to send Oakland Police, Fire-Rescue and EMS to the scene.

Mr. Finello remained on the line with the caller and continued to coach her through the process, telling her to remain calm and send her friends to seek out ladders and rope from the surrounding homes, as well as telling her to stay in eye and voice contact with the victim in the water. The caller's friends returned some time later with a ladder and some rope but were unable to assist or rescue the victim. As Mr. Finello remained on the 9-1-1 call with the young lady, Oakland Police, Fire Rescue and EMS arrived and completed a successful rescue.

Mayor Schwager gave the background of what occurred during the lifesaving rescue that took place on January 3, 2014. On Friday January 3, 2014 at approximately 13:20 hours, the Oakland Fire Department was dispatched for a reported ice rescue at Rotten Pond located within Ramapo State Park off of Skyline Drive. Chief Curtis LeRoy signed into service right away and

immediately called for two additional ice teams from Ringwood and Pompton Lakes to respond to the scene.

Chief LeRoy was in his own personal vehicle at the time which had a plow on it and enabled him to clear the roadway of drifted snow down to the remote location within the park. Upon his arrival, Chief LeRoy witnessed a male individual through the ice roughly fifty to sixty feet off shore in the water clinging to the ice. There were four individuals standing in the roadway next to the lake who had summoned help for this victim. The group of four had already placed an extension ladder roughly 28 feet out onto the ice from the shoreline. Chief LeRoy identified himself as the Chief of the Fire Department and seeing the urgency of the situation, asked the witnesses if anyone had a rope. With none available, the Chief went out onto the ladder that was lying on the ice roughly 28 feet in length and cut the halyard off the ladder in an attempt to try to extract the victim. Chief LeRoy had no radios with him due to responding in his own vehicle. Officer Thomas Pianettini was next to arrive on scene and transmitted the confirmation of an ice rescue and along that 1030 was on the ice also, telling all units that were signing into service to expedite. Officer Pianettini came down to the lake's edge to try to assist Chief LeRoy and went through the ice into the water on the lake's edge roughly two feet deep. One of the witnesses ran to the nearby house and brought back a personal flotation device along with a boat cushion. Officer Pianettini re-entered the water and gained access to the ladder and provided Chief LeRoy with the flotation device and the boat cushion. Chief LeRoy, who was unable to go any further due to the ice thickness, attempted to throw the boat cushion to the victim who was screaming for help. This failed due to the high winds coming across the lake.

Assistant Chief David Hutsebaut arrived next in Unit 1040. Asst. Chief Hutsebaut grabbed his throw bags and passed them along. These attempts also failed due to the high winds. The victim claimed he could not hold on any longer and submerged under water. Chief LeRoy, realizing the victim was about to drown, jumped off the ladder and onto the thin ice which cracked underneath him. The victim reappeared and went under the water a second time. Chief LeRoy repositioned himself and forced the ladder into the victim snagging his arm and securing him. As Chief LeRoy attempted to make his way closer to the victim, the ice gave way under the ladder dropping him into a foot of water. Realizing that he could not go any further, he awaited the arrival of Utility 1044 with the ice rescue sled. Officer Pianettini was still standing in waist deep water waiting to help secure Chief LeRoy in case he were to fall through the water. Officer Pianettini yelled for help over the radio.

Upon the arrival of Unit 1044, the crew immediately deployed the ice rescue sled and Firefighter Steven Longa, who was wearing a cold-water suit, proceeded to make his way toward the victim. Steven encountered difficulty getting to the victim at first due to the water that surrounded him. Chief LeRoy instructed Steven to reach down into the water and locate the ladder and pull his way to the victim. The victim was very lethargic and helpless. Steven was able to secure the victim and called out for the shore team to remove the sled from the ice. As the sled came close, Chief LeRoy jumped onto the rear of the sled as the ice was giving away around him. Once the victim was at the shore line, the firefighters lowered a stokes basket down the rocks and the victim was taken out for evaluation by First Aid personnel. Chief LeRoy, Officer Pianettini and Firefighter Longa were treated for exposure to sub-freezing temperature. Officer Pianettini was transported to Chilton Hospital for exposure from standing in the water for the entire time of the rescue. The victim was transported to St. Joseph's Regional Trauma Center.

Mayor Schwager, Councilman Pignatelli and Councilman Kulmala presented plaques to the Fire Department, Police Department, and First Aid Squad for their outstanding response. Individual awards were presented to Chief LeRoy, Officer Pianettini, and Firefighter Longa.

MAYOR'S REPORT:

Twice per week garbage pick up will begin the week of April 7th. The Library Art show is this weekend. On April 26th, there will be a cleanup at Great Oak Park. Mayor Schwager advised that the Borough will once again have a summer intern program for juniors in high school. On April 5th, the Mayor's Weight Loss Challenge begins. It is a 12-week program and classes will be held on nutrition and exercise. Register at www.dwbw.net. The theme is that together we can make Oakland a healthy community. This will help Oakland get points for Sustainable Jersey Certification.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Jensen, seconded by Councilman Pignatelli, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Pignatelli, Visconti.

Frank Monaco, 60 Thackeray, went to the Board of Education meeting with Councilman Kulmala. He presented his idea to change the end time of school so it would alleviate traffic in town. One member indicated they had looked into this issue years ago. Mr. Monaco also brought up the Crossroads. Mayor Schwager advised that the deadline for articles for Crossroads is March 31st. Councilman Kulmala advised that he and Mr. Kunze then met with the School Business Administrator, 2 members of the Board of Education and the Superintendent of Schools. The Superintendent went to Chief Kasper to ask for a traffic study.

Mike Kozak, 24 Cayuga Ave, spoke of his ideas for striping on Ramapo Valley Road. He proposed moving the yellow line over to the left at Ramapo Valley Road north by Oak Street. The road is 48 feet wide which leaves room for four 12 foot wide lanes or three lanes. Kevin Boswell, Borough Engineer, advised that the County standard is a 12 foot lane. The adjustment to a curb lane is 13 foot wide. A turn lane is between 8 feet and 11 feet. There are other things that need to be considered such as approach factors. Mr. Boswell can research this and discuss it with the County. Mr. Kozak asked if the Borough can have a meeting on this issue before they pass an ordinance. He would like to keep northbound traffic flowing. Mayor Schwager suggested arranging a meeting with the Borough Engineer. Mr. Kunze confirmed that a meeting with the Engineer is required to look at road standards. Mr. Kozak proposed removing the traffic light at West Oakland Avenue and diverting traffic to a new ramp off of Route 287. Councilman Pignatelli advised that the traffic light at West Oakland is governed by the State. Discussion ensued over that intersection and traffic light. Councilman Visconti commented that Mr. Kozak's plan for restriping Ramapo Valley Road southbound at Oak Street was very close to what he was trying to verbally explain at the last meeting. He thinks the Borough will have a hard time convincing the Federal Government they have to build a ramp off of Route 287. Mr. Kozak spoke about the possibility of bike lanes. He advised that the next Green Team meeting is on April 21st at the Senior Center.

WORK SESSION**2014 ROAD PROGRAM AWARD BID:**

Mr. Kunze advised that bids were received on March 18th and there were a number of competitive bids. Based on funding, we can award the base bid and Alternate A. The low bidder was Smith Soudy with a bid of \$ 549,381.58. Borough Engineer Rebecca Mejia advised that they reviewed the bids and Smith Soudy appears to have a complete bid. The bids are under Attorney review now. A resolution to award the bid will be placed on the next agenda.

DESIGNATION OF WASTEWATER MANAGEMENT PLANNING AGENCY

Special Counsel for the Borough, John Napolitano, advised that the Borough entered into a Memorandum of Understanding with the Northwest Bergen County Utilities Authority for wastewater treatment services. The Borough needs to amend the Wastewater Management Plan. NWBCUA acts as Planning Agency for all the towns they service. The Wastewater Management Plan examines existing and future wastewater needs and where they will be treated. The NWBCUA has agreed to pay for this Plan. We would pass a resolution to designate them as the Planning Agency. Mr. Napolitano advised that certain ordinances have to be adopted during this process such as one for water conservation. He explained that the Borough met with the Highlands Council. The Highlands Council will give a consistency determination. The Highlands Council agreed that it makes sense to allow the NWBCUA to be the Planning Agency and the benefit is that NWBCUA will fund the Wastewater Management Plan. Mr. Napolitano explained that the DEP has to sign off on the Wastewater Management Plan. The DEP realizes that the small package plants are difficult to maintain as well as there are areas that have failed septic.

Councilman Visconti explained that the two obstacles so far are signing on the the Highlands Council plan and the Wastewater Management Plan. Mr. Napolitano advised that the Borough is tentatively on the Highland's Council agenda for May. In regards to the Wastewater Management Plan, the first step is to authorize an agreement with NWBCUA. The Borough will define with the Engineer the priority areas to address first. The more areas we address immediately, the more NWBCUA may fund. Councilman Visconti explained that the Wastewater Management Plan is for the whole town and would take us over the next twenty years. Mr. Napolitano explained that once the Plan is implemented, we would have to theoretically update it every five years. The Plan gives us the opportunity in the future to address our needs. Councilman Visconti advised it is important to have an all-inclusive Wastewater Management Plan because it is difficult to amend. Borough Engineer Kevin Boswell advised that we are shifting focus to strategic planning. We can move the burden of responsibility and cost for the Wastewater Management Plan to the NWBCUA. The role of the Borough becomes more advisory. This is the right step for the best interests of the taxpayers of Oakland.

COUNCIL REPORTS:

Councilman Kulmala: He attended the Board of Education meeting with Frank Monaco on March 18th. A follow-up meeting was held on March 24th with Mr. Kunze, Board of Education members, the Board Administrator and Superintendent. The Board has an interest to begin a dialogue in order to work together. Councilman Kulmala is hoping they will meet quarterly. They did discuss the Crossroads and the Board will try to get in the next issue. The OCC met on March 19th and they welcomed new member Peter Tuohy. The OCC installed two new cameras in the Council Chambers.

Councilman Visconti: He advised there was no Flood Commission meeting last month. The Flood Commission will meet on April 14th at 7:30 pm. The Library is holding their Art Show this

weekend. On April 27th, there will be a Jazz ensemble concert. He spoke about Library programs. There will be a cleanup at Great Oak Park on April 26th at 11 am. He asked people who want to help to register online. The Boy Scout projects for the Park are on hold until the weather breaks. The new sign will go up. Tree services have already started to remove dead branches. The DEP will visit once the snow melts to do a walk thru. There is a local company that wants to do work on the C1 stream.

Councilman Pignatelli: On April 2nd, we will celebrate Oakland's 112th birthday at the Senior Center. On Saturday March 15th, he was invited to the Senior Citizen's club to celebrate St. Patrick's Day.

Councilman Jensen: The Easter Egg Hunt will be held on April 12th at 11 am. The next Budget meeting will be held March 29th from 9 am to 12 pm. He thanked the firemen for the job they do.

Councilwoman Coira: The information for Recreation signups is available on the Recreation website. If you miss signups, participation in the sport is not guaranteed. There will be a volleyball clinic for grades 2 to 5. The next Recreation Commission meeting is March 31st at 8 pm at the Danny D'Elia Building. Twice per week garbage pickup will begin on April 7th as well as yard waste pickup.

Frank Monaco, 60 Thackeray, commented that the situation on his road is getting worse with the potholes and the gas company digging up the road constantly. He wants to see Thackeray paved. He wants P.S.E. & G. to pay since they keep digging up the road. Mr. Kunze explained that P.S.E. & G. is required to pave when they do a gas line installation. It doesn't make sense to pave with multiple gas leaks and to have them dig up the road again. Mr. Kunze advised he will call P.S.E. & G. to ask for a status.
