MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager and Student Mayor Connor announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

Assemblyman Robert Auth was in attendance to congratulate the students. He commended the students for becoming active in government. He presented the students with handouts.

MAYOR'S REPORT:

Mayor Schwager advised that the Borough of Oakland will be receiving a \$ 550,000 grant for open space. The ribbon cutting ceremony for Great Oak Park will be held Sunday at 10 am. Special guests will include Chief Perry of the Ramapough Indians. There will be a Flag Day ceremony on Sunday June 14th at 1 pm at Veteran's Park. The carnival will be held June 24th to 27th. On Saturday June 13th, the Ladies Auxiliary of the Fire Department will hold a Fish & Chips dinner at 5 pm. Last Saturday, the baseball and softball parade was held along with the ribbon cutting for the new walking trail. What made the event so special was all the volunteers.

Student Mayor Connor read the following report:

The Student Council and Valley Middle School are very proud of all of our accomplishments this school year. As a school, we collected more food for the Oakland Food Pantry and toys for the Chris Croker Toy drive than any other past year. We also donated \$200.00 to The Holocaust Museum, \$500.00 to the Juvenile Diabetes Research Foundation and \$1,000 dollars to The Cure Starts Now, an organization whose goal is to find a cure for children's brain cancer. This year, for the first time, we partnered our student council members with the children from Oasis in Paterson. Oasis is a safe haven for women and children to help break the cycle of poverty through education and compassion. The student council went to Paterson after school to do a craft project with the children, and we will continue to do this project for many years to come.

At this year's graduation ceremony on June 19th, one of our eighth grade students, Aboudi Rai, will be reading his winning graduation poem in front of an audience, at Indian Hills High School. In the National Spelling competition, 8th grader Daniel Hu advanced to the semi finals for two

consecutive years. This year, Daniel was runner up. We are also proud to announce that 7th grader Aideen Gannon was presented with an award from the 23rd Annual Playwrights Festival of Bergen County for writing the winning play, "What Just Happened". This play was performed by the theatre arts students at Bergen Community College.

On behalf of the Student Council, I would like to present donation checks to the Oakland Police Department, Fire Department and First Aid Squad. Mayor Connor presented a check to Detective Mark Piercy of the Oakland Police Department, Assistant Chief Dave Hutsebaut and Lt. Lou Thurston of the Fire Department and to Paul DeLorenzo from the Oakland First Aid Squad.

Student Mayor Connor thanked Mayor Schwaeger and Borough Clerk Lisa Duncan for giving us the opportunity to be a part of the Town Council meeting and for allowing us to tour Town Hall and all of its departments. Lastly, we would like to thank Dr.Caffaro, Mr. Desiderio, Ms. Christiano, the Board of Education, as well as our parents and teachers for supporting the Valley Middle School Student Council Program.

PRESENTATION ON STIGMA FREE CAMPAIGN

Jody Goffredo advised that the Stigma Free campaign means a lot to those who need help with mental health issues. The town will provide training that will benefit individuals that need help. She thanked the Mayor and Council.

Councilman Pignatelli advised that the first meeting was held at Borough Hall. Twelve to fourteen people attended. He explained that because of the stigma of mental health illness, people do not seek help. The next step in the program is to establish a mental health first aid program where people will be taught to recognize signs. He will announce the dates of the training sessions when they are scheduled.

Heidi McCallum, 140 Manito Avenue, has a daughter that suffers from mental illness. She has lived that stigma for many years. They kept quiet about her illness until recently when she got really sick. Everyone in the community rushed to help. Mrs. McCallum appreciates the effort of putting together a Stigma Free campaign.

Councilman Pignatelli advised that 1 in 4 people have a mental health problem. This training will teach people how to help those suffering with mental illness.

WHEREAS, at the June 2013 meeting of the Bergen County Mental Health Board, members of the Board learned from Care Plus NJ staff that the agency was working collaboratively to establish a Stigma Free Zone in Paramus; and

WHEREAS, the members of the Mental Health Board supported the initiative and recognized that the initiative was aligned with the Board's mission to raise awareness of the disease of mental illness; and

WHEREAS, the National Institute of Mental Health reports that 1 in 4 adults experiences mental illness in a given year and 1 in 17 adults live with a serious mental illness such as schizophrenia, major depression, or bipolar disorder; approximately 20% of youth ages 13 to 18 and 13% of youth 8 to 15 experience severe mental disorders in a given year, and;

WHEREAS, the stigma associated with the disease of mental illness is identified as the primary reason individuals fail to seek the help they need to recover from the disease, and;

WHEREAS, Stigma-Free Zones aim to inspire public interest and open dialogues about stigma, raise awareness of the disease of mental illness and create a culture wherein residents who have the disease of mental illness feel supported by their community and neighbors and feel free to seek treatment for the disease without fear of stigma and;

WHEREAS, promoting awareness that there can be no "health" without mental health will break down barriers and encourage residents of all ages to be mindful of their mental health and ask for help when needed; and

WHEREAS, local resources are available to treat the disease of mental illness so no one resident needs to suffer alone or feel hopeless, and;

WHEREAS, establishing Stigma-Free Zones will raise awareness of resources and encourage residents to engage in care as soon as the need is identified so recovery can begin, hope is inspired and tragedies are avoided, and;

NOW, THEREFORE, BE IT RESOLVEDS that the Borough of Oakland recognizes the community needs and supports the efforts of the County of Bergen in designating Oakland as a Stigma-Free Zone.
