REGULAR MEETING OF THE MAYOR AND COUNCIL HELD AT THE MUNICIPAL COURT /COUNCIL CHAMBERS 10 LAWLOR DRIVE, OAKLAND, NEW JERSEY WEDNESDAY NOVEMBER 12, 2014

MOVE TO EXECUTIVE SESSION:

On motion of Councilwoman Coira, seconded by Councilman Talamini, the following resolution be introduced, adopted and duly passed on roll call vote:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, (N.J.S.A. 10:4-12) permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist,

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Oakland, County of Bergen, State of New Jersey, as follows:

MEETING CALLED TO ORDER: By Mayor Schwager at 7:31 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Coira, Jensen, Kulmala, Talamini, Visconti. Absent: Councilman Pignatelli. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Steven Muhlstock, Borough Attorney.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

EXCUSE ABSENCE:

On motion of Councilman Visconti, seconded by Councilwoman Coira, the absence of Councilman Pignatelli be excused.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Talamini, Visconti.

MAYOR'S REPORT:

Mayor Schwager congratulated Councilman Talamini and Councilwoman Coira on their reelection. She advised that on October 30th, a pee-wee football game was held between Oakland
and Franklin Lakes. Oakland won the game and Franklin Lakes' Mayor Bivoni brought donuts to
Borough hall. She thanked Mayor Bivona. The Toys for Tots runs through town on December
6th. Rockland Electric will be doing vegetative maintenance on various streets beginning
November 15th. On November 11th, the American Legion held a Veteran's Day ceremony. Last
Wednesday, a meeting was held with Northwest Bergen County Utilities Authority to further
discuss the possibility of sewers. The traffic light at Courthouse Place is being worked on by the
State.

APPOINTMENT OF JUNIOR FIREFIGHTERS:

On motion of Councilman Jensen, seconded by Councilman Kulmala, the Council appointed Michael Cassella as Junior Firefighter to the Oakland Volunteer Fire Department.

Mayor Schwager administered the Oath of Office to Michael Cassella.

Dave Richardson, 320 Ramapo Valley Road, spoke about the potential hazard from people turning into the Post Office parking lot from Ramapo Valley Road. He asked if the Borough was going to finish resurfacing West Oakland Ave. He at least asked if the pothole by the light at Skyline could be patched. Mr. Kunze advised that the Borough did apply for a DOT grant to resurface areas where there was a discrepancy of ownership but the Borough was denied funding. The area Mr. Richardson is speaking about is owned by the County not the Borough.

Don Burns, 22 Whittier Lane, commented that it was great to see the Valley Middle School 8th graders at the Veteran's Day ceremony. He thanked Councilman Talamini for getting the school involved. Councilman Talamini advised that the school was happy to be a part of the ceremony. They hope to make it an annual event.

Marisol Kozlovski, 19 Barnard, advised that this week are the second grade class trips to the Van Allen House. Dutch Christmas is going to be held on December 7th. She spoke of a problem with the Recreation soccer kindergarten program and explained that she pulled her child from the program. She spoke of an issue with the reimbursement process. Mayor Schwager asked if she has gone to the Recreation Commission meeting. Ms. Kozlovski advised that she could not find the meeting schedule. Recreation Chairman Mike Guadagnino advised that he was not aware of this situation and that he can be contacted at any time. He advised that the Recreation Commission meets the fourth Monday of the month and the schedule is on the Recreation website. Councilman Talamini commented that he has kids in Recreation and he had to get a refund and he had a positive experience.

PUBLIC HEARING ON THE BOROUGH OF OAKLAND APPLICATION TO THE BERGEN COUNTY OPEN SPACE, RECREATION, FARMLAND AND HISTORIC PRESERVATION FUND-MODULAR DUGOUT PROJECT

Recreation Chairman Mike Guadagnino advised that the Recreation Commission is looking to put in four modular dugouts-two on Field 9 and two on Field 3. These two fields are directly in the sun and these modular dugouts would protect the children. The Borough is applying for a grant for 50% of the cost.

PUBLIC HEARING ON THE BOROUGH OF OAKLAND APPLICATION TO THE BERGEN COUNTY OPEN SPACE, RECREATION, FARMLAND AND HISTORIC PRESERVATION FUND-FLOOD ACQUISITION PROGRAM

Aaron Cela from the Land Conservancy of New Jersey explained that the Borough has applied to Bergen County for Phase 2 of the Roosevelt Boulevard propery acquisitions. This application is to purchase the following seven properties: 76 Roosevelt Blvd, 78 Roosevelt Blvd, 80 Roosevelt Blvd, 82 Roosevelt Blvd, 84 Roosevelt Blvd, 71 Roosevelt Blvd, and 7 First Street. This continues the purchase of the properties contiguous to the Truman Field to preserve for open space and to help alleviate flooding. Councilman Visconti asked what the total acreage of open space would be. Mr. Cela responded there would be approximately 3 acres in addition to Truman Field. He explained that the homes would no longer be in the floodway and the town would not be in a position to endanger emergency services by having to rescue people in a flood.

Mayor Schwager advised that at the last meeting, Councilman Visconti brought up the idea of a Committee to look at vacant Borough properties. According to the bylaws, it would be considered an Ad-hoc Committee which would be appointed by the Mayor. She advised that Councilman Jensen already started working on this and he met with the DPW Superintendent and the Borough Administrator. Mayor Schwager advised that he can continue working and report back to the Council. Councilman Visconti responded that the concept he had is larger than

something one person can handle. It would involve coordination with other entities to inquire about affordable housing. He would like to see Councilwoman Coira on this Committee as well as Councilman Jensen. He advised that according to the bylaws, the Council President appoints standing committees and there are sub-committees as well. Mayor Schwager asked Councilman Jensen to talk to Councilman Visconti. Councilman Visconti asked why the Mayor cannot just appoint Councilwoman Coira to the Committee. Councilman Jensen advised that he would like to do the job and he doesn't think there needs to be a formal committee. If he needs help, he can ask for it. Mayor Schwager advised that this will be held until the next meeting.

RESOLUTION 14-253 AUTHORIZE GRANT APPLICATION-MODULAR DUGOUT PROJECT

On motion of Councilman Jensen, seconded by Councilwoman Coira, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, the Bergen County Open Space, Recreation, Farmland & Historic Preservation Trust Fund ("County Trust Fund") provides matching grants to municipal governments and to nonprofit Organizations for assistance in the development or redevelopment of municipal recreation facilities; and

WHEREAS, the Borough of Oakland desires to further the public interest by obtaining a matching grant of \$19,480.00 from the County Trust Fund to fund the following project: Modular Dugouts; and

WHEREAS, the governing body has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions and desires to make an application for such a matching grant and provide application information and furnish such documents as may be required; and

WHEREAS, as part of the application process, the governing body received public comments on the proposed park improvements in the application on November 12, 2014; and

WHEREAS, the County of Bergen shall determine whether the application is complete and in conformance with the scope and intent of the County Trust Fund; and

WHEREAS, the applicant is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the above named project and ensure its completion on or about the project contract expiration date.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Oakland:

That said Ordinance be published in full in The Record on or before November 15, 2014 together with notice of this introduction and of the time and place for further consideration for final passage, and that the Clerk post a copy of said Ordinance in the Municipal Building and make copies available to the public.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Talamini, Visconti.

WORK SESSION:

RESOLUTION ON PENSION CLARIFICATION

Mr. Kunze advised that recently the Governor asked for a report on the Pension system. Mr. Kunze advised that there is a vast difference between the State Pension system and the PERS and PFRS for municipal and county employees. The fiscal health of those systems is much better than the State system because municipalities have been fulfilling their obligations. We do not want to see the health of those funds jeopardized by whatever the State does. Councilman Visconti advised that the local pension funds are funded at 75% while the State pension fund is funded by 48%. He explained that in the late 90's, the Pension fund was doing well and the State decided not to have municipalities fund. In 2005, the municipalities got hit with a five-year phase in to make up for what had not been contributed. The municipalities have been paying ever since. He advised that it is important to recognize the separation of the funds and recognized that municipalities are doing their job and the State is not. A resolution will be listed on the next agenda.

ROOSEVELT AVENUE DUE DILIGENCE

Mr. Kunze advised that the Land Conservancy submitted proposals for due diligence for the acquisitions of Roosevelt Boulevard. Once he is finished reviewing the proposals, he will bring forth resolutions for approval.

DIRECT DEPOSIT ORDINANCE

Mayor Schwager advised that she spoke to several State legislators and they did not know why this legislation was passed. Borough Attorney Steven Mulstock advised that Attorney Chewcaskie suggested having an ordinance incorporating the direct deposit provisions and make it retroactive to January 1, 2014. That ordinance would make it permissive for employees to have direct deposit. An ordinance will be introduced at the next meeting.

NEW BUSINESS:

Councilman Kulmala advised that the Recreation lighting project and walking path project are ready to go. There is an opportunity for the Borough to run extra conduit while the ground is dug up. The idea is that down the road, conduit could be run in a loop to service the Recreation complex, Police Department, Senior Center, Valley Middle School, Borough Hall, DPW and Library buildings. This could be advantageous for phones, cable, and having wi-fi at the Recreation fields.

By putting the infrastructure in, the Communications Commission can do live broadcasts. He is asking for a Change Order to lay a track of 4 inch conduit. Mayor Schwager asked how disruptive this would be. Mr. Kunze advised that the trenching is already being done with the project so we are only talking about the cost of material. He explained that this is only one leg of the conduit that would be run. Councilman Visconti thought it was a fantastic idea and asked for

the cost. Mr. Kunze responded that the original concept was for 3,000 linear feet but that has been cut down to 2,200 linear feet. Borough Engineer Rebecca Mejia advised that the job for the lighting project has already been awarded. We are waiting for a price from the contractor to run 2,400 linear feet. She advised that the anticipated cost of the Change Order would be \$ 60,000 to \$70,000.

Councilman Visconti asked if there is money for the Change Order. Mr. Kunze advised that there is sufficient funding because the pricing for the project came in lower than anticipated. Councilman Jensen feels this is a great idea and would take Oakland into the future. Recreation Chairman Mike Guadagnino advised that it is one of the most forward thinking ideas for the Recreation fields. It is a great project. Mr. Kunze advised that Ms. Mejia is getting pricing from the contractor so hopefully there will be a Change Order resolution for the next meeting.

COUNCIL REPORTS:

Councilman Talamini: The Veteran's Day ceremony was held yesterday and the 8th graders from Valley Middle School, the Principal and Superintendent of Schools attended. They hope to continue attending this ceremony in the future. The school is looking to do more with community events and are talking about doing a program at the tree lighting ceremony.

Councilman Kulmala: The deadline for articles for the next Crossroads issue is November 24th. OEM will hold a meeting on November 18th to continue planning for the tabletop drill. The Planning Board will meet tomorrow. Regarding the issue of double wood, he advised that the poles are coming out. Long Hill is done as well as the one by the Police Department. Councilman Kulmala advised that Oakland has a well-manned Fire Department and the Junior Firefighter program has proven to be successful. OCC is looking for new members.

Councilman Visconti: The Flood Commission met last Monday. The river restoration project is moving forward. A meeting will be held on November 26th with Trout Unlimited. They are hoping to get everything in place to get the project done in 2015. There is a small window of time to make the project happen. The CRS program is moving forward. There is a meeting scheduled with FEMA on January 6th. They are talking about a committee to document the river restoration project. A meeting was held three weeks ago for the Library project. The Library had asked for some revisions in the plan. The Borough met with the Northwest Bergen County Utilities Authority. The mapping of the sewer service area was discussed.

Mayor Schwager advised there is a video link on the Flood Commission website. Councilman Visconti responded that it is a time lapse video of another river project. Mayor Schwager thanked Flood Commission Chairman Lew Levy for all his efforts.

Councilman Jensen: He advised that former Congresswoman Marge Roukema passed away today. The First Aid Squad will hold an open house for its 60th Anniversary on Saturday November 22nd. The Tree and Menorah Lighting Ceremony will be held on Sunday December 7th at 5 pm.

Councilwoman Coira: She advised that the Recreation website contains a lot of information about sports programs and registration information. The Recreation Commission meets the last Monday of each month at 8 pm at the Danny D'Elia building. Councilwoman Coira advised that fees from tree permits go into the Shade Tree Trust account. The money is then used to plant trees around the Borough. The Shade Tree Commission is looking to plant additional trees in the downtown area in the spring.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Jensen, seconded by Councilwoman Coira, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Talamini, Visconti.

Aaron Cela, Land Conservancy, advised the Mayor and Council that the proposals for due diligence for Roosevelt Boulevard acquisitions are for Phase 1 of the project.

Mike Pritchard, 23 Calumet Ave, expressed concern that the condition of the State's pension fund would affect our bond rating. Mr. Kunze explained that there is a statewide pension fund for employees. Currently the funds are separate for State employees and municipal employees. The concern is that in the future, the State would enact legislation that would allow them to use funds from the municipal portion to balance the state portion.

Dave Richardson, 320 Ramapo Valley Road, asked if the Valley View property would be sold to the public because he knows a landscaper who might be interested in purchasing the property for storage for equipment. Mr. Kunze advised that the structure would be removed even if we decide to sell the property.

CLOSED FOR PUBLIC DISCUSSION:

On motion of Councilman Jensen, seconded by Councilwoman Coira, this portion of the meeting be closed to public discussion.

ROLL CALL: All yeas, Councilmembers Coira, Jensen, Kulmala, Talamini, Visconti.

Discussion ensued over contract negotiations with the White Collar union and PBA. No action taken.
