#### MOVE TO EXECUTIVE SESSION:

MEETING CALLED TO ORDER: By Mayor Schwager at 7:38 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Coira, Knapp, Kulmala, Talamini. Absent: None. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Nylema Nabbie, Borough Attorney.

### SALUTE TO THE FLAG:

#### MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

#### PRESENTATION OF AED UNIT:

Maureen Boulanger from Atlantic Health Systems presented an Automated External Defibrillator unit to the Borough of Oakland for use at the Recreation fields. Mike Guadagnino, Recreation Chairman, thanked Atlantic Health for their donation. The Recreation Commission had wanted three AED units in the Recreation complex. The Altana family donated one and now Atlantic Health has donated a unit. The Recreation complex will be fully armed. Mayor Schwager thanked Ms. Boulanger and Atlantic Health Systems on behalf of all the residents.

#### MAYOR'S REPORT:

Mayor Schwager congratulated Councilman Talamini and Pat Pignatelli for winning the Election. She commented that although she lost the Senate race, she is so happy to be Mayor of Oakland. As she was campaigning, she got to visit other towns in District 39. She saw things that other towns are doing and has new ideas she wants to present for Oakland. Mayor Schwager advised there will be a Shred It event on December 2<sup>nd</sup> from 8 am to 12:00 pm in the Borough Hall parking lot.

## OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Kulmala, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Coira, Knapp, Kulmala, Talamini.

Ryan Schwertfeger, 58 Andrew Ave, reminded residents about the craft show fundraiser for the dog park. It will be held November 12<sup>th</sup> from 10 am to 4 pm at the Knights of Columbus.

Mayor Schwager reminded residents that Saturday November 11<sup>th</sup> is Veterans Day. There will be a ceremony in Veterans Park at 11:00 am.

#### CLOSED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Kulmala, this portion of the meeting be closed to public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Coira, Knapp, Kulmala, Talamini.

#### WORK SESSION:

#### AMEND TRAFFIC CODE:

#### AMEND TRAFFIC CODE-DOGWOOD DRIVE:

Mr. Kunze advised that the Police Department has recommended two changes to the traffic code in order to address a safety issue and improve traffic flow near Dogwood school in the afternoon. Left turns from Dogwood Drive into the entrance of Dogwood School would be prohibited from 2:30 to 3:30 pm except for school buses. Also, parking on the north side of Dogwood Drive from Hickory to the school entrance would be prohibited from 2:30 to 3:30 pm as well. Traffic Officer Fiore advised that this is a safety issue. Cars park along the curb and then parents who are waiting to turn into the school sit next to the parked cars. It forces cars coming down Dogwood Drive to go into the wrong lane. He advised that anything we do at the schools is for the safety of the children.

Councilman Kulmala asked when this would go into effect. Officer Fiore responded it would be effective when the schools open after Christmas break. Councilwoman Coira asked if parents are going to be able to park on Dogwood further up the hill. Officer Fiore responded they would be able to. Councilman Knapp suggested these changes should be communicated to parents as soon as possible. Councilman Kulmala agreed.

An ordinance will be listed for introduction at the next meeting.

#### DCA PROPOSAL TO EXEMPT CERTAIN CONSTRUCTION PERMITS:

Mr. Kunze advised that the Department of Community Affairs has made a proposal that would exempt certain work from construction code permits. The League of Municipalities and the NJ Building Officials Association have expressed concerns over safety impacts of the proposal. Borough Construction Official Dan Hagberg advised he served on the DCA Code Advisor Board and he recommended this proposal not be adopted. He explained that the DCA wants to reduce enforcement by 30%. He explained that items considered ordinary maintenance would not require a permit. It removes prior approval and removes the UCC from those requirements. He spoke about concerns for the Borough of Oakland in regards to floodplain requirements. He explained that if someone is working outside the NFIP regulations, we could be in violation for our CRS program. Mr. Hagberg explained that three towns have petitioned the DCA for a public hearing on this proposal. The hearing will be held November 29th but Mr. Hagbern advised he has heard this proposal will be adopted. Councilman Biale expressed concerns over safety issues. Mayor Schwager asked if we are allowed to have stricter enforcement. Mr. Hagberg advised that the town would not be able to supercede the Uniform Construction Code. Councilman Kulmala questioned if the Fire Department can still call if they find an issue or a hazard in a house. Mr. Hagberg said they can still call him, but he would have no enforcement powers if a permit is not required.

Mr. Hagberg advised that the Building Department lets the tax assessor know when work is being done so an assessment can be made. If permits are not required, the tax assessor won't get the information. Mayor Schwager asked what we can do. Mr. Hagberg asked the Council to consider doing a resolution opposing the proposal. Councilman Biale commented that the number one issue is safety. Councilman Kulmala asked Mr. Hagberg if the State will make exemptions for areas in the floodplain. Mr. Hagberg responded that the State does not look at each town's needs. Councilwoman Coira asked if this is pending legislation or regulations. Mr. Hagberg responded it is regulation. Councilwoman Coira is concerned with non-cosmetic work

not requiring permits but agreed with some of the points. Mr. Hagberg advised he is concerned about flood properties.

# WORK SESSION:

## SHARED SERVICE AGREEMENT WITH BERGEN COUNTY-OEM EQUIPMENT:

Mr. Kunze advised that the agreement that is being offered by the County would allow us to borrow both emergency and non-emergency equipment for short periods of time, subject to the equipment being available. There would generally be no cost to the Borough except for fuel and repairs. This arrangement would provide us with another option for delaying with emergency situations if needed. A resolution to authorize the agreement will be listed on the next agenda.

#### AMEND PLANNER CONTRACT-AFFORDABLE HOUSING WORK:

Mr. Kunze advised that Burgis Associates had previously been awarded a contract to create a Housing Element and Fair Share Plan and to assist in Affordable Housing litigation. Since this has been an ongoing issue, a contract amendment of \$56,500 is needed to cover both certain services rendered and additional work that is anticipated. The cost of this work would be covered in part by a Highlands Council grant and in part by the Affordable Housing Trust Fund so we do not expect it to impact the current fund budget. A resolution will be listed on the next agenda.

# AMEND ATTORNEY CONTRACT:

Mr. Kunze advised that due to continued work on Affordable Housing litigation and tax appeals, it is necessary to increase the Borough Attorney's contract by \$ 10,000. Funding is available in the legal budget and Tax Appeal reserve to cover the amount. A resolution will be listed on the next agenda.

#### CDBG GRANT:

Mr. Kunze explained that the applications for this year's Community Block Development Grant round are due December 8<sup>th</sup>. The only place we can use CDBG money is for the Senior Center. After considering a number of potential options, we are recommending a project to replace the vinyl siding which is 26 years old and is starting to degrade. Councilman Talamini asked if this is just going to be siding or the whole exterior of the building. Mr. Kunze responded that the roof was replaced several years ago and the doors seem to be in good condition. He will ask the Engineer and DPW if there is anything else to pursue in the grant application. A resolution will be listed on the next agenda.

#### **NEW BUSINESS:**

Mayor Schwager advised that she will appoint an Ad-Hoc Committee for Station Park at the next meeting. She would like the Council members to think of who will be liaison to the Committee.
