WHEREAS, Boswell McClave has submitted all paperwork necessary to comply with the Borough of Oakland's Pay-to-Play policy; and

WHEREAS, this contract for a professional service for which no public bidding is required; and

WHEREAS, the Chief Financial Officer has certified that funds are available in Account # C-04-56-712-208;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Council of the Borough of Oakland hereby authorize Boswell McClave Engineering to perform an inspection of the Patriot's Way Bridge as specified in the March 6, 2017 proposal for an amount not to exceed \$ 6,000.00; and

Councilman Kulmala asked how the inspection will be done. Borough Engineer Rebecca Mejia responded that an inspection will be done while the bridge is open. Weight restrictions should be determined according to the National Bridge Inspection Standards. Councilman Kulmala asked how the weight restriction is determined. Ms. Mejia responded it is formula based. Councilman Biale asked if the bridge has been inspected by the State or Federal Governments using NBIS standards. Ms. Mejia responded that this is a local bridge so the inspection falls to the municipality. Councilman Talamini asked how long the testing will take place. Ms. Mejia advised it is weather dependent and will be done over the course of a couple of days. The report will be ready in approximately 3 to 5 weeks.

Councilman Biale commented that a bridge is supposed to last 75 years and this bridge is only 17 years old. The Borough has to do its due diligence. Councilman Kulmala asked what recourse the Borough has. Mr. Chewcaskie advised that there may be issues. He spoke of the Statute of repose for design professionals which exempts them from liability after 10 years. He explained that he is compiling information so that he can put everyone on notice. He explained that the

bridge was installed by the developer. It was taken over by the municipality in the early 2000's. We are now doing research to see who actually built the bridge. Councilman Biale commented that we may be past the Statute of repose but the bridge was supposed to last 75 years not 17. Mr. Chewcaskie advised that the Statute of repose is not a Statute of limitations. It was created to protect the design professionals.

RESOLUTION 17-92 APPOINT DEPUTY REGISTRAR

She explained that the Borough has been without a Deputy Registrar and has received a letter from the State saying we are not in compliance. None of the Borough employees wished to fill the position and Ms. Frey-Veltre was interested. Councilman Visconti questioned if this position should be opened up to the public. Mr. Chewcaskie explained that according to the Statute, the appointment of Deputy Registrar is made by the Registrar. The Governing Body is just confirming the amount of compensation. Mr. Kunze explained that they tried to solicit candidates in-house. Then we sought shared service agreements with three separate towns. Nothing was successful. Then we got a letter from the State about not being in compliance. Councilman Visconti asked if Ms. Frey-Veltre is trained. Mayor Schwager responded she will be trained after we confirm the appointment.

WORK SESSION:

OVERVIEW OF BUDGET:

Mr. Kunze advised that the budget will be introduced on March 22nd. The public hearing and budget adoption will be scheduled for April 26th. If an amendment is required that would result in a public hearing, that will be scheduled for May 10th along with adoption of the amendment and final adoption of the budget. The total projected funding for budget introduction is \$18,749,795. Operating budgets including the Library are up 2.4%. This is mostly driven by the projected increase in the Solid Waste budget. The current fund salary and wage budgets are projected to increase 1.94%. Appropriations are compliant with the appropriation cap. Mr. Kunze explained that there is no increase in State Aid once again. The anticipated surplus is being reduced by \$215,000. The reduction is offset by reductions in appropriations including \$200,000 for capital and \$5,000 for the Library. The total local non-tax revenue collections were strong last year and we are recommending modest increases in various revenue lines totaling \$25,385. The projected total tax levy to support Borough and Library operations would be \$14,811,104 which is an increase of 1.84%. This increase is compliant with the tax levy cap. Councilman Visconti commented that this budget for introduction is continuing to fund the road program and the fire truck. However, the bridge issue upsets the apple cart and what we may be able to do this year.

NEW BUSINESS:

Mayor Schwager spoke about the new bail reform. If a defendant is indigent, they can apply for a public defender. Initially, this is done by the County Public Defender. However, if there is a detention hearing, that is going to fall on the municipal public defender and the Borough will have to pay for that. Councilman Visconti asked if the County paid for this previously. Mayor Schwager responded that this is a new mandate. Councilman Visconti commented that this is a State mandate and our taxpayers are going to have to pay. Mr. Kunze advised that our public defender requested the standard per session rate per appearance. He has to look at the budget and see if there is flexibility in the existing contract or if we have to add money to her contract.

COUNCIL REPORTS:

Councilman Knapp: No report.

Councilwoman Coira: The Planning Board will meet tomorrow at 7 pm.

Councilman Visconti: On April 22^{nd} , there will be a townwide Park clean up. Information will be listed on the Borough website. Next Monday, the Flood Commission will meet at 7:30 pm. He spoke about programs offered by the Library. There will be a construction kick off meeting tomorrow at 2 pm.

Councilman Biale: Senior Center Director Rose Burik received a thank you from Congressman Gottheimer for hosting his talk a few weeks ago. The Senior Center will have bingo on March 16th at 1 pm. The book club will meet on March 17th at 11 am. The Valley Hospital Auxiliary will speak at the Senior Center on March 9th. The County Executive will visit the Senior Center on April 21st at 11 am.

Councilman Kulmala: He attended the Recreation Commission meeting. The Communications Commission will meet next week. Volunteers are needed for the TV Committee. The OEM held a meeting last week. The OEM is involved in the town clean up, is looking to clear up trees in the river and will have a command station at the carnival. The new sirens are working.

Councilman Talamini: The Public Events Committee members need to fill out Citizen Leadership forms for reappointment. The Easter Egg Hunt will be held April 9th.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Visconti, this portion of the meeting be opened for public discussion.
