WHEREAS, land use is an essential component of overall sustainability for a municipality; and

WHEREAS, poor land-use decisions can lead to and increase societal ills such as decreased mobility, high housing costs, increased greenhouse gas emissions, loss of open space and the degradation of natural resources; and

WHEREAS, well planned land use can create transportation choices, provide for a range of housing options, create walkable communities, preserve open space, provide for adequate recreation, and allow for the continued protection and use of vital natural resources; and

WHEREAS, given New Jersey's strong tradition of home rule and local authority over planning and zoning, achieving a statewide sustainable land use pattern will require municipalities to take the lead;

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the Borough of Oakland resolve to take the following steps regarding municipal land-use decisions with the intent of making the Borough of Oakland a truly sustainable community. It is the Borough intent to include these principles in the next master plan revision and re-examination report and to update our land-use zoning, natural resource protection, and other ordinances accordingly:

<u>Regional Cooperation</u> – Oakland pledge to reach out to administrations of our neighboring municipalities concerning land-use decisions, and to take into consideration regional impacts when making land-use decisions.

<u>Transportation Choices</u> – Oakland pledges to create transportation choices with a Complete Streets approach by considering all modes of transportation, including walking, biding, transit and automobiles, when planning transportation projects and reviewing development applications. Oakland will reevaluate parking with the goal of limiting the amount of required parking spaces, promoting shared parking and other innovative parking alternatives, and encouraging structured parking alternatives where appropriate.

<u>Natural Resource Protection</u> – Oakland pledges to take action to protect the natural resources of the State for environmental, recreational and agricultural value, avoiding or mitigating negative impacts to these resources. Further, Oakland pledges to complete a Natural Resources Inventory when feasible to identify and assess the extent of natural resources and to link natural resource management and protection to carrying capacity analysis, land-use and open space planning.

<u>Mix of Land Uses</u> – Oakland pledges to use zoning power to allow for a mix of residential, retail, commercial, recreational and other land use types in areas that make the most sense for Oakland and the region, particularly in downtown and town center areas.

<u>Housing Options</u> – Oakland pledges, through the use of zoning and revenue generating powers, to foster a diverse mix of housing types and locations, including single and multi-family, for-sale and rental options, to meet the needs of all people at a range of income levels.

<u>Green Design</u> – Oakland pledges to incorporate the principles of green design and renewable energy generation into municipal buildings to the extent feasible and when updating site plan and subdivision requirements for residential and commercial buildings.

<u>Municipal Facilities Siting</u> – Oakland pledges, to the extent feasible, to take into consideration factors such as walkability, bikability, greater access to public transit, proximity to other land-use types, and open space when locating new or relocated municipal facilities.

BE IT FURTHER RESOLVED that the Borough Clerk be and she is authorized and directed to maintain a copy of this Resolution in office of the Borough Clerk, for public inspection, pursuant to law.

FINAL PUBLIC HEARING: ORDINANCE NO. 17-CODE-757-TABLED

Councilwoman Coira explained that this ordinance had been tabled because she had concerns that the ordinance is unconstitutional as it applies to Oakland. The ordinance includes critical land use and the whole Borough is sole source aquifer. The net effect is the same as the other pipeline ordinance and in her opinion, is unconstitutional. She would like an answer to her concerns without having to pay the attorney who drafted the ordinance. Borough Attorney Nabbie explained that her office did not draft the ordinance and they did not do research on it so she is reluctant to give an opinion. It seems to be a form ordinance.

MOTION TO REMOVE FROM TABLE:

On motion of Councilman Biale, seconded by Councilman Knapp, Ordinance 17-Code-757 be removed from the table for final adoption.

ROLL CALL: Yeas, Councilmembers Biale, Talamini, Visconti. Nays, Councilmembers Coira, Knapp, Kulmala.

Mayor Schwager broke the tie and voted nay. The ordinance remains tabled.

NEW BUSINESS:

Councilman Talamini advised that the Public Events Committee is deciding whether to have another date scheduled for fireworks. They were thinking about having the event on a Friday night. There are costs involved such as the cancellation fee to the fireworks vendor and costs for Police and DPW personnel to work the event. He asked if a survey could be put on Facebook to ask the residents if they want to have the fireworks. Councilman Biale asked what the cost will be to the vendor. Mr. Kunze advised there is a small charge because the vendor showed up onsite the day the fireworks were cancelled. He explained that we can reschedule the fireworks at no additional fee. If we cancel entirely, there is a cancellation fee of 50%. The fireworks cost is \$11,000 plus the cost of Police and DPW personnel to work the event. Councilman Talamini explained that Public Events already paid for Police and DPW for the carnival and would have to pay them again if the fireworks were rescheduled. Councilman Visconti thinks it is a good idea to ask the public. Mr. Kunze suggested that we can wait for Public Events to hold their meeting on Monday.

COUNCIL REPORTS:

Councilman Talamini: The Public Events Committee is getting ready for Halloween. Councilman Talamini, Councilman Biale and Councilman Knapp met with some members of the School Board as well as the Superintendent of Schools and School Business Administrator regarding the School Election. The Board of Ed is

waiting for the report from the State Committee. He advised that February is the latest we can wait to move the School Election to November. Councilman Biale commented that there are rumors that after January, all school elections will be moved to November. They are waiting for a new Governor to make a change.

Councilman Kulmala: He commented it is good to be back from his trip. He brought information back for Councilman Biale regarding LED lighting.

Councilman Biale: The Senior Center will hold Bingo on August 17th at 1 pm. There will be root beer floats on August 21st at 1 pm. The Oldies Night concert will be held on Breakneck Road on August 24th at 6:30 pm.

Councilman Visconti: There was no Flood Commission meeting. The Library construction is still on schedule. There was no quorum for the Park Committee meeting this month. He met with Engineer Gary Ascolese regarding Station Park.

Councilwoman Coira: She spoke to an arborist regarding the tree work being done by Rockland Electric. The regulations have changed and they now have to clear everything above the wires. If the tree dies because of what they cut, Rockland is responsible to replace the tree.

Councilman Knapp: No report.

Mr. Kunze advised that the new air conditioning unit for the Senior Center is going to be installed tomorrow. Regarding the VOC issue at the Council Chambers, it is going to be removed tomorrow. We will have to wait a week then retest and then we can get back in there. The Court offices need to address the mold issue before the Court personnel can return.

Mayor Schwager asked about the water testing in the schools. Councilman Talamini advised that the water got the same rating as the testing last year but the State changed the thresholds. The schools have shut off the water fountains that failed and are getting new fountains. Councilman Visconti commented that it could be a problem with the internal plumbing.

Mayor Schwager asked about the Patriot's Way Bridge grant. Mr. Kunze has not heard from the State regarding the grant.

Mayor Schwager advised we will need to hold an Executive Session this evening. She commented that in the past, the Council has cancelled the last meeting in August. Is there any reason we need to have the August 23rd meeting. Mr. Kunze advised that it would be five weeks before we can pay bills. He suggested that the Council can do a quick meeting on August 30th. The consensus was to hold Exec session at 6:30 pm and the regular meeting at 7:00 pm.
