SALUTE TO THE FLAG AND MOMENT OF SILENCE

Mayor Linda H. Schwager announced that proper notice of this meeting was made as to time, date, place, and agenda.

MAYORS REPORT:

Mayor Schwager thanked the Access for All Committee for organizing the Santa Tour event at the Danny D'Elia Building. The Mother's Club of Oakland and Oakland Elks Lodge donated the refreshments. The Indian Hills High School Interact Club also donated their time to help with the event. It was announced that anyone who is interested in joining the Access for All Committee is welcomed to file a Citizen Leadership Form. The Borough Holiday Lighting Showcase took place on December 20, 2022. Mayor Schwager attended the Bergen County Police Academy Graduation to congratulate Karley Greulich and welcome her to the force.

OPEN PUBLIC COMMENT:

Councilman Pignatelli set forth the motion, seconded by Councilman Kulmala, to open for public comment.

ALL IN FAVOR.

Justin Lee and George Lutfey of 7 Bannehr Street, Oakland, N.J. 07436, commented that their Cannabis Cultivation Business is wanted by the residents and has met all of the qualifications set forth by ordinance. A petition was provided to the Mayor with over 500 signatures in favor of their business license. It was noted that 50 signatures were from Oakland residents. Mr. Lutfey introduced the owner of Precision PC, a company that assists with compliance. It was noted that 67% of residents voted in favor of marijuana. Mr. Lutfey commented that Kusala Care LLC. has

arranged to outsource their water. Mr. Lutfey commented on the protest that took place at Councilman John McCann's home.

Jason Thomas, owner of Precision Quality Compliance, introduced himself and his company, which assists with compliance and control in the cannabis industry.

Gregory Lutfey commented that a Tort Claim has been filed against the Borough of Oakland for damages against their business. Mr. Lutfey commented that Kusala Care LLC. has been paying rent for five (5) months. Mr. Lutfey added that Kusala Care LLC. has satisfied all of the requirements set forth by the ordinance and the application was submitted in September 2022. The State has deemed that Kusala Care LLC. is qualified per Mr. Lutfey. Mr. Lutfey added that the motion to table has delayed their efforts and will force their timeframe to expire with the State. Mr. Lutfey added that if the Borough continues to table, Kusala Care LLC. must take the appropriate legal actions. Mr. Lutfey urged the Governing Body to embrace capitalism and to move forward with the endorsement.

Deborah Mutterer of 101 Walnut Street, Oakland, N.J. 07436, commented that the 50 signatures from Kusala Care LLC. is minimal compared to the 12,700 plus residents in the Borough. Ms. Mutterer asked on the status of the sinkhole in front of her driveway. Mr. Yakimik advised that he would circle back with Ms. Mutterer on the issue.

22-318: AUTHORIZE SHARED SERVICES AGREEMENT WITH BERGEN COUNTY UTILITIES AUTHORITY FOR SANITARY SEWER CLEANING

WHEREAS, the Borough of Oakland requires, at various times, jetting services of sanitary and storm water systems; and

WHEREAS, the Superintendent of the Department of Public Works and the Borough Administrator have reviewed the proposal of Northwest Bergen County Utilities Authority (NBCUA) to provide such services on an as-needed basis; and

WHEREAS, the Borough Attorney has reviewed the Shared Service Agreement forwarded to the Borough by the Executive Director of the NBCUA; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor of the Borough of Oakland is hereby authorized and directed to execute the Shared Service Agreement for the provision of sanitary sewer cleaning for the Borough of Oakland; and

22-319: AUTHORIZE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION AMENDED GREEN ACRES PROJECT AGREEMENT

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides loans and/or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Borough of Oakland has previously obtained a grant of 3,525,000.00 from the State to fund the following project(s):

#0242-04-055 Borough of Oakland Open Space and Recreation Plan; and

WHEREAS, the State and the Borough of Oakland intend to increase Green Acres funding by \$500,000; and

WHEREAS, the applicant is willing to use the State's funds in accordance with its rules, regulations and applicable statutes, and is willing to enter into an Amendment of the Agreement with the State for the above-named project;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Oakland, County of Bergen, State of New Jersey, as follows:

WHEREAS, the New Jersey Department of Transportation wishes to modify the agreement and authorize additional funding in the amount of \$43,914.80 for the final design stage of the Safe Routes to Schools Grant Project; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Borough Council hereby authorize an agreement modification with the New Jersey Department of Transportation for additional funding in the amount of \$43,914.80 for a total agreement amount of \$114,116.78;
