22-312: AUTHORIZE CELL TOWER CO-LOCATION AGREEMENT

WHEREAS, a Lease Agreement was entered into with Sprint Spectrum, LP, the predecessor in interest to SBA 2012 TC Assets, LLC ("SBA") on September 29, 2002 for the installation of wireless telecommunications facility at the Thornton Road Water Tank Site; and

WHEREAS, Paragraph 3 of the lease agreement provides for the collocation on the wireless telecommunications facility; and

WHEREAS, pursuant to the terms of the Lease Agreement, fifty (50%) percent of any rent received by SBA for such collocation is to be paid to the Borough; and

WHEREAS, SBA has negotiated an agreement with Dish Wireless LLC; and

WHEREAS, such agreement provides for the payment of \$1,999.90 per month to SBA with a 2 percent annual increase; and

WHEREAS, SBA has requested that the Borough approve the agreement with Dish Wireless LLC for collocation on the Thornton Road Water Tank wireless telecommunications facility.

WORK SESSION:

HISTORIC PRESERVATION COMMISSION/COMMITTEE ANALYSIS:

Borough Attorney Brian Chewcaskie provided a memorandum explaining the differences between establishing a Historic Preservation Commission vs. Committee. Mr. Chewcaskie advised that a Commission is a creature of statute and would be an autonomous body with specific review powers of land use applications. The Commission would also have oversight on permit applications for residential construction and improvement projects. A Committee is an advisory body with specific charges. Mr. Chewcaskie added that the Borough Planner is working on identifying historic structures in the Borough. Councilman Pignatelli asked for the intent of establishing such a body. Mayor Schwager added that the Borough must be plan ahead of sewers being installed in the Central Business District. Mr. Chewcaskie also added that the Borough would have the right to enact historic districts within the Borough. It was explained that if there is a non-historic property within a historic district, the Commission would have the authority to review construction permit applications. Councilman Pignatelli stated that he is in favor of a Committee form. Mayor Schwager suggested that the Governing Body review the analysis and this topic be placed as a work session item at the next Borough Council Meeting.

NEW BUSINESS:

No new business reported.

OLD BUSINESS:

Mayor Schwager asked on the status of the Stream House Design and a follow-up meeting with the State Historic Preservation Office. Mr. Kunze advised that he is working on scheduling a meeting for the near future.

Councilman Talamini left the meeting at 7:55 p.m.

COUNCIL COMMITTEE AND LIAISON REPORTS:

COUNCILMAN KULMALA: Absent.

COUNCILMAN MCCANN: Councilman McCann read aloud a message from the Police Chief warning residents to lock their cars and to not leave key fobs in their car due to recent thefts in the area. If the public has any leads on the recent thefts within the Borough, please contact the Oakland Police Department Detective Bureau at (201) 337-6171. Councilman McCann informed the public of an individual by the name of Larry Levine who has been inappropriately contacting him. Councilman McCann advised that although Mr. Levine is entitled to his first amendment rights to contact a public official, but on two occasions, personal property was approached by Mr. Levine and/or an agent of Mr. Levine's. Councilman McCann warned Mr. Levine to not approach his property at any time in the future. Mayor Schwager confirmed that this is not the Levine Family who lives on Martha Place.

COUNCILMAN PIGNATELLI: Councilman Pignatelli reported that the Environmental Commission held their meeting on December 6th. The Sustainable Oakland Green Team is recycling Christmas Lights throughout the Holiday season at the Ace Hardware and Copper Tree Mall. The Commission is working on projects for 2023 such as park cleanups and solar panels. The Commission is working on revitalizing the butterfly and pollinator gardens within Great Oak Park. Lastly, the Commission will be working on promoting composting to the public via social media and educational opportunities. The Senior Center Noon Year's Eve Party was announced on December 31, 2022 at 11:00 a.m. Councilman Pignatelli encouraged the public to get the flu shot, especially senior citizens. Over 4,000 deaths have been reported in 2022 due to the flu.

COUNCILMAN SALIANI: Councilman Saliani reported that the Shade Tree Commission met and the Borough Tree Inventory is 50% completed. The Commission is seeking a new Borough Forester. RFQ's have been released for spring tree plantings and tree removal and pruning. Councilman Saliani read aloud statistics for tree permits and replacements. The Toys for Tots Train was announced for December 10, 2022 at Bush Plaza.

COUNCILMAN SLASINSKI: Councilman Slasinski reported that the completion date for the Sanitary Sewer Treatment Plants Decommissioning Project remains August 24, 2023. The contractor has completed all force main piping work except for the directional drilling at the railroad crossing on Ramapo Valley Road. Boswell Engineering investigated that the work be done at night, however at an extra cost to the Borough. The contractor has commenced installing the gravity sewer along Monhegan Avenue and Lakeside Boulevard. This work will take approximately two (2) months to complete. The Iroquois Pump Station Upgrades project will be completed by early 2023. The Oakland Public Library has announced a performance of the Nutcracker on December 11, 2022.

COUNCILMAN TALAMINI: Absent.

Mayor Schwager announced that there is a meeting scheduled with the public for an update on the Sanitary Sewer Treatment Plant Decommissioning Project on Thursday December 15, 2022 at the Oakland Senior Center, 20 Lawlor Drive.

OPEN PUBLIC COMMENT:

Councilman Pignatelli set forth the motion, seconded by Councilman Saliani, to open for public comment.

ALL IN FAVOR.

Edward Hudzina of 576 Ramapo Valley Road, Oakland, N.J. 07436 asked why his neighbor's mailbox was not replaced yet as a result of the sidewalk installation project. Mr. Hudzina suggested that installing sewers in the downtown would bring in an excess of redevelopment that will negatively affect the already poor traffic situation.

Mame Schwarzfischer of 187 West Oakland Avenue, Oakland, N.J. 07436 encouraged the public to attend the Toys for Toys Event. Ms. Schwarzfischer advised that she would like to setup something to recognize the Veterans on Veterans Day for 2023. Mayor Schwager advised that the American Legion Post 369 usually hold an outdoor ceremony. Ms. Schwarzfischer advised that she would get together with the American Legion to expand the program for 2023. Ms. Schwarzfischer encouraged the public to volunteer at the Van Allen House for educational programs.

Councilman Pignatelli set forth the motion, seconded by Councilman Saliani, to close public comment.
