Meeting of the Borough of Oakland Mayor and Borough Council opened on the above date at 7:00 p.m. in the Oakland Municipal Court/Council Chambers, 10 Lawlor Drive, Oakland, N.J. 07436.

Mayor Linda H. Schwager presiding.

Mayor Linda H. Schwager announced that proper notice of this meeting was made as to time, date, place, and agenda.

SALUTE TO THE FLAG AND MOMENT OF SILENCE:

MAYOR'S REPORT:

Mayor Schwager congratulated the Indian Hills High School students on making it to the Mock trial finals against Bergen Catholic. Mayor Schwager stated she will be in a short scene with other mayors for the FLOW Follies, which involves the schools in Franklin Lakes, Wyckoff, and Oakland. She encourages all to come and enjoy the show. At the last Council meeting the issue of the Borough cannabis ordinance was raised in work session, and the request was made to bring forth a repeal. Many questions were raised about the committee that spent months investigating and proposing a draft ordinance. Mayor Schwager reviewed the hard work and investigation that the Ad-Hoc Committee performed. Mayor Schwager stated that the committee brought forth a very well thought out ordinance which involved many capable and qualified persons. Mayor Schwager also stated that the Council voted unanimously in favor of the proposed ordinance. Mayor Schwager sited Lodi's situation and the revenue they are receiving. The Mayor stated that the ordinance cannot be repealed for 5 years.

Councilman Pignatelli set forth the motion, seconded by Councilman Saliani, to open for public comment.

Mike Guadagnino of 34 Hopper Street, Oakland, NJ 07436 stated he was a member of the Cannabis Ad-Hoc Committee. He takes offense to the statements made about the committee without anyone from the committee there to defend the work they did. Mr. Guadagnino stated that he and all the members worked very hard to come up with an Ordinance that was in the best interest of Oakland residents. At no time did they ever consider retail and their focus was on growing, manufacturing and distribution. He stated that they put the ordinance together keeping in mind the 38% of residents that didn't vote for cannabis to be legal.

Matt Goodrich of 72 Hiawatha Blvd. Oakland, NJ 07436, stated he was on the Cannabis AD-Hoc Committee. The committee did a great job reviewing and researching what would and not work for the Borough of Oakland.

Frank Di Pentima of 6 Mountain Lakes Road, Oakland, NJ 07436 stated he was on the Cannabis Ad-HOC Committee. He was against cannabis. Everyone working together on both sides of the discussion came to the consensus of what would be best for Oakland and what to take advantage of. Mr. DiPentima encouraged the Borough Council to look at ways to save and generate money for the residents.

Jo-Ann Ashkenazi of 502 Ramapo Valley Road, Oakland, NJ 07436 stated she was on the Cannabis Ad-Hoc Committee as well and found the attack on their work offensive and feels apologies are in order. Ms. Ashkenazi sited many facts with regards to mothers and babies and the effect of several drugs.

Mame Schwarzfischer of 187 West Oakland Avenue, Oakland, NJ 07436 read aloud statistics of deaths related to other drugs legal and illegal. Feels that many residents need financial help, and the income would be beneficial to the Borough.

Justin Lee of 7 Banneher Street, Oakland, NJ 07436 stated he had a one-and-a-half-hour phone call with Councilman McCann with regards to cannabis and the effects/affects to the community. He defends the benefits of properly used and grown products. There are shops selling unregulated product with pesticides in it. He stated there are three species of plants and recommend that people do their research and educate themselves.

George Luftey of 7 Banneher Street, Oakland, NJ 07436 stated that cannabis was legalized 2 years ago. Mr. Luftey gave out a one-page document from the states cannabis ordinance to the councilmembers pointing out all the rules and regulations they must follow to not lose their license. Their top priority is health and safety standards and compliance to the rules.

Mame Schwarzfischer of 187 West Oakland Ave, Oakland, NJ 07436 stated that 10 % of the workforce would be Oakland residents. How many residents could they employ per the ordinance?

Matt Goodrich of 72 Hiawatha Blvd, Oakland, Nj 07436 cited the benefits of the revenue to the residents of Oakland.

PUBLIC HEARING ON BERGEN COUNTY OPEN SPACE TRUST FUND GRANT REPURPOSE SUBMITTAL FOR TRUMAN FIELD REFURBISHMENTS PROJECT

Mr. Kunze advised that in late 2021, the Borough was awarded a \$200,000 grant through the Bergen County Open Space Trust Fund to help fund the refurbishment of Truman Field. The original scope focused on rehabilitating the field, replacing the irrigation system, and replacing the fence among other items. Since the original grant award, the recreation Commission's focus has shifted to providing field lighting to enable increased use of facility and a decreased playing surface to make is safe, and both the irrigation system and fencing would be repaired instead of replaced. This change in scope requires approval from Bergen County to utilize the previously awarded grant funds and the public hearing is part of the approval process. Resolution 23- authorizes the submittal of the application. Resolution 23-91 authorizes the submittal of the application to Bergen County.

BE IT RESOLVED, that the Mayor and Borough Council of the Borough of Oakland wish to enter into a Bergen County Trust Fund Project Contract ("Contract") with the County of Bergen for the purpose of using a \$127,995.00 matching grant award from the 2022 Funding Round of the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund ("Trust Fund") for the municipal park project entitled Bush Plaza Revitalization Project;

23-91: AUTHORIZE GRANT REPURPOSE SUBMITTAL FOR FY 2021 BERGEN COUNTY OPEN SPACE TRUST FUND MUNICIPAL PARK INPROVEMENT FUND FOR TRUMAN FIELD REFURBISHMENTS

WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund (the "County Trust Fund"), provides matching grants to municipal governments for assistance in the development or redevelopment of municipal recreation facilities; and

WHEREAS, the Borough of Oakland (the "Borough") had received a 2021 Trust Fund matching grant award of \$204,369, which was approved via County of Bergen Board of Chosen Freeholders Resolution No. 1094-21, dated December 15, 2021, for its "Truman Field Refurbishments" project (Project Contract No. 2100550); and

WHEREAS, Truman Field Refurbishments project was to include the construction of a New Surface, Leveling and Sprinkler System; and

WHEREAS, the Mayor and Borough Council has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions and desires to make such a request for use of its grant and provide application information and furnish such documents as may be required; and

WHEREAS, as part of such request, the governing body received public comments on the proposed repurpose and use of its 2021 Trust Fund Municipal program grant award on February 22, 2023; and

WHEREAS, the County of Bergen shall determine whether the proposed request and use of the 2021 Trust Fund grant award are complete and in conformance with the scope and intent of the County Trust Fund; and,

WHEREAS, the Borough is willing to use the County Trust Fund grant in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the approved project and ensure its completion on or about the project contract expiration date of December 15, 2023.

WHEREAS, N.I.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and WHEREAS, N.I.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Oakland, County of Bergen has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2023 budget year.

Councilman McCann stated that he must leave the meeting early and would like to give his committee report. Mayor Schwager gave councilman McCann the floor to speak. Thank you to all for coming out and for your comments. Whether or not I disagree on a personal level I have never interjected my personal feelings into this issue at all, as related to the prior meeting. Councilman McCann apologized to Mayor and Councilman Pignatelli for behavior and tone. He cited professional background and experience. He never disparaged the Ad-Hoc Committee. Asked why PD was not on the Ad-Hoc or those in addiction recovery industry. Challenged credible sources of public health. Cited an article from a San Diego Hospital. Mayor commented that Councilman McCann was not on the committee and did not provide any comments. He stated he had a fruitful and open-minded conversation with Mr. Lee. Councilman McCann left the meeting at 8:16PM.

WORK SESSION:

SUSTAINABLE OAKLAND GREEN TEAM RAIN BARREL PROGRAM

Mr. Kunze reviewed the program that the Green Team would like to implement. Residents can buy barrels at the Borough's cost and it is similar to the recycling barrel and composter programs. The cost of the barrel would be \$75.00. Councilman Kulmala added that the team explored this a year ago and fee would cover barrel cost only.

SHARED SERVICES AGREEMENT WITH BOROUGH OF BLOOMINGDALE FOR STREET SWEEPING SERVICES:

Councilman Saliani stated that currently the Borough contracts with a vendor to sweep the Borough roads in compliance with stormwater management requirements and at additional times on certain roads as litter control measure. The vendor cost and cost to dispose of the collected material is approximately \$36,000 plus the time and fuel cost for our personnel to handle the material disposal. While this approach has proven to be more cost effective than buying and operating our own machine, there have been increasing issues with the vendor's performance such as equipment breakdowns, material not being swept and lack of set sweeping schedule. As an alternative, the Borough of Bloomingdale is able to provide the service to us, having just purchased an additional sweeper. The cost would be slightly higher, at about \$40,500 per year of a proposed five-year agreement. The range for increase 2 % per year with a 60-90 days' notice. However, this cost includes disposal of the material, thus freeing up DPW personnel for other tasks, and we will have control over the scheduling. Bloomingdale already provides the service to other municipalities and those towns report that the service level is excellent. Street sweeping is an important activity, both for compliance with the states stormwater management regulations and for keeping Oakland clean and presentable. Therefore, even though the cost is slightly more, Councilman Saliani recommends approval of the shared service agreement with Bloomingdale. Councilman Kulmala

asked if it is our personnel or Bloomingdale's personnel doing the work? Mr. Kunze stated that Bloomindale staff will operate the equipment and dispose of debris freeing up Borough employees. **NEW BUSINESS:**

OLD BUSINESS:

Mayor Schwager reminded the Oakland Community of the scheduled Blood Drive on February 28, 2023, from 12-6 at the Oakland Senior Center. No appointment needed. \$10.00 amazon card will be given by mail.

Councilman Kulmala asked for an update on where things are with the testing of water. Mr. Kunze responded that permit applications have been filed, they are being reviewed by the DEP. We are undertaking the bid process to procure the required equipment, and we will take bids next Friday. Mr. Kunze advised that there should have bid award recommendation for the March 8, 2023 meeting. Councilman Saliani asked if there is an update on Patriots Way Bridge. Mayor Schwager responded that she is in contact with the Governor's office, with the Congressman's office and the Department of Transportation. We are waiting for an answer. The Mayor is working hard to get money for the Borough. Councilman Pignatelli added that he had heard that they were considering lowering the weight limit from 10 tons to 3 tons. Mr. Yakimik stated they inspected the bridge last June; they are calculating the results. Boswell is expecting the results at the end of the week. Councilman Saliani stated he would like to keep the RML community and board informed.

COUNCIL COMMITTEE AND LIAISON REPORTS:

Councilman Kulmala: It was reported that the Sustainable Oakland Green Team is having their Sunday Hike at 11 am on March 5, 2023 for the Ramapo/Skyline Loop trail walk. Meet in lower parking lot. The Sustainable Green team is also hosting the Environmental Commission and Shade Tree commission on February 28, 2023 for a joint meeting to discuss coordinating future projects. The Green team is also hosting two Bird Watching events on April 29 and May 13 at Great Oak Park, signups are now open. Check the website for more information. Reminder, Spring is here, and the Oakland Library hosts a seed bank with a large selection of organic vegetables, it is time to start planning. You can ask the library front desk for information. The next Styrofoam Drive will be April 22, 2023. The Arts Committee is meeting Monday February 27, 2023, at 7 PM at the Senior Center. The last Thursday Open Mike night has been rescheduled. 3rd Annual Arts in Oakland is accepting applications. The event is scheduled from June 9-11, includes poetry and music. Looking for performers and visual artists with talent. For more information go to the Arts in Oakland Website. Planning Board has had a busy couple of weeks. They had a very positive meeting on February 15, 2023. They took a walk from Franklin Avenue to West Oakland Avenue. Several ordinances will be forth coming from the Planning Board, which includes creating an Architectural Review Board, a Historical Commission and the intent is to get in front of the possibility of Sewers coming to downtown.

Mayor Schwager is meeting with the Oakland Chamber of Commerce. She added that she is sponsoring a breakfast to get the businesses involved and working with the Council so they can help in strengthening the structure of downtown.

Councilman Pignatelli: Councilman Pignatelli stated his credentials with regards to public health and he would like it on record his experience and public health involvement for many years. Councilman Pignatelli stated the Borough Council's job was not to pass judgement on the law. The Borough Council's job was to consider what would be a good fit for Oakland and to help lower our debt. Retail establishments were never an option for Oakland. Councilman Pignatelli read aloud a report from the Chief of Police. The Board of Health meeting did not pass any rules or regulations and are pleased to report that there is a 100% vaccination rate in the pre-schools.

Councilman Saliani: The Bush Plaza Park Ad-Hoc Committee has received a grant from the Bergen County Open Space Trust Fund for the project. The Committee has scheduled a follow up meeting on March 6, 2023, regarding implementation of the project and fundraising efforts. Recreation is holding a Spring Break Camp for grade K-8. Summer sports clinics are open for signups, there will be no late registrations. The sign-up period is March 1-31, 2023. All information is available at Oaklandrec.org. The Rutgers safety course is schedule for March 10, 2023 there is no charge for the course and is mandatory for all coaches. The Indian Hills Basketball team is in the quarter finals in states for basketball.

Councilman Kulmala stated that he and Mr. Yakimik had a utility company do a walk through to review and discuss having a cohesive plan to move forward. Mr. Goodrich asked the Councilmembers to be leaders with regards to the cannabis ordinance

Dave Richardson of 320 Ramapo Valley Road, Oakland, NJ 07436 asked if Ramapo Valley Road is being paved this year. Mr. Kunze confirmed that Ramapo Valley Road is on the list to be paved this year. There is a pothole on E. Oak Street and Ramapo Valley Road. Mr. Yakimik will investigate issue.

Danny D'Elia of 7 Fordham Road, Oakland, NJ 07436 stated a better apology to the resident from the last meeting is required and should be forthcoming from Councilman McCann.
