WHEREAS, the Borough Council invited written arguments/statements from Ms. Brennan and the attorney for the applicant, Ben Cascio, Esq.; and

WHEREAS, Mr. Cascio submitted a written statement on December 16, 2021; and

WHEREAS, the Borough Council conducted a hearing on December 20, 2021; and

WHEREAS, the Borough Council, after carefully considering the evidence presented on behalf of the applicant as well as all testimony and review of the advice and recommendations of the Board's professionals, makes the following findings of fact and conclusions of law:

- A: FINDINGS OF FACT
  - 1. The applicant, Ellahi Fuel, Inc. filed an application with the Zoning Board of Adjustment seeking a use variance to operate a vehicle service station.
  - 2. The Board heard testimony from the following individuals on the following dates:
    - December 8, 2020 Sam Ellahi
    - February 9, 2021 Sam Ellahi and Robert Weissman, Civil Engineer
    - April 13, 2021 Bryan Rowin, Oakland Traffic Officer, and Joseph Staigar, Traffic Engineer for applicant
    - June 8, 2021 Sam Ellahi, Robert Weissman and Joseph Staigar

July 13, 2021 – Joseph Staigar, Charles Heydt, applicant's Planner,

John Yakimik, Board Engineer and Steve Lydon, Board Planner

- 3. The Zoning Board approved the application on July 13, 2021 and memorialized its determination on September 14, 2021.
- 4. The Borough Council has reviewed all the testimony as provided in the written transcripts of the proceedings before the Board.

## B: CONCLUSIONS OF LAW

- 5. The Borough Council specifically finds that the applicant, Ellahi Fuel, Inc., did not establish special reasons for the grant of the use variance requested as required under <u>N.J.S.A</u>.40:55D-70(d). Specifically, the Borough Council finds that the Board misapplied the special reasons standard required in review of this application as the use of the property by Ellahi Fuel was a convenience to the applicant and was presented as a way to alleviate concerns that exist regarding a non-conforming use to the south of the proposed property. The vehicle service station use on the adjacent property served as a convenience to the applicant and did not provide any benefit to the area, nor were any of the purposes of zoning advanced which would merit granting the application. The particular suitable standard is fact specific and site sensitive that requires a finding that the general welfare would be served because the proposed use is peculiarly fitted to the particular location. See <u>Price v. Himeji</u>, 214 NJ 263 (2013)
- 6. The Borough Council finds that the Board ignored the advice of its own professionals, the Board Engineer and Board Planner, with regard to the review of the application. Specifically, the Board Engineer recommended certain actions be taken into consideration if Terhune Street was to be widened. The applicant refused to consider any such recommendations. The Board Planner, Steve Lydon, indicated that in the zone there are 75 specific uses which could be placed on the site which were not addressed by the applicant or the applicant's planner. In fact, Mr. Lydon indicated that the Master Plan had specific recommendations for the downtown zoning districts and service stations were specifically prohibited as a permitted use.
- 7. The Borough Council finds that special reasons were not identified that would support the grant of the use variance. In addition, the negative criteria was not satisfied in that there would be substantial detriment to the public good and an impact on the Borough's Master Plan and Zoning Ordinance. As to the detriment to the public good, the Borough Council finds that the expansion of an additional non-conforming use in the downtown area will have a significant impact on the surrounding area and businesses being conducted and also have a negative impact on traffic. With respect to the Master Plan, the Borough Council specifically finds that the proposed use is contrary to the Master Plan and no attempt was made by the applicant to reconcile this discrepancy.
- 8. This Resolution is intended to be a synopsis of the review of the record by the Borough Council and is not intended to be exhaustive. Since this is a *de novo* review, the Borough Council specifically has reviewed the entire record and considered all evidence and testimony considered by the Board. As a result of this review, the Borough Council determines to reverse the Board's decision in accordance with the authority granted to the Council pursuant to <u>N.J.S.A.</u>40:55D-17.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Oakland, that the determination of the Oakland Zoning Board of Adjustment granting a use variance pursuant to <u>N.J.S.A</u>.40:55D-70(d) is hereby reversed. The Borough Council determines that the site is not suitable for the use proposed and that the variance cannot be granted without substantial detriment to the public good and that the requested variance relief will substantially impair the purpose and intent of the Master Plan and Zoning Ordinance of the Borough of Oakland and therefore the determination of the Zoning Board of Adjustment is hereby reversed.

The Clerk was directed to take from the table Ordinance No. 22-Capital-874 and read by title for its final hearing.

The Clerk then read by title an Ordinance entitled " CAPITAL ORDINANCE OF THE BOROUGH OF OAKLAND, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$400,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE WATER UTILITY CAPITAL IMPROVEMENT FUND AND THE WATER UTILITY CAPITAL FUND BALANCE OF THE BOROUGH."

#### WORK SESSION:

COMPLETE STREETS TECHNICAL ASSISTANCE PROGRAM:

Mr. Kunze explained that in order to increase our chances of obtaining grant funding for downtown streetscape improvements, the Borough needs to adopt a 'Complete Streets' policy. Through a competitive application process, the NJTPA and Rutgers University provide free technical assistance to help towns develop their policies. We would like to utilize this assistance and seek to apply for acceptance in their program. Councilman Talamini asked if this program would allow the Borough to get more funding. Michael Carelli, Assistant Administrator, responded that complete streets takes into account vehicles, pedestrians and bicycles. It is just a policy but it will increase our chances of funding in the future. The DOT advised that the Borough will not receive funding unless we had this policy. Councilman Kulmala asked if this addresses the shortcomings for our last two TAP grant applications. Mr. Carelli responded that it does. Councilman Kulmala asked what area this will be applied to. Mr. Carelli responded that it is focused on the downtown from Franklin Ave. to Oak Street. Mr. Kunze explained that when we filed the last TAP grant application, there were elements that addressed issues of complete streets but we lost points because we didn't have a policy.

#### OLD BUSINESS:

Councilman Pignatelli advised he and the Mayor met with the Borough Administrator, Police Chief and Engineer on the traffic downtown. The Engineer will take the suggestions from the meeting and run it through a simulator and come up with cost estimates. He explained that they will look at the cost benefit and bring to the Council to make a decision.

COUNCIL REPORTS: Councilman Van Eck: No report.

Councilman Kulmala: The Green Team had a meeting last night. Ali Fleeson was named Chair and Brian Reilly Vice-Chair. They collected 500 lbs of sytrofoam and over 1000 residents dropped off Styrofoam in the Styrofoam drive. The seed bank is open at the Library and the Green Team is working on holding a plant sale. The Planning Board will hear a commercial application for a building on Van Vooren Drive.

Councilman Pignatelli: The Senior Center will have a Super Bowl Movie Day party on February 3<sup>rd</sup>. There are appointments available for a podiatrist who will come to the Senior Center on February 18<sup>th</sup>. The Knitting and crochet club will do a service project in February.

Councilman Talamini: He is looking forward to being liaison to Municipal Alliance. He asked if the Citizen Leadership forms could be a fillable form on the website.

Councilman Slasinski: The water main replacement at Doty Road is substantially complete. The contractor will begin work on the water main replacement on Grandview and Mountainview Ave. The Skyview lining project is 90 percent complete. The Borough is evaluating treatment options for the PFAS. The Library will have more programs by the end of February. The Senior Center offers delivery of Library items to homebound residents.

Councilman Saliani: Christmas trees will be collected on February 4<sup>th</sup>. If residents see potholes, they should report it to the DPW. The DPW will begin annual outfall inspections in February. The Borough's paper shredding will take place on May 14<sup>th</sup>. Shade Tree Commission is looking for a new member. They are starting an Adopt a Tree program and there are already 15 requests. The Shade Tree Commission meets the first Monday of the month and is currently on Zoom. The historical grant for the Van Allen House was approved.

Councilman Kulmala: The Patriots Way Bridge remains safe. The next inspection is scheduled for June 2022. Congressman Gottheimer held a press event in December 2021 to bring attention to the bridge. The current cost of replacement is \$ 5.65 million.
