Goals for the upcoming Year.

- 1. Recycling center/ Dump. We as a governing body will do whatever it takes to oppose this center!!! As I have stated before it is 60ft from the first residential community and 80 feet away from the Ramapo River.

 The governing body has already authorized 10,000 dollars to secure legal services!
- 2. Bring the State, County and Railroad to the table to address the neglected areas of Oakland that fall within their control. Route 287n Exit 58. West Oakland Ave. barrels guardrail etc. Same for the exit by the EXXON. How nice would it be to have a sign at the corner welcoming visitors to Oakland? Trim the trees by the tracks when you turn left on west Oakland Avenue. New signage by welcoming everyone to Oakland!
- 3. Complete Bush plaza! Thank you to all the volunteers that had the vision to start this project, now it time to finish it!
- 4. Van Allen house property. The ugly fence has to go! This property has to be completed so it is a bookmark that at one end with Bush Plaza at the other. I have asked volunteers to create a land scape design rendering of the property! The governing body will get this done!
- 5. Downtown-I will say it again we need to be ready and have vision of down town Oakland when sewers come into town. We need to develop a 5 year plan with a vision for what's best for Oakland. I will more information once we get this initiative going.
- 6. Patriots way bridge... As soon as our borough engineer and contractor provides us with a project plan and timeline, I will call for a public meeting with all residents of the Reserve so that our engineer can share this information and set exceptions for the residents. I will task them to have the meeting in the next 30 to 60 days. The borough will also provide monthly updates to the Reserve board and meet with them as required! Good communication is the key to success.
- 7. Reverse 911. This will only be used in the case of an emergency for official information. I have been working with Mr. Kunze to expand the service for phone and text messaging for residents that wish to subscribe to community events and general information.

And to my colleges on the Oakland Council I look forward to working with you, together we can we can move Oakland forward.

Once again thank you for entrusting me as the Mayor of Oakland and let's get to work.
