Mayor Linda H. Schwager announced that proper notice of this meeting was made as to time, date, place, and agenda.

### **SALUTE TO THE FLAG AND MOMENT OF SILENCE:**

#### **MAYOR'S REPORT:**

Mayor Schwager commented that the Borough of Oakland has supplemental funding onhand for the Patriot's Way Bridge Project just over \$1 million dollars. The Mayor has been working with our local legislators and Congressman to obtain additional funding for the superstructure replacement. The Mayor advised that federal funding was on a reimbursement basis only, and that the project could not start until funding has been secured. The Mayor announced that she negotiated with the NJDOT and has secured funding over multiple fiscal years. The Mayor thanked the Borough Administrator, Borough Clerk, and Kevin Boswell of Boswell Engineering for their hard work in filing the grant applications and for securing the funding. The Mayor thanked Senator Paul Sarlo as well. The Mayor announced that the Borough has received an allotment of \$3 million dollars from NJDOT, and still apply for more funding in the FY 2024 cycle. The project could start as soon as possible, while still being eligible for future NJDOT funding. The Mayor stated that the funding is pending the Governor's signature of the State budget. The Mayor thanked the NJDOT Commissioner Diane Gutierrez-Scaccetti for her hard work on this. The Mayor asked the Borough Council to introduce a bond ordinance at the July 19, 2023 Borough Council Meeting to be able to proceed with the project. The Mayor concluded that she looks forward to the ribbon cutting ceremony.

Dave Richardson of 320 Ramapo Valley Road, Oakland, N.J. 07436, expressed concerns with electric motorcycles and bicycles.

Alison Fleeson of 224 Hiawatha Boulevard, Oakland, N.J. 07436, asked the Governing Body to put up a PRIDE flag on Borough property in celebration of June 2023 Pride Month.

Thomas "Chopper" Russo of 392 Ramapo Valley Road, Oakland, N.J. 07436, congratulated all who helped with the Borough Carnival, including the Department of Public Works, Access for All, Oakland Police, Oakland Fire, and the Public Events Committee members. Mr. Russo read aloud revenue statistics for the Carnival.

Kerri Sirinides of 41 Sioux Avenue, Oakland, N.J. 07436, announced that Access for All Committee had over 80 participants during the special session at the Carnival. Ms. Sirinides read aloud a letter addressed to the community from the Access for All Committee.

Frank DiPentima of 6 Mountain Lakes Road, Oakland, N.J. 07436, expressed concerns with the Sewer Decommissioning Project, and encouraged the Borough Council to reach out to him regarding financial incentives. Mr. DiPentima asked for an apology for Ms. Cedar. Mr. DiPentima cited liquor license approvals.

Andrea Levy of 780 Ramapo Valley Road, Oakland, N.J. 07436, announced that the Great Oak Park Arts Pavilion is soon to be completed. The Recreation Commission and Arts Committee has announced an opening night on September 7, 2023. More information is forthcoming. There is a First Sunday Hike on July 2, 2023 at 9:00 a.m. at the Skyline Drive Lower Level Parking Lot. Ms. Levy thanked everyone who helped with the Arts Festival.

Michael Guadagnino of 34 Hopper Street, Oakland, N.J. 07436, thanked Boswell Engineering for their in-kind donations of engineering services for the Arts Pavilion.

Mayor Schwager swore-in the new Police Officers.

#### **ENGINEER'S REPORT:**

Kevin Boswell of Boswell Engineering reported on several urgent matters. Mr. Boswell explained the land use permitting process for the PFAS Treatment Systems Project. Mr. Boswell reported that the Borough is scheduled to be published in the New Jersey Register on August 7, 2023 in regards to an amendment to allow parts of the Borough to be on sewer. There will be a 30day comment period for the public, with an approval for October of 2023. Mr. Boswell was informed by NJDEP that the remaining land use permit would be issued by the end of next week for the PFAS Treatment Systems project. Mr. Boswell explained the federal funding process for Transportation projects. It was explained that if the Patriot's Way Bridge project was federally funding, the project would be subject to federal environmental requirements, which is something that the Borough should avoid. Mr. Boswell explained the funding availability through the NIDOT Local Aid Program, which does not have the allowable funding for the Patriot's Way Bridge project. Mr. Boswell commented that the Commissioner of the Department of Transportation inserted a \$3,000,000.00 line item in the NJDOT's FY 2024 budget, which is pending the Governor's signature. Mr. Boswell worked on a spending plan with the Commissioner, and the Borough will be eligible for future grant funding, even after starting the project now. Councilman Pignatelli asked if bonding precludes the Borough from receiving future funding. Mr. Kunze reported that this is the largest single grant that the Borough has received. Mr. Kunze advised that the bid will be out to the public for a longer period of time as opposed to other projects. Mr. Boswell explained that there is six (6) construction phases of the project, and is a 24-month project.

#### HOUSING ELEMENT AND FAIR SHARE PLAN PRESENTATION FROM BOROUGH PLANNER:

Planning Board Planner Steve Lydon presented the Housing Element and Fair Share Plan to the Governing Body and to the public. The Housing Element and Fair Share Plan was adopted by the Planning Board earlier in the year. The Governing Body's endorsement is sought. Mr. Lydon cited the statistics for affordable housing obligations for the Borough of Oakland. Mr. Lydon explained the Housing Rehabilitation Program, which gives the opportunity for residents to receive up to \$30,000 in home upgrades at no-cost. More information is on the Borough website. Mr. Lydon reviewed the proposed land use ordinances, which are required to be adopted for affordable housing purposes. The ordinances are up for introduction. Mr. Lydon provided background on the downtown affordable housing ordinances.

#### 23-211:

RESOLUTION EXPRESSING SUPPORT FOR S3906 WHICH WOULD PROVIDE THE BOROUGH OF OAKLAND WITH \$4,117,130.44 OF STATE FUNDS TO REPAY DEBT, ADVANCE CAPITAL PROJECTS, AND PROVIDE PROPERTY TAX RELIEF

**WHEREAS;** The New jersey Debt Defeasance and Prevention Fund was created for the purpose of repaying or decreasing taxpayer-funded debt and funding capital projects that would otherwise be paid for with new debt; and

**WHEREAS**; the New jersey Debt Defeasance and Prevention Fund is expected to have an unallocated balance of at least \$4.32 billion; and

WHEREAS; members of the New Jersey Senate Republican Caucus, including Senator Holly Schepisi, have introduced Senate Bill 3906 (S-3906), which would allocate \$4.32 billion from New Jersey Debt Defeasance and prevention Fund to towns and counties to repay local government debt, advance capital projects of their choosing, and provide property tax relief to residents; and

**WHEREAS**; funds would be allocated by S-3906 on a per capita basis, meaning every town and county would get a fair share of funding based on population; and

**WHEREAS**; S-3906 provides that \$3 billion would be allocated to New jersey municipalities on a per capita basis, and \$1.32 billion would be allocated to New Jersey counties on a per capita basis; and

**WHEREAS**; prior allocations from the New Jersey Debt Defeasance and Prevention fund have not been determined in a fair, equitable, or transparent matter; and

**WHEREAS**; the Borough of Oakland would receive an estimated allocation of \$4,117,130.44 million under S-3908 based on the 2020 Untied States Census data; and

WHEREAS; S-3906 requires funds to be disbursed within 30 days of the legislation's enactment; and

**WHEREAS**; S-3906 is not expected to have a fiscal impact on the proposed State Budget for Fiscal Year 2024; and

**WHEREAS**; local and county governments are contending with the soaring health care premiums, rising pension costs, and inflationary pressures that have impacted their budgets; and

**WHEREAS**; the significant allocations to towns and counties across New Jersey that have been proposed under S-3906 would help lower and stabilize property taxes for years to come.

**NOW, THEREFORE, BE IT RESOLVED;** that the Mayor and Borough Council of the Borough of Oakland, in the County of Bergen, and State of New Jersey, hereby support S-3906; and

**BE IT FURTHER RESOLVED;** that a copy of this resolution be forwarded to Governor Phil Murphy, to the District 39 State of New Jersey Legislators, and to the New Jersey State League of Municipalities.

#### **WORK SESSION:**

#### PERMITTING ALCOHOLIC BEVERAGES AT OAKLAND SENIOR CENTER EVENT:

Mr. Kunze reported that as part of the Oakland Senior Center, 'Senior Week', taking place in August of 2023, the Senior Center Director would like to host a wine and cheese event, however, there is a prohibition on alcohol at Borough properties. The Senior Center Director would like a one-time exception. The Borough Council consented to adopting a resolution at the July 19, 2023 Borough Council Meeting.

#### OPEN SPACE TRUST FUND REAUTHORIZATION:

Mr. Kunze reported that the Borough's local open space trust fund tax expires at the end of 2023, and is in need to for reauthorized. It was originally established in 2003. The ordinance needs to be adopted by the deadline for submission of a referendum to the Bergen County Clerk's office. The Borough Council needs to decide if the verbiage should change in the ordinance. It was recommended to mirror the State's ordinance, which allows for recreation and historic preservation purposes. There is a benefit to the Borough to have half a cent, as we will be eligible to continue as a Planning incentive community with the State Green Acres program. Councilman Talamini asked if the change would make it more flexible for spending the funds. The Borough Council consented to introducing the ordinance at the July 19, 2023 Borough Council Meeting.

Judith Ashburg of 91 Cicasaw Road, Oakland, N.J. 07436, encouraged the Borough Council to raise a Pride Flag on Borough properties. Ms. Ashburg cited personal stories related to the LGBTQ+ community.

Wanda Ashburg of 91 Cicasaw Road, Oakland, N.J. 07436, commented that she works for the Census Bureau, and that the demographics of the community have changed over the years. Ms. Ashburg cited controversies related to Pond's Church and the Pride Flag and LGBTO+ community. Ms. Ashburg commented on children and having an open dialogue with their parents.

Rachel Spina of 135 Franklin Avenue, Oakland, N.J. 07436, commented on the last time a request of this nature was brought forth to the Governing Body. Ms. Spina commented on her experiences at the Ramapo Indian Hills Board of Education Meetings. Ms. Spina cited statistics. Ms. Spina encouraged the Borough Council to raise a Pride Flag.

Liz Carletta of 161 Lakeshore Drive, Oakland, N.J. 07436, asked the Borough Council to raise a Pride Flag each year during June. Ms. Carletta commented that it is important for allies to understand the LGBTQ+ community.

Thomas "Chopper" Russo of 392 Ramapo Valley Road, Oakland, N.J. 07436, commented on PFAS and the road conditions. Mr. Russo asked about the pending downtown ordinances and when they will be adopted by the Borough Council.

Ann Cedar of 33 Winding Ridge, Oakland, N.J. 07436, thanked the Borough Council for obtaining the grant funding for the superstructure replacement of the Patriot's Way Bridge, and that their efforts are appreciated. Ms. Cedar asked what the timeline is until the project can start, and asked if there was an agreement in place with the County of Bergen regarding ownership and maintenance of the bridge. The Mayor added that the Borough would approach that subject once the superstructure replacement is complete.
