MAYOR'S REPORT:

Mayor Schwager announced the Oakland Carnival, which will run from June 21, 2023 through June 24, 2023 at the Oakland Recreation Complex. The Memorial Day Parade is scheduled for Sunday May 28, 2023 at 1:00 p.m. Lineup begins at 12:00 p.m. The Borough Shredding Day is scheduled for Saturday May 27, 2023 from 9 a.m. to 12 p.m. at the Borough Hall. RESOLUTION TO AUTHORIZE ESTIMATED PROPERTY TAX BILLING FOR

THIRD QUARTER OF 2023

WHEREAS, N.J.S.A 54:4-66.2 allows for a governing body of a municipality operating on the calendar fiscal year to use an estimated 3rd quarter tax bill if it is determined that the tax collector will be unable to complete the mailing or delivery of tax bills by June 14 provided that the estimated and reconciled tax bills shall be mailed by June 30 and September 30 respectively, and

WHEREAS, it is anticipated that the Borough Tax Collector will not be in receipt of a certified tax rate in enough time to be able to complete the mailing and delivery of real property tax bills by June 14, 2023 as is required by law; and

WHEREAS, the Tax Collector and the Chief Financial Officer have requested that the Council provide them with the latitude to submit estimated 3rd quarter real property tax bills in the event that they do not timely receive a certified tax rate, which would allow the Tax Collector to complete the mailing and delivery of real property tax bills by June 30, 2023; and

WHEREAS, the Tax Collector, in consultation with the Chief Financial Officer, has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3 and they have both signed a certification showing the tax levy for the previous year, and the range of permitted estimated tax levies; and

WHEREAS, in accordance with Chapter 72, P.L. 1994, the Tax Collector requests the Council approve the estimated tax levy of \$71,228,218.16 at a tax rate of 2.355; and

WHEREAS, the above levy and rate have been calculated on a worksheet that is attached hereto and made a part hereof by reference; and

WHEREAS, the above levy amount falls between the mandated estimated range required by N.J.S.A. 54:4-66.3(a)(1) and approval will enable the Borough to meet its financial obligations; maintain the tax collection rate; provide uniformity for tax payments; and save the unnecessary cost of interest expenses on borrowing.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Oakland, in the County of Bergen, and State of New Jersey, as follows:

- 1. The Tax Collector is hereby authorized and directed to prepare and timely issue estimated tax bills for the Borough of Oakland for the third quarter installment of 2023 taxes.
- 2. The entire estimated tax levy for 2023 is hereby set at \$71,228,218.16. The estimated tax rate for 2023 is hereby set at 2.355.
- 3. In accordance with applicable law, the third quarter installment of 2023 taxes (whether estimated or not) shall not be subject to interest until the later of August 10 or the twenty-fifth calendar day after the date the estimated bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
- 4. A copy of this resolution shall be forwarded to the Tax Collector and Chief Financial Officer for their records.
- 5. The Tax Collector and the Chief Financial Officer are hereby authorized to take all steps necessary to effectuate the purpose of this resolution.
- 6. This resolution shall take effect as herein provided.

WHEREAS, the County of Bergen shall determine whether the application is complete and in

conformance with the scope and intent of the County Trust Fund; and

WHEREAS, the applicant is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the above named project and ensure its completion on or about the project contract expiration date.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Oakland, in the County of Bergen, and State of New Jersey as follows:

- 1. That it is hereby authorized to submit the above completed project application to the County by the deadline of May 13, 2023, as established by the County of Bergen; and

RESOLUTION TO AUTHORIZE A NON-BINDING BALLOT QUESTION RELATED TO PERMISSIBILITY OF CANNABIS BUSINESSES IN THE BOROUGH OF OAKLAND

WHEREAS, in the 2020 General Election the Borough of Oakland participated in a statewide ballot question which asked, "Do you approve amending the Constitution to legalize a controlled form of marijuana called 'cannabis'?"; and

WHEREAS, said ballot question received sufficient support to pass and created a pathway to legalization of recreational cannabis in the State of New Jersey; and

WHEREAS, subsequently the New Jersey Legislature passed the CREAMM Act which created the statutory mechanism for legalization of recreational cannabis and authorized the Cannabis Regulatory Committee ("CRC") to adopt rules to effectuate said statutes; and

WHEREAS, the CRC created six (6) recreational classes of cannabis licenses and left authority to individual municipalities as to whether to permit or prohibit any or all of the six (6) classes of licenses within their borders; and

WHEREAS, the citizens of Oakland have not been given the opportunity to vote regarding their opinion on whether or not to allow cannabis businesses within the Borough of Oakland; and

WHEREAS, N.J.S.A. 19:37-1 permits municipalities to authorize by a resolution for a non-binding ballot question to "[a]scertain the sentiment of the legal voters of the municipality or county upon any question or policy pertaining to the government or internal affairs thereof"; and

WHEREAS, the governing body of the Borough of Oakland requests the County Clerk to place two (2) non-binding ballot questions pursuant to N.J.S.A. 19:37-1 to ascertain the sentiment of the legal voters of Oakland as to the question of whether they support cannabis businesses operating in the Borough of Oakland for both the cultivation and related processes and retail sale of same

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Borough Council of the Borough of Oakland, in the County of Bergen, and State of New Jersey, do hereby submit to the County Clerk of the County of Bergen to place a two (2) non-binding ballot questions for the November 2023 General Election pursuant to N.J.S.A. 19:37-1 stating as follows:

The Borough Clerk then read by title Ordinance No. 23-CODE-904 entitled, "AN ORDINANCE AMENDING CHAPTER 7; SECTION 16 OF THE CODE OF THE BOROUGH OF OAKLAND RELATED TO PERMIT PARKING"

On motion of Councilman Kulmala, seconded by Councilman Pignatelli, the following resolution be introduced, adopted and duly passed on roll call vote.

BE IT RESOLVED, that an Ordinance entitled, "AN ORDINANCE AMENDING CHAPTER 7; SECTION 16 OF THE CODE OF THE BOROUGH OF OAKLAND RELATED TO PERMIT PARKING, be introduced;

That said Ordinance be considered for final adoption at a Borough Council Meeting on Wednesday May 24, 2023 at the Borough of Oakland Municipal Court/Council Chambers, 10 Lawlor Drive, Oakland, N.J. at 7:00 p.m.

WORK SESSION:

GOVERNING BODY MEMBER SALARIES:

Councilman McCann proposed that the Governing Body members release their salaries due to save budgetary funds. Councilman Kulmala said that he is ok with giving up his salary. Councilman Pignatelli added that he does not consider it a salary – but rather a small stipend that recognizes a title of a part-time position. Councilman Talamini has no comment. Councilman Slasinski has no comment. Mayor Schwager added that she uses her salary to give back to the Borough, whether it

for tickets for events, the carnival, or other events. The Mayor polled the Borough Council. The Borough Council agreed not to pursue releasing the salaries.

STATE OF NEW JERSEY ASSEMBLY BILL NO. 5163 VIOLATION OF THE REAR SEAT BELT LAW:

Mayor Schwager proposed an endorsing resolution for Assembly Bill No. 5163, which allows Police officers to give a ticket if the rear passenger is not wearing a seat belt. Councilman Talamini added that this is a project that his daughter is working on with Indian Hills High School. The Borough Council agreed to have an endorsing resolution on the May 24, 2023 Borough Council Meeting.

AMEND PARKING ORDINANCE FOR PARKING OF TRUCKS, VEHICLES, AND TRAILERS:

Borough Administrator Richard Kunze stated that this is result of a conversation with the Police Department. The current code needs to be tightened to reflect specific and/or all Borough roadways. The current code does not list any specific roads and cannot be enforced. Councilman Kulmala thanked Mr. Kunze for his work on this ordinance. Mr. Kunze clarified that the ordinance would state anything over 3 tons, and/or trailers, RV's, etc. The Borough Council consented to introducing the ordinance at the May 24, 2023 Borough Council Meeting.

CAPITAL ORDINANCE:

Chief Financial Officer David Young presented the Borough's capital plan for 2023. Mr. Kunze highlighted specific projects and needs. Councilman Kulmala asked if the card access system is for the Recreation Complex. Mr. Kunze clarified that the project will finish the DPW Building and the Recreation Complex. Councilman Kulmala asked if the Borough got a grant for the replacement of the Senior Bus. Mr. Kunze responded that the Borough tried to pursue NJDEP funding, but it was limited and only for electric busses. Councilman Pignatelli asked if the bus will be ADA accessible. The Borough Council consented to introducing the capital ordinance at the May 24, 2023 Borough Council Meeting.

WELL #9 ELECTRICAL RENOVATIONS:

Mr. Kunze brought forth a proposal for engineering services to replace the electrical infrastructure at Well #9. The project is needed due to the expected PFAS Compound Treatment System project. The Borough Council consented to adopt the proposal at the May 24, 2023 Borough Council Meeting.

SHORT TERM RENTALS / BOARDING HOUSE ORDINANCES:

Mayor Schwager brought forth the proposed ordinances for consideration due to receiving several complaints from residents within the past few months. Councilman Kulmala asked that the Borough consider Mr. Pedalino's questions and concerns before introducing the ordinances as is.

NEW BUSINESS:

No new business reported.

OLD BUSINESS:

Mayor Schwager addressed speeding issues on Hiawatha Boulevard. Mayor Schwager added that she receives complaints about the conditions of the roads. Mayor Schwager expressed concerns about the conditions of Lakeside Boulevard. Mayor Schwager addressed concerns with the weight restrictions of the Patriot's Way Bridge. Mayor Schwager clarified that the Police Department encouraged two emergency exits. Mayor Schwager added that the Borough is submitting one more grant application, and if the funding does not come through, that the Borough will pursue the replacement via bonding. Councilman Saliani asked if the short-term repairs are still being considered. Mr. Yakimik responded that there is a plan in place, and that quotes are being sought out from bridge contractors to repair specific localized sections of the deck. Councilman McCann asked why the Borough has to conduct another inspection, and questioned if there are uncovered problems that we do not know about. Mr. Yakimik responded that hands-on inspections need to be performed to get a better understanding of what is happening below the deck. Mr. Yakimik added that the Lenape Lane Bridge is in good condition and can withstand up to 35 tons of weight, Mr. Yakimik addressed the Lakeside Boulevard conditions, and advised that the road will be payed over the summer. Councilman Kulmala asked for a timeline of the Patriot's Way Bridge project moving forward. Councilman McCann asked if the Borough could go out to bid now while we wait for the NJDOT grant decision. Mr. Yakimik advised that the Borough would not want to go out to bid twice because contractors will be spending a lot of time and money on preparing bid specifications for this project. Mr. Kunze suggested to wait to hear back from the NJDOT prior to going out to bid, but suggested working out the financing end now to save potential time.

COUNCIL COMMITTEE AND LIAISON REPORTS:

Councilman Talamini: Councilman Talamini announced the Memorial Day Parade for Sunday May 28, 2023 at 1:00 p.m. along Ramapo Valley Road. The Public Events Committee is seeking volunteers. The Oakland Carnival is June 21, 2023 through June 24, 2023 at the Oakland Recreation Complex. Councilman Talamini thanked the Access for All Committee for their participation.

Councilman Kulmala: Councilman Kulmala reminded residents that there are vacancies on the Zoning Board of Adjustment. The Sustainable Oakland Green Team's FLOW Green Film Festival is scheduled for Saturday June 3, 2023 in Veterans Park. Councilman Kulmala announced that the Sustainable Oakland Green Team hosted a successful outdoor hike last weekend.

Councilman Pignatelli: Councilman Pignatelli thanked all of the teachers as part of Teacher Appreciation Week. Councilman Pignatelli cited statistics from the Oakland First Aid Squad.

Councilman McCann: Councilman McCann thanked the Police Officers during National Police Week. The Public Safety Committee is going to work with the Administration Committee to review

the safety aspects of the cannabis businesses in the Borough. Mayor Schwager added that the Police did participate in the Cannabis Ad-Hoc Committee.

Councilman Slasinski: Councilman Slasinski reported that the Communications Commission is seeking volunteers. Councilman Slasinski cited programs from the Oakland Public Library.

Councilman Saliani: Councilman Saliani reminded residents to report street light outages and potholes to the Department of Public Works. The Shade Tree Commission is seeking additional members. Councilman Saliani announced soccer, football, and cheerleading signups. Councilman Saliani added that he is the new liaison to the Flood Commission.

OPEN PUBLIC COMMENT:

Councilman Kulmala set forth the motion, seconded by Councilman Pignatelli, to open for public comment.

ALL IN FAVOR.

Michael Guadagnino of 34 Hopper Street, Oakland, N.J. 07436, commented on Councilman McCann.

Matthew Goodrich of 72 Hiawatha Boulevard, Oakland, N.J. 07436, cited statistics from the 2020 General Election.

Thomas "Chopper" Russo of 393 Ramapo Valley Road, Oakland, N.J. 07436, congratulated Manito Elementary School for being ranked one of the best schools in the area. Mr. Russo announced that the Mother's Club will be handling the legalized games of chance at the Carnival.

Mame Schwarzfischer of 187 West Oakland Avenue, Oakland, N.J. 07436, asked what the process is moving forward for Kusala Care LLC's cannabis cultivation license.

Jennifer Hansen of 12 Fieldstone Court, Oakland, N.J. 07436, expressed concerns with the traffic in the Ramapo River Reserve, and asked if the Borough could install a speeding monitor on Ramapo River Trace.

William Sisti of 12 Eagle Crest Place, Oakland, N.J. 07436, commented that he is pleased with all of the new infrastructure being installed and suggested that residents are not driving slow enough down the roads in question. Mr. Sisti asked what the cost would be to the average taxpayer for the full superstructure replacement of the Patriot's Way Bridge.

Kevin Heffernan of 40 Grove Street, Oakland, N.J. 07436, commented on the discussion of the Governing Body member salaries.

Michele Younes of 2 Rock Ledge, Oakland, N.J. 07436, asked if the residents of the Crystal Lake area received hand delivered letters on the weight restrictions. Ms. Younes asked for direct communications by the Borough on the Patriot's Way Bridge.

Councilman Pignatelli set forth the motion, seconded by Councilman Kulmala, to close public comment.

Councilman McCann addressed resident Michael Guadagnino.
