MEETING CALLED TO ORDER: By Mayor Schwager at 7:33 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini. Absent: None. Also Present: Kathlyn Gurney, Deputy Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney and John Yakimik, Borough Engineer.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MAYOR'S REPORT:

Mayor Schwager acknowledged the upcoming holidays and wished everyone a Happy Easter and Passover. She thanked Chopper Russo, Councilman Talamini and members of Public Events for their participation in a successful Easter Egg Hunt held last Saturday.

Mayor Schwager announced upcoming events in April:

April 4, Seniors in Place Luncheon at 12pm. April 5, AARP Driver Safety Class at 11am to 4pm. April 5th – 29th, Annual Art Show Exhibit displayed at the Library. Reception held on Saturday, April 14th 1pm to 4pm. April 6th – Rutgers Safety Course offered free for residents, \$40 for nonresidents. April 24th –Celebrations for Josefine Berkowicz 103 birthday and Angelo Chiusano being selected as the Goodwill Ambassador.

Mayor Schwager reminded the public that there is a drop-off box at the Police station for the disposal of prescription drugs and that eligible NJ residents will receive new Medicare cards in June 2018. She reported that Spring Clean Up will begin the first week of April and instructed residents to begin collecting limbs and branches downed by the storm and the town will haul away piles no bigger than 4-feet in length and 4-inches in diameter.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Knapp, this portion of the meeting be opened for public discussion.

A resident from 94 Andrew Avenue informed Council that he has contacted the town about a hazardous situation on his property where he has lost 10-feet of his property due to erosion. He is unable to erect a fence in that location and fears for his children's safety. He requested support from the town. It was determined that Mr. Yakimik from Boswell Engineering will meet with the resident after the meeting to discuss options and set up a meeting with Mr. Kunze and Anthony Marcucilli, Superintendent.

Chopper Russo informed Council of Public Events schedule for the next few months: Memorial Day Parade, Sunday, May 27th Carnival, June 13th – 16th and Fireworks Friday, June 15th Ladies Auxiliary Break, Sunday, April 8th Town Clean Up, Saturday, April 21st Father's Club, May 4th, 5th and 29th Town Wide Garage Sale, May 5th

Mr. Russo expressed the need for volunteers and that anyone interested can contact him.

APPROVAL OF MINUTES: MARCH 14, 2018 EXECUTIVE SESSION On motion of Councilman Biale, seconded by Councilman Pignatelli, the minutes from the Mayor and Council Executive Session of March 14, 2018 be approved.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

PRESENTATION ON BENEFITS OF CHICKENS AND AMENDING THE ORDINANCE:

Mayor Schwager explained that she and Ms. Abigail Andro met at Borough Hall to discuss her interest in having the current zoning ordinance changed requiring that residents have one acre of property to house chickens. She invited Ms. Andro to attend the next Council meeting and give a presentation on the benefits of changing the ordinance.

Ms. Andro informed Mayor and Council that she is third grader, a member of student council and a girl scout interested in having the current ordinance changed to reduce the lot size requirement to house chickens from one acre to a half acre. She began her research on chickens when her sister became ill with lyme disease and her parents were looking for non-toxic ways to rid ticks from their yard. They decided to acquire some chickens, because they eat a wide variety of insects along with their regular diet. Currently, the Andros have 14 chickens and no roosters. Her mother, Dana Andro, found out about the lot requirements when visiting the Building Department for permits to improve their chicken coups. Mayor Schwager read the current ordinance.

The benefits of owning chickens has taught Ms. Andro a sense of responsibility since she feeds them, cleans their pen and collect their eggs. There are also sustainable benefits which include fertilization for yard plants.

During her research, she collected ordinances from other towns that allow chickens. A discussion ensued concerning towns that have adjusted their ordinance to allow chickens, the specific requirements, standards and setbacks concerning chicken coups. Mayor Schwager explained that the zoning officer will be notified that no further action will be taken until Council has had an opportunity to review their ordinance. Mr. Chewcaskie would review some of the ordinances from the surrounding towns and have something drafted by the next meeting.

Mayor Schwager invited Ms. Andro to become a member of the Green Team.

PRESENTATION ON OPPOSING DEPARTMENT OF AGRICULTURE NEW REGULATIONS CONCERNING BEEKEEPING:

Residents of 61 Yawpo Avenue and Mr. John Matarese of Franklin Lakes expressed their concerns with new regulations, drafted for adoption by the Department of Agriculture, on Beekeeping. Mr. Matarese explained that the draft adopted by the assembled Delegates at the 2016 and 2017 State Agriculture Convention, is inconsistent with the direction given by the State Board of Agriculture.

The draft contains a misunderstanding of beekeeping practices, bee behavior and bee biology and reflects a poor understanding of municipal land use planning and regulations in New Jersey. Mr. Matarese went into detail on some of the new regulations which he referred to as "drastic and unnecessary" concerning barriers imposed upon hobbyist and small commercial beekeepers.

Ms. Carol Peterson, 95 Seminole Avenue, informed Council that she is a beekeeper and has a hive on her property. She explained that honey bees are not aggressive bees and that they are responsible for the pollination of 70 to 80 percent of the food we eat. The new law could be a detriment of the future of beekeeping and honey bees.

A discussion ensued concerning their recommendation for support. Incentive programs involving bees were discussed by Mr. Matarese and he requested that the Council form a committee and adopt a resolution opposing the new draft regulations imposed by the Department of Agriculture. Councilman Biale and Councilman Pignatelli were chosen.

BUDGET:

Appropriations:

Mr. Kunze discussed that the Total Current Fund Appropriations are proposed at \$19,880.93, a decrease of \$1,845,406.65. Other significant appropriation changes were Solid Waste Collection increasing by \$135,000 and Pension obligations increasing by \$104,883. The health benefit budget is decreasing by \$50,000.

Overall funding for salaries and wages in the current fund are projected to increase by 2.7% and money is included to hire two additional employees mid-year and to make a part time position into a full time position. This budget is \$1.1million under the appropriation cap limit.

Revenues:

Non Tax

Anticipated revenue from the Court would increase by \$16,500 and we propose to double the amount of anticipated from investment income to \$40,000. Recycling revenue is up by \$52,000 as a result of the change to dual stream collection.

Surplus

Surplus utilization is compliant with our surplus policy and would increase from \$1,198,000 to \$1,900,000. The most significant element is that surplus used to support general operations is up by \$352,000.

Tax Impact

As a result of this increased surplus usage, there will be no tax increase this year. In fact, there will by a tax decrease of \$85. It should be noted that the Library Tax Levy is separated from the rest of the municipal levy and is determined by a state formula. The levy is increasing by \$25,789 (32%).

This budget is below the tax levy cap limit by \$295,000.

BOSWELL PROPOSAL-2018 ROAD PROGRAM:

Mr. Kunze advised that Boswell Engineering submitted a proposal for engineering services for the 2018 Road Program. A resolution will be listed on the next agenda.

RESOLUTION TO SUPPORT CDBG PROGRAM:

Mr. Kunze explained that the President has proposed eliminating the CDBG funding program. This program has helped municipalities in Bergen County to provide funding for various improvements. The Bergen County Board of Chosen Freeholders has asked the municipalities in Bergen County to pass a resolution in support of the CDBG program because of the impact these grants have had on improving the quality of life in Bergen County.

COUNCIL REPORTS:

Councilman Talamini reported that an email was sent to the state by the Superintendent with regard to changing the date of school board elections and he is still waiting a response. He reminded the public get out and vote April 17th for the school board election. He thanked the volunteers and Chopper Russo with Public Events for a great job organizing the Annual Easter Egg Hunt. He thanked Recreation for the completion of a successful basketball season.

Councilman Kulmala updated the public that funding has been authorized and meetings will begin with regard to the Patriots Way Bridge. He announced that the Library will be closed April 3rd, 4th and 5th due to the renovation. He shared pictures of the Library improvements. He reminded the public if people are interested in coaching, the Rutgers Class for Coaching is being offered at the Senior Center and stressed the need for volunteers.

Councilman Biale reported that the Senior Art Exhibit will be held April 5th through the 29th with a reception to be held April 14th from 1pm to 4pm. Storm related pickup should be wrapping up and spring cleanup begins April 2nd. Remember that collected brush and branches cannot exceed 4-feet in height and 4-inches in diameter. The LED street light plan is almost complete. There will be new fixtures added to Manito, Pawnee and Minnehaha. A meeting has be scheduled with Margaret Hickey to discuss projects involving the Stream House and Van Allen House. The Pilgrim Pipeline group has hired more counsel to help lobby their cause and he will have more to report at the next meeting. At Ramapo College there will be a Food and Water Action educational forum March 29th.

Councilman Pignatelli reported that they addressed two violators at the last Board of Health meeting and next meeting will be held April 17th. There will be an Environmental meeting April 10th. Cleanup at Great Oak Park will be held Saturday, April 21st at 9am.

Councilman Knapp reported that he will be giving a monthly updates on each Public Safety agency. For the month of February Police had 155 calls of service, 448 motor vehicle stops, 6 statutory checks and 54 school checks. The First Aid Squad had 65 calls. The Fire Department had 29 calls of service and 3 drills. There was a storm debrief meeting to discuss the effects of the storm and how it was handled by Orange and Electric. NW Bergen Mayors Association will hold a conference with all local utility companies. No update on Municipal Alliance and the cleanup event at Great Oak Park will be held April 21st.
