ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini. Absent: None. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney.

STUDENT ROLL CALL: Present: Mayor Trey Esak; Councilmembers Jasmine Azar, Benjamin Good, Jack Cooper, Krishan Patel, Giacomo Scalici, Vidath Diyabalanage.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MAYOR'S REPORT:

There will be a Styrofoam Recycling collection on Sunday April 28th. The dates for Hazardous Waste collection will be held at Bergen Community College on June 23rd and October 20th and at Campgaw in Mahwah on May 11th, July 20th and September 14th. The Garden Club will hold a plant sale on May 4th. Regarding the bathrooms at the Rec Field, the ladies' bathroom at the Danny D'Elia building is ready to open. There are some minor issues with the mens' bathroom that need to be corrected before that can open. There will be a ceremony on April 25th at 11 am to dedicate the Oakland Post Office to former Postmaster Frank Leone. Mayor Schwager thanked Congressman Gottheimer for supporting the bill to dedicate the Post Office.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Pignatelli, seconded by Councilman Knapp, this portion of the meeting be opened for public discussion.

Don Sena, 47 Thackeray Road, commented that only 8 towns in Bergen County have a separate school election in April. He advised that the budget vote is not necessary as long as the budget is within the State guidelines. In 2019, the Board of Education budgeted \$25,000 for the election. In 2018, the Board of Education spent over \$21,000 for the school election. There were only 477 votes in the 2019 election and only 354 of those voted for the candidate. This Council has the ability to change the election to November. He hopes the Council will show fiscal responsibility and move the election.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

WORK SESSION:

PROPOSED POWER PLANT:

The Council received literature regarding a proposed power plant to be built in New Jersey. They are asked to do a resolution opposing the power plant. Councilman Pignatelli commented that this proposal is to construct a power plant in NJ but the power is going to be used in NY. He is in favor of a resolution to oppose the power plant. Councilman Levy concurred. Councilman Kulmala commented that there is no inherent benefit to NJ so he would support a resolution to oppose the pwer plant. Councilman Biale recused himself from the discussion. Councilman Talamini does not see the necessity for Oakland to weigh in on the issue but he is ok if the Council wants to send a resolution. Councilman Pignatelli responded that a resolution sends a message to the elected officials in Trenton. Mayor Schwager advised that the Bergen County League of Municipalities and the Northwest Bergen Mayors' group passed resolutions opposing the power plant. A resolution will be listed on the next agenda.

SCHOOL BOARD ELECTION:

Mr. Kunze advised that the memo from the Borough Attorney as well as the statute has been provided in the packets. If the election is moved to November, people will vote for the candidates but would not vote on the budget unless it is over the 2% cap. Mayor Schwager commented that Ridgewood and Clifton moved back from November to April elections. She wanted to know why they chose to move back. Mr. Kunze responded that Ridgewood moved back to April based on input from the public who wanted to vote on the budget. The school board sued them and the Village won the case. The change in Clifton was initiated by the school board. There was a lawsuit involved there as well. They were concerned with the candidates' costs in November as well as the position on the ballot.

Mayor Schwager thinks the State did a disservice by giving choices. They should have made everyone move to November. She advised that the last time the budget was voted down was about 10 years ago. She advised that Oakland is the only town in the FLOW area that has a local school election in April. The regional school board holds their election in November.

Mr. Chewcaskie advised that the Council can adopt a resolution moving the election to November and then the Board of Education could adopt a resolution to move it to April. There are issues with moving to November that affect the board members' terms. There are three ways the school election can be moved to November: petition by the voters, the Governing Body can adopt a resolution or the School Board can adopt a resolution. Mr. Chewcaskie commented that the statute is not extremely workable. There are tensions on this issue between the public, Governing Body and the School Board. Mayor Schwager asked if this could be a ballot question for the voters. Mr. Chewcaskie does not think so but he is not sure.

Mayor Schwager commented that when Clifton's election was in November, they said the candidates were on the bottom of the ballot and people didn't vote. However, they said there was not a big turnout in April either. Councilman Levy asked if anyone has spoken to the School Board. Mayor Schwager responded that she has and the School Board wants to keep the election in April. Councilman Levy thinks the School Board should come explain their reasoning to the Mayor and Council. Councilman Pignatelli commented that the public deserves the right to have the full explanation. He believes in the democratic process. The school election was separated for a reason. He would like the Board of Education to come explain the pros and cons so that the Mayor and Council can make a decision.

Councilman Biale commented that there are only 8 municipalities in Bergen County that have school election in April. It is not fiscally responsible to spend \$45 per person to come vote in April. Councilman Levy agrees but he would like to hear from the Board of Education. Councilman Kulmala thinks it is a major overreach to change the election without having all the details. It is important for citizens to have a voice and he agrees that someone from the Board of Education should come to educate the Governing Body and the public. Mayor Schwager is asking someone from the Board of Education to come to a Council meeting and then the public can hear the reasoning for having the election in April. Mayor Schwager advised that the Oakland schools are wonderful and she appreciates the time given by the School Board members. She is asking them to justify having the school election in April when only 4% of the public votes.

Councilman Pignatelli wished that the Board of Education would do more outreach to the public to get a bigger voter turnout. Councilman Biale advised that 66% of the taxes residents pay go to the schools. Councilman Talamini agreed that everyone complains about their taxes and most of it goes to the schools. Councilman Talamini asked if Mr. Sena has gone to the Board of

Education meeting to speak to them. Councilman Talamini does not think the Mayor and Council should be moving the election. He would rather have the election separate and also retain the right to vote on the budget. Councilman Pignatelli commented that if the Board of Education does not come to a Council meeting, it leaves the decision to the Council. Councilman Kulmala asked Mr. Sena if he went to the Board of Education to bring his concerns. Mr. Sena responded he did not because the Mayor got stone-walled.

BANNER SPONSORSHIP PROGRAM:

Mr. Kunze advised that at the last meeting, there was discussion on the new banner sponsorship program. Some renderings of the banners have been done in several color schemes. We are looking for final direction to proceed. Mayor Schwager advised that these banners will have local businesses or organizations on them. The money collected from these banners will be used towards holiday decorations. The big discussion has been the color scheme.

The student officers were asked to give their opinions. Jack Cooper advised that he likes the blue with yellow because it matches Indian Hills' colors. Vidath Diyabalanage also liked the blue with yellow border. Giacomo Scalici thought the blue with gold looked nicer. Jasmine Azar agreed with the blue and gold border. Benjamin Good liked the blue background with the green border because it incorporates all three Borough colors. Krishan Patel likes the blue background with the yellow border because aesthetically it looks the best and makes everything show better.

Councilman Pignatelli agreed with the blue background and yellow border. Councilmembers Levy, Knapp and Biale agreed. Councilman Kulmala liked Benjamin's assessment so he chooses the blue background with green border. Councilman Talamini thinks the blue with gold looks better.

OLD BUSINESS:

Councilman Knapp asked if there was an update on the paving on Route 287 because 287 north at exit 58 is still bad. Borough Engineer John Yakimik responded that the paving is not finished. Mr. Yakimik will reach out the DOT and bring it to their attention.

COUNCIL REPORTS:

Councilman Talamini (Councilman Patel): The school budget passed. He thanked the voters for their support. The Public Events Committee held another great event with the Easter Egg Hunt. There was a train and refreshments and pictures with the Easter Bunny. The Public Events Committee is always looking for members.

Councilman Kulmala (Councilman Good): Football, Cheerleading and Soccer registrations are now taking place. Visit the Recreation website for more information. The next meeting of the Recreation Commission will be held April 29th at 8:00 pm. The bid packet for the roller rink project is still on target to be ready by the first week of May. There are three vacancies on the Communications Commission. The OCC oversees the newsletter committee, bulletin board committee, website and social media committee, and the tv committee. The OCC works with the Borough to help disseminate information to the public. The OCC would like to thank the Mayor and Council for supporting the request to add a junior member. By adding a junior member, the OCC hopes to get a unique perspective. The OCC hopes to work with the schools to encourage students to volunteer. The next OCC meetin will be held on May 6th.

Councilman Biale (Councilwoman Azar): The Senior Center will hold bingo on May 16th at 1 pm and movie day will be held May 22nd at 1 pm. The Senior Center is now maintaining an email list for monthly updates. There will be a weekly walking club every Tuesday in May and June.

There will be a special guest from the Borough each week. There will be a luncheon presentation from an elder care attorney on May 30th at 12 pm. The Senior Center will hold a Kentucky Derby Day party on Thursday May 2nd. The Borough awarded a \$225,000 contract for renovations to the Van Allen House. The work is scheduled to begin May 7th and will last six months. There are additional interior renovations that are needed which will cost approximately \$250,000. The Borough is seeking permission from the State to dismantle the Stream House. A decision should be forthcoming. The Van Allen House renovations will be funded mostly by grants. However, there is no funding in place for dismantling the Stream House. Councilman Biale, Mayor Schwager and Mr. Kunze met with the Historical Society to discuss the future of the building. The Oakland-Franklin Lakes Rotary club has expressed an interest in helping with fundraising.

Councilman Pignatelli (Councilman Diyabalanage): The Green Team met on April 23rd. They are holding a bulk Styrofoam collection at Borough Hall on April 28th. On May 4th and 5th, they will be planting tree seedlings that were gotten from the Roots for Rivers grant. The trees will be planted along the banks of the stream that runs through Great Oak Park. Volunteers are needed. There will be a program on butterflies on June 11th at the Library. Don Torrino will speak about using native plants in a butterfly sanctuary. The Green Team will staff a booth at the carnival along with the Environmental Commission. The Green Team will be collecting toys at the car show which will be distributed to needy children. The Bergen County Utilities Authority will hold their hazardous waste collection events on May 11th, July 20th and September 14th at Campgaw Reservation in Mahwah. The items collected include gasoline, paint and pesticides. There will be separate dates for tires, electronics and paper shredding. They will be June 8th and October 6th.

Councilman Levy (Councilman Cooper): The grant committee is pleased to announce that Columbia Bank will be donating \$25,000 to the Roller Hockey Rink Project.

Councilman Knapp (Councilman Scalici): Fire Department had 42 calls in March for 1230 hours. Year-to-date is 90 calls for 1814 hours. The First Aid Squad had 86 calls in March and participated in an active shooter drill in Allendale. The Police had 58 motor vehicle stops, 71 school checks, 39 alarm calls and 18 radar details in March. Year-to-date, the Police Department has responded to 4,950 calls. May is Bicycle Safety Month. The Police Department advised that people should wear properly fitting helmets and bright clothing and should choose their routes carefully. The Oakland Police Department has been giving out good deed certificates to young residents who are doing good deeds or being a role model. The great lawn in Great Oak Park is progressing. James Construction has completed clearing and the DPW has seeded.
