SALUTE TO THE FLAG AND MOMENT OF SILENCE

Mayor Linda H. Schwager announced that proper notice of this meeting was made as to time, date, place, and agenda.

MAYORS REPORT:

Mayor Schwager announced a Veterans Day Ceremony on Friday November 11, 2022 at 11:00 a.m. in Veterans Park. Should there be inclement weather, the ceremony will be moved indoors at the American Legion Post 369. The Public Events Committee is hosting the Christmas Tree and Menorah Lighting Ceremony on December 4, 2022 in Veterans Park. The Public Events Committee will be decorating the Bergen County Winter Wonderland Tree in Van Saun Park. Mayor Schwager congratulated John McCann and Kevin Slasinski on their election win and thanked them for a nonnegative campaign. It was announced that Optimum Channel 77 will be upgraded to high definition on November 15, 2022. Call customer service should you need to upgrade your SD box.

OPEN PUBLIC COMMENT:

Councilman Pignatelli set forth the motion, seconded by Councilman Kulmala, to open for public comment.

ALL IN FAVOR.

Kevin Heffernan of 40 Grove Street, Oakland, N.J. 07436, provided statistics regarding Historic Preservation Commissions/Committees in the State of New Jersey. Mr. Heffernan provided a handout regarding the pros and cons of a Commission versus a Committee. Mr. Heffernan encouraged the Governing Body to establish a Historic Preservation Commission.

Councilman Pignatelli set forth the motion, seconded by Councilman Saliani, to close public comment.

ALL IN FAVOR.

PRESENTATION AND DISCUSSION ON CANNABIS CULTIVATION LICENSE:

Mayor Schwager introduced the Borough's Cannabis Counsel Mr. Ron Mondello. Mr. Mondello introduced himself and explained the process of Cannabis licensing. The applicant is seeking a resolution of support from the Governing Body, which is required to obtain a license from the State Cannabis Regulatory Commission.

George Lutfey and Justin Lee introduced themselves as the co-owners of Kusala Care LLC. Mr. Lee explained their company's cultivation process called microbial loop. Mr. Lutfey explained that the company is a microbusiness, which means that they operate in less than 2,500 sq. ft. and 50% of the company's owners must live in the Borough of Oakland or a surrounding town. Kusala Care LLC is also a social equity business, in which all employees have previous entanglements with cannabis law. Mr. Lutfey explained that their company wants to collaborate with other businesses. Mr. Lutfey explained that their company wants to destignatize and educate the community via social media, seminars, and classes. Mr. Lee explained their intention to host community cleanups and work with the Sustainable Oakland Green Team on projects and educational programs. Mr. Lee presented their security plan, which involves cameras, adequate lighting, and locks. Mayor Schwager asked if security guards are on site. Mr. Lee advised that security guards would be on site during hours of operation. Mr. Lee advised that they estimate producing 600 pounds per year. Councilman Pignatelli asked for the owners past business experience. Mr. Lee and Mr. Lutfey explained their prior business and professional experience. Mr. Lutfey advised that Kusala Care LLC's projected revenue is \$1.5 million gross, with the Borough eligible for 2% of the gross revenue. Mr. Lee explained that their company put in a waiver request for trucking in their own water. It was explained that their proposed water usage is much less than the average homeowner due to their regenerative water recycling process. Councilman Pignatelli asked who enforces the premises. Mr. Mondello stated that the enforcement is the Borough's responsibility. Mr. Mondello advised that if the company changed to a larger facility, that they would have to come forth to the Governing Body for approval given that demand far exceeds supply. Mr. Mondello advised that if there is an issue with odor on the premise, that Kusala Care LLC. may have to increase their equipment to remediate any potential issues. Councilman McCann asked what happens if the company cannot resolve any potential issues such as odor or alike. Mr. Mondello advised that the Borough has the right to revoke the local license. Councilman Pignatelli suggested that the Borough designates a local enforcement issue. Mr. Kunze advised that it depends on the nature of the complaint. Councilman Kulmala asked if the license could have conditions. Mayor Schwager confirmed that Kusala Care LLC holds a conditional license until the Borough provides a resolution of support. Mr. Mondello advised that an entity would have to renew their license each year. Mr. Lee advised that they will file an amendment to remove the verbiage regarding delivery in their application, as it is not their intention to provide delivery services. Mr. Mondello advised that he is not concerned about the owners' inexperience in running a cultivation business. Mr. Mondello further advised that should Kusala Care LLC want to expand to tier #1, they would have to prove to the Cannabis Regulatory Commission that their demand far exceeds supply, although Kusala Care LLC must come forth to the Governing Body as well. Mayor Schwager read Resolution #22-290 in full as follows:

22-290: RESOLUTION IN SUPPORT OF APPLICATION FOR CLASS 1 CANNABIS CULTIVATION LICENSE IN THE BOROUGH OF OAKLAND

WHEREAS, pursuant to P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of marijuana by adults 21 years of age or older, the Borough of Oakland ("Borough") adopted ordinance 22-Code-872, which allows for a limited number of cannabis

businesses to be located in specific sections of the Borough; and

WHEREAS, the Act established the Cannabis Regulatory Commission ("Commission") to oversee and regulate the cannabis industry in the State of New Jersey and the Commission promulgated Personal Use Cannabis Rules, N.J.A.C. 17:30-1.1 et. seq. on August 19, 2021; and

WHEREAS, in order for a cannabis business to operate, both State and Local approval are required; and

WHEREAS, N.J.A.C. 17:30-5.1 requires that a municipalities governing body express its support for a cannabis license applicant through a resolution of the governing body; and

WHEREAS, pursuant to N.J.A.C. 17:30-5.1(g), the support resolution should indicate that the proposed cannabis business location is appropriately located or otherwise suitable for activities related to the operations of the proposed cannabis business; and

WHEREAS, the Borough's Cannabis License Application Evaluation Committee has received and reviewed the application submitted by Kusala Care, LLC. and has recommended that the Borough Council approve its application and adopt a resolution in support of their application for a State License;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Oakland, County of Bergen, State of New Jersey as follows:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length;
- 2. The Borough recognizes that Kusala Care, LLC. will be operating a Class I Cannabis Cultivation business involved in the cultivation of cannabis products and that the business location will be 27 Muller Road, Oakland, N.J. 07436 if approved by the State of New Jersey Cannabis Regulatory Commission;
- 3. Approving Kusala Care, LLC. application for a Class I Cannabis Business License would not exceed the limit established by the Borough for Class I Cannabis Cultivation licenses located in the Borough;
- 4. Kusala Care, LLC's proposed Class I Cannabis Cultivation Business use and location satisfy the Borough's Zoning and Cannabis Ordinances;
- 5. Kusala Care, LLC. shall continuously comply with the Borough's ordinances governing cannabis operations and any future applicable changes that may be made thereto;
- 6. If Kusala Care, LLC. is not in compliance at any time with the Borough's Cannabis Ordinances and any future applicable changes thereto, the Borough reserves the right to withdraw its support for their operations and suspend or revoke their local license;
- 7. The Borough approves Kusala Care, LLC's application submitted to the Borough and endorses Kusala Care, LLC's application to be submitted to the Commission for a Class I Cannabis Cultivation Business License at the location in the Borough as set forth above, which location is appropriate and suitable for a Class I Cannabis Cultivation License;
- 8. The Mayor, Borough Administrator, Borough Clerk, Borough Attorney, Chief Financial Officer, and any other necessary official, officer or employee of the Borough be and they are hereby authorized to execute any and all documents and to make any and all actions necessary to complete and realize the intent and purpose of this Resolution;
- 9. This Resolution shall take effect immediately.

AUTHORIZE STRATEGIC PLAN SUBMITTAL TO BERGEN COUNTY DEPARTMENT OF HEALTH SERVICES FOR FY24 MUNICIPAL ALLIANCE PROGRAM

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey; and

WHEREAS, the Borough of Oakland Property Maintenance Officer has advised that the property located at 81 Lakeview Terrace and identified as Block 2518 Lot 16 on the Tax Assessment Map of the Borough of Oakland was in violation of the Borough's property maintenance code; and

WHEREAS, the property owner of the premises was notified by the Borough on several occasions respecting the condition of the property and the need to remedy same consistent with the requirements of the Borough's property maintenance code 10-3.1 et seq.; and

WHEREAS, the Borough was compelled to provide labor and expend significant costs totaling \$305.60 in order to clean up the property at 81 Lakeview Terrace; and

WHEREAS, the property maintenance code of the Borough of Oakland permits the imposition of the lien in the nature of additional taxes in such case; and

WHEREAS, a report dated October 25, 2022 detailing the work performed and expenses incurred has been provided to the Borough Administrator who has approved the cost and expenses.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Oakland that the Tax Collector be and is hereby directed to charge as additional real property taxes to the owner of the property located at 81 Lakeview Terrace the sum of \$305.60 being the amount due pursuant to the report dated October 25, 2022.

WHEREAS, Utility is not obligated by State law or agreement to relocate its own facilities as its own expense for this type of Project; and

WHEREAS, the provisions of the State's Accommodation of Utilities within Highway Right of Way N.J.A.C. 16:25 and Code of Federal Regulations, 23 C.F.R. 645, Subpart B are applicable;

Mr. Kunze responded that Capital Alternatives LLC. used to be the Borough's grant writer for specific NJDOT grants with a retainer amount per grant. Mr. Kunze added that last time the Borough looked into grant writers, the price was rather high. Mayor Schwager encouraged the Borough Council to look into vendors at the 2022 League of Municipalities Conference.

Those that participate can obtain a reduction on their car insurance. There is a Veterans Day Ceremony scheduled for November 11, 2022 at 10:45 a.m. in Veterans Park. Residents are encouraged to attend.

COUNCILMAN SALIANI: Councilman Saliani reported that the property survey for Bush Plaza has been completed by Boswell Engineering. The Borough will be looking for a new Forester for 2023.

COUNCILMAN SLASINSKI: Councilman Slasinski reported that the Decommissioning Project for the Sanitary Sewer Treatment Plants continues along Hiawatha Boulevard with pipe installation. Over the next two weeks, all force main work is expected to be complete. The contractor will then move to the crossing at the railroad. Boswell Engineering has resolved a service issue for the

Iroquois Pump Station Upgrade Project, and the project is expected to be complete in 2023. The Oakland Public Library thanked the first responders and DPW for a successful Truck Day.

COUNCILMAN TALAMINI: Councilman Talamini applauded the Public Events Committee for a successful Halloween Parade and Trick or Trunk. The Annual Christmas Tree and Menorah Lighting Ceremony is scheduled for December 4, 2022 at 5:00 p.m. in Veterans Park. Councilman Talamini congratulated all who ran in this year's election.
