Mayor Linda H. Schwager announced that proper notice of this meeting was made as to time, date, place, and agenda.

#### SALUTE TO THE FLAG AND MOMENT OF SILENCE:

#### MAYOR'S REPORT:

Mayor Schwager announced that various events have been rescheduled. The annual Car Show and the Horseshoe Tournament will be held October 1st. The Great Oak Park event will be held on October 14, 2023. The Halloween Parade and Trunk or Treat will be held on October 28, 2023. The Mayor advised that the Lakeside Ave water main project is being advertised for bid and will include paving. She advised that the Mountain Lakes and Chapel Hill discussed at the last meeting have been reviewed. The Borough is waiting for a report to determine is there will be a tonnage increase for Patriot's Way Bridge. Mayor Schwager advised that the angled parking spaces adjacent to the Hiawatha Fire House are for Fire Department personnel only. Mayor Schwager alerted the public to a Bergen County Utility Authority public hearing on Thursday August 28, 2023 at 1:30 PM in the Mayor and Council Chambers. This hearing is about a proposed amendment to the Bergen County Solid Waste Management Plan to include Oakland Materials LLC as a Class B Recycling Facility to be located at 342 W. Oakland Avenue in the industrial park with access via Edison Avenue. She advised that we need residents to attend and give input. This meeting was stated to be given public notice on 9/8 and 9/15/23 and Borough Attorney Matt Gilson stated that the Borough's position is that these notices were not accurate. Mayor Schwager then stated she has received a copy of the 62-page Green Streets Policy from the Environmental Commission. Mr. Kunze stated this will be distributed to the Mayor and Council in the fall.

#### ENGINEER'S REPORT:

Borough Engineer Mr. Yakimik stated that the Patriot's Way Bridge Advertisement for bids will be placed prior to October 13, 2023. Mr. Yakimik stated that with regards to the PFOS, the three wells remain on schedule. The contractor J Fletcher Creamer stated they will be starting within the next

one to two weeks and the Carbon filters are on schedule to be delivered mid-November 2023, with the full project completed by February 2024. Mr. Yakimik stated they have advertised for bids on the Lakeside water main, and they are due by October 17, 2023. The work would be done late fall through winter; paving will be done curb to curb in the spring. Mayor Schwager stated there are trucks and construction materials still present.

Mr. Yakimik stated that these trucks belong to Pacific who is the current sanitary pump station which is the treatment plant conversion to the pump station, they are winding down for the end date in November which will include the decommissioning part. As for the recent complaint of oil, it was confirmed to be algae and site maintenance is being watched.

Mike Guadagnino 34 Hopper Street asked if Doty Park would be part of the cleanup. Borough Administrator Mr. Kunze stated when the project is complete. The contractor will have to remove all the material and restore the site to the condition it was when they started using it. Mr. Guadagnino stated that the sign was broken and replaced, and he would like to be assured that they clean up properly.

Kerri Sirinides 41 Sioux Avenue, advised that one of her tree's limbs fell her neighbors roof. A tree company recommended that the whole tree needed to be removed because it was dead. Now she has received a letter stating she has to replace the tree or pay \$500.00. Ms. Sirinides has already paid \$000.00 to have the tree removed. Councilman Saliani stated he would review this with the Shade Tree Commission.

Councilman Pignatelli set forth the motion, seconded by Councilman Kulmala, to close public comment.

WORK SESSION:

**Proposed Streetscape:** The Planning Board has referred an updated streetscape design ordinance for the council's consideration and approval. The Ordinance establishes standards and regulates elements such as trees, sidewalk, street lighting, benches, and bike racks in the B-2, DT1 and DT-2 Zones. Councilman Saliani asked if it would be better to wait for the new assessment report. Councilman Kulmala stated that this recommendation will allow the committee to have a working document to go along with the T&M report. Additional discussions will take place at that time. Councilman Talamini stated that the Borough should consider LED lighting for the old-style lights. Councilman Kulmala stated that the Complete Streets program report will have an impact on planning.

#### Major Modification Water Allocation Permit 5199:

The NJDEP has approved the amended Wastewater Management Plan. The Council will need to move forward with seeking a major modification to our Water Allocation Permit to account for the inter-basin transfer that will result from sending future sewer flow to the NBCUA. This action is necessary prior to expansion of the sewer system. The permit application will include a water conservation and drought management plan and an assessment of future water demands. Boswell Engineering has proposed to undertake this work for an amount not to exceed \$40,000.00.
