Andrea Levy of 780 Ramapo Valley Road, Oakland, N.J. 07436 asked the Governing Body on the status of the new lead based paint law and how the property owners are being educated about the new law. Mr. Chewcaskie advised that the Borough is preparing an ordinance for introduction prior to the end of the year. Mr. Kunze advised that the Borough Building Sub Code Official is taking the required courses for the lead based paint inspections certification.

Mr. Heffernan provided updated conceptual drawings of the park and expressed the importance of bringing the park to reality. Mr. Heffernan explained that the park will be completed in phases using grants and fundraising efforts. The park will feature a four sided clock, benches, trees, a new flagpole, and landscaping. A fundraising plan with four (4) different donor levels was presented and is being prepared by the Committee for release. There are several sponsorship opportunities available and all potential donors will be reached out to via mail and other means. The hope is to construct Phase 1 in the fall of 2023.

**WORK SESSION:** 

#### **Short Term Rentals:**

Mr. Chewcaskie advised that the current zoning ordinance permits housing of three (3) boarders in all residential districts. The recommendation is to introduce the ordinance at the next Council Meeting. Exclusions include licensed hotels or parish houses. Mr. Chewcaskie advised that the second ordinance would prohibit short-term rentals. The Borough of Franklin Lakes recently passed an ordinance expanding on short-term rentals to include prohibitions on renting out swimming pools. Mr. McCann read aloud an email from the Police Chief advising that no vehicle thefts to-date in 2022 were correlated to short-term rentals. Mr. Pignatelli suggested that the Governing Body review the short-term rental ordinance and bring forth on work session at the next Council Meeting. Mr. McCann asked if this could be brought forth via a referendum on the ballot. It was advised that zoning ordinances are not eligible for referendum. The Planning Board must review this ordinance prior to final adoption. The Governing Body agreed to act on the boarding house ordinance at the next meeting and to further review the short-term rental ordinance prior to the next Council Meeting.

## **OLD BUSINESS:**

Councilman Talamini asked the status of the Roosevelt Boulevard home demolitions and the acquisitions of homes on Lenape Lane. Mr. Chewcaskie advised that issues are being addressed by the NJDEP and the Borough should be proceeding in the near future. Mr. Kunze advised that a bid would be out this fall for the demolitions.

## **NEW BUSINESS:**

No new business reported.

## **COUNCIL COMMITTEE AND LIAISON REPORTS:**

**COUNCILMAN KULMALA:** Councilman Kulmala reported that the Sustainable Oakland Green Team held a successful Styrofoam Drive on September 24, 2022. An entire box truck was filled with Styrofoam. The Community Garden received over 100 pounds of food donations for the 2022 growing season. A report from the Police Chief was read aloud. The Recreation Commission is hosting wrestling, basketball, and lacrosse registrations. There is a \$30 late fee. The baseball mum sale is underway at the Dunkin Donuts Parking Lot this weekend.

**COUNCILMAN MCCANN:** Councilman McCann reported that the 2021 Annual Audit was received and will be reviewed in further prior to the October 12, 2022 Council Meeting.

**COUNCILMAN PIGNATELLI:** Councilman Pignatelli reminded the public that the next Planning Board Meeting is scheduled for October 13, 2022 at 7:00 p.m. at the Oakland Senior Center, 20 Lawlor Drive, Oakland, N.J. 07436. Discussions will continue on the Hovnanian Development off McCoy Road. The Environmental Commission is preparing formal comments in regards to same.

**COUNCILMAN SALIANI:** Councilman Saliani advised that the Shade Tree Commission has recommended a resident for appointment at the next Council Meeting. Councilman Saliani advised that the Bergen County Trust Fund has submitted their recommendations for FY22 grant funding and more information is forthcoming.

**COUNCILMAN SLASINSKI:** Councilman Slasinski reported that the completion date of the Sanitary Sewer Decommissioning Project remains August 24, 2023. Piping work is progressing along Franklin Avenue and is expected to be completed within three (3) weeks. Boswell Engineering is working on bid specifications for the water main improvements along Acorn Street, Birch Avenue, and Florence Avenue. The Oakland Public Library is hosting a mind reading game show on Thursday September 29, 2022. Registration is available on the Oakland Library website. The Oakland Public Library thanked the Oakland DPW for landscape maintenance.

**COUNCILMAN TALAMINI:** Councilman Talamini encouraged residents to volunteer for the Public Events Committee. The Annual Halloween Parade and Trick or Trunk will be held on October 29, 2022 at 10:00 a.m. in the Municipal Plaza Parking Lot.
