- 10. Dog Park 4 years ago the Shade Tree committed to plant trees at dog park. 7 hard wood and several conifers will go in to replace the five trees (12 inches or greater) that are being taken out. The trees being removed are in the footprint of the dog park and need to be removed. We are content with species and set back. Ed Clark signs off on proposed trees, but we are concerned about the watering and care. Larry Levine motioned to accept the plan as Ed Clark presented, Kim Bouma seconded, and all were in favor.

 - a. Tom Connolly is on the planning board Concerned about the enforcement of tree replacement after clearing for development. Building permit should contain a rule that a CO cannot be obtained without Shade Tree signing off. Tom Connolly recommends that the planning board put 2-year bond for tree replacement. The shade tree commission agreed to inspect. If a new tree dies it is usually within 2 years. It is legitimate that the bond be held for 2 years, even after the CO is given.
 - b. It is in the STC ordinance that a bond can be ordered but it had not been used.

- c. Shade tree member will attend the Planning board to explain support of bond use if necessary.
- d. Ryan Schwertfeger, thanked members for their attention to the trees at the planned Dog Park.
