We will relook at all 35 trees and including the 9 new trees on the borough list to be removed. The list will be divided up among us and have all trees inspected by September 21. And then prepare list to go out a to bid asap. The trees will be prioritized to ensure that the most dangerous trees come down first. The bid will be given more time to collect more competitive bids. Motion was made by Ed Clark and seconded by Tony Smid. The bids will be opened at the November 2 STC meeting.
