NOW, THEREFORE, BE IT RESOLVED by the Board of Health of the Borough of Oakland that said Board of Health Attorney be and is hereby appointed for the year 2013; and

BE IT FURTHER RESOLVED, that compensation for said Board of Health Attorney for the year 2012 shall be claimed, approved and paid in the manner set forth in N.J.S.A. 40a:5-18 and pursuant to agreement to be entered into between parties; and

2013 BERGEN COUNTY DEPT. OF HEALTH SERVICES PUBLIC CONTRACT

It was reported that the Mayor and Council have approved and executed this contract. R.E.H.S. hours were reduced to 6.5 units. Per Mr. Kunze, if there is a need for additional hours of R.E.H.S. service, the contract will be amended, as was done in 2012.

NEW BUSINESS

2013 WALDWICK INTER-LOCAL AGREEMENT FOR CHILD HEALTH CONF. SERVICES

It was reported that, contrary to the information the Borough of Waldwick provided during budget preparation, there will be a minor increase in the cost of CHC Services. The cost for immunizations only will increase from \$15/child/visit to \$20/child/visit. The Administrative Fee remains the same at \$125/year and the cost for an exam with immunization(s) remains at \$35/child/visit.

The Mayor and Council have approved and executed this contract.

MCCOY FARMS SEPTIC PLAN REVIEW - BLOCK 4202, LOT 1.10

Inspector McGrath informed the Board that the property-in-question is one of 23 building lots in the McCoy Farms project. Inspector McGrath reported that she had reviewed and approved the septic plan which she then distributed and reviewed with the Board.

On motion of Mr. Ostapczuk, seconded by Mr. Talucci, the Board approved the plan for Block 4202, Lot 1.10.

ANY OTHER BUSINESS

Council Liaison Pignatelli informed the Board that in response to making an announcement at the Mayor and Council meeting about the opening on the Board of Health, Ms. Daria Blanco responded. Ms. Blanco was asked to complete a Citizen Leadership Form which Mr. Pignatelli distributed to the members of the Board for their review. To date, no other residents had come forward to express interest and no potential candidates had been identified by any members of the Board.

Mr. Talucci addressed the Board about over-the-counter single ingredient liquid pediatric Acetaminophen that was made in two different concentrations, a standard pediatric formula and concentrated (triple strength) infant drops. The concentrated infant drops were discontinued by the manufacturer in May 2011, on recommendation of the Consumer Healthcare Products Association and Institute for Safe Medication Practices, and are being phased out because of the potential for dosing confusion with the standard strength pediatric liquid formula. The product was not recalled.

Mr. Talucci reported that pediatric Acetaminophen is highly tolerated if given properly; however, if infants/children are administered the same ml doses of the concentrated infant drops as the standard formula, unwanted side effects such as abdominal pain, irritability, liver failure and heart problems can occur.

Mr. Talcucci said the concentrated infant drops are still available on the shelves of retailers, including ShopRite in Oakland, and expressed concern that parents might confuse the products and administer an incorrect dose to their children. Mr. Talucci was also concerned that ShopRite could possibly be held liable should this happen.

Mr. Talucci felt ShopRite should post near the concentrated infant drops a warning to parents to check labels carefully and advise them to consult their pharmacist or pediatrician if there is any confusion about the concentration they have in their possession and to contact their child's healthcare provider immediately if their children develop any children's acetaminophen side effects.

The Board decided to have the information Mr. Talucci presented sent to ShopRite with a cover letter.

Inspector McGrath reported that the mother of an Indian Hills High School student called to complain about how the school followed up on an incident that occurred in her daughter's art class. Her daughter cut herself on the blade of an X-acto knife. Inspector McGrath followed up with Principal Evangelista, the school nurse, the Board of Education and Bergen County and Valley Hospital public health nurses. All blood-borne pathogen protocols were followed. It was the opinion of the Board that the Board of Health has no jurisdiction in the matter.
