FRANK'S PIZZA

Mr. Tony Greco, 586 Manhattan Avenue, Thornwood, NY, introduced himself as the owner of the establishment.

Mr. Tiffinger advised Mr. Greco that he had been called to appear before the Board due to receiving two Conditionally Satisfactory ratings in a 12-month period. Inspector Meeker reported that a refrigerator was not working properly and food was being cooled improperly. Furthermore, the hand-wash sink was obstructed and hands were not being washed at the appropriate times.

Mr. Tiffinger told Mr. Greco that prior to being issued these two consecutive Conditionals, the Board had never experienced problems with his establishment and mentioned Frank's Pizza was voted as having the best pizza in Oakland at a poll taken at the Farmer's Market. Mr. Greco said it was inexcusable and felt it was due to a change in personnel that occurred over the last year. He accepted full responsibility for the temperature problems. Mr. Tiffinger said all of the problems were Mr. Greco's responsibility because there are food managers on the premises that should be supervising the employees.

Council Liaison Pignatelli asked Mr. Greco if he knew why cooling large batches is a problem. Mr. Greco said they used to break down the batches of sauce into smaller batches and then put them into ice baths to quickly cool it to proper temperature. He said he doesn't know what happened. Mr. Tiffinger said somebody wasn't watching. Mr. Greco said he spends three to four days a week in his Pompton Lakes store.

Mr. Tiffinger told Mr. Greco that since Frank's Pizza had been fairly good in the past, he expects to have no further problems with the establishment in the future.

On motion of Mr. Ostapczuk, seconded by Ms. West, the meeting was closed to the public.

LICENSING OF NON-PROFIT AND BOROUGH-AFFILIATED TEMPORARY EVENTS

It was reported that this subject was brought before the Board for two reasons, i.e., non-profit organizations and some Borough agencies are bringing in unlicensed and uninspected outside vendors to cater events and Borough agencies are preparing and serving food to the public without obtaining a health license. Administrator Kunze recommended sending a letter to non-profit organizations and a memo to Borough agencies outlining licensing protocol in order to ensure the public is protected from illness and to protect the Borough from potential lawsuits.

Ms. Dubowick had prepared the requested memo and letter, both of which the Board reviewed and approved. The Board agreed that a license will be required if the food being served by Borough agencies falls under the state's definition of potentially hazardous food, regardless of whether a fee is being charged, and that coffee and donuts being consumed at meetings would not require a license. Non-profit agencies must apply for a temporary health license when serving or selling food if they do not currently hold a license, and outside vendors must obtain a temporary health license.

ORDINANCE PROHIBITING THE FEEDING OF DEER

Per Administrator Kunze, Mayor Schwager asked the Board to review Princeton Township's ordinance prohibiting the feeding of deer and requested a recommendation on whether the ordinance should be adopted in Oakland. The Board reviewed the ordinance and was of the opinion that such a prohibition would help keep deer out of residents' yards and, thus, help prevent the spread of Lyme disease

The Board decided to move forward with adopting the ordinance and asked Mr. Romans to prepare a finalized version for introduction at the September meeting and adoption at the October meeting.

The Board also decided that prior to introducing the ordinance efforts should be made to educate the public on the purpose of the regulation. Ms. Dubowick will prepare a short article for placement on the website and submission to the newspaper.
