WHEREAS, Board of Health member Mary Ann West has nominated Thomas J. Romans, Esq. to serve as the Board of Health Attorney for the year 2019; and

WHEREAS, the Board of Health of the Borough of Oakland will receive an Affirmative Action compliance statement from Thomas J. Romans, Esq. prior to entering into a contract, and

NOW, THEREFORE, BE IT RESOLVED by the Board of Health of the Borough of Oakland that said Board of Health Attorney be and is hereby appointed for the year 2019; and

BE IT FURTHER RESOLVED, that compensation for said Board of Health Attorney for the year 2019 shall be claimed, approved and paid in the manner set forth in N.J.S.A. 40a:5-18 and pursuant to agreement to be entered into between parties; and

BE IT FURTHER RESOLVED that the contract amount shall not exceed \$4,000.00 (\$2,925.00 retainer and \$1075.00 other legal services) without further authorization of the Board of Health of the Borough of Oakland, and the Chief Financial Officer has certified sufficient funds are available in Account #19-01-27-330-028; and

BE IT FURTHER RESOLVED that the President of the Board of Health of the Borough of Oakland is hereby authorized to sign the agreement on behalf of the Board of Health of the Borough of Oakland; and

BE IT FURTHER RESOLVED, that the Secretary of the Board of Health of the Borough of Oakland shall cause a notice of the adoption of this resolution to be printed in a qualified newspaper within ten (10) days after passage hereof.

Council Liaison Pignatelli felt it was a good article.

Also discussed were the effects of both alcohol and marijuana on the developing brain. Mr. Talucci pointed out that the percentage of alcohol is included on the label of all alcoholic beverages, but marijuana is not labeled with the amount of THC it contains which makes it more dangerous.
