- a. Town Council Update- Councilwoman Coira discussed the PILOT Program. She also noted that the Borough Unregulated Pipeline ordinance is being updated by Mayor& Council per advice of the coalition of North Jersey towns working together to protect itself from oil spills.
 - i. Bi-County property acquisition is still being discussed by the Council.
 - ii. Progress is being made on downtown sewerage. Coira explained that the Borough needs to rescind its Highlands-conforming status in order to provide sewage treatment to the downtown area via an interbasin connection to Franklin Lakes. The Borough is discussing this with the NJ DEP.
- <u>b.</u> Great Oak Park Update A public hearing is required for purchase of a Bandstand to be installed in Great Oak Park on a Great Lawn. The Band shell would be purchased with a grant from Bergen County for open-space improvement.

- c. Green Team Update Oakland certification needs to be renewed by 12/31/17. reports necessary for recertification have been submitted for a total of 320 points. Sustainable Jersey will respond with the number of points actually earned. Borough has until the first week of November to complete actions. Kevin Mauro attended presentation of an SJ grant for bike stands in Oakland.
