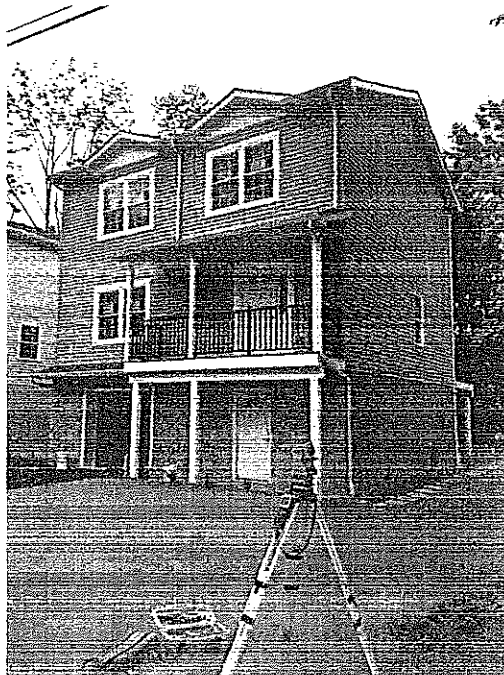

Photo One Caption Front View

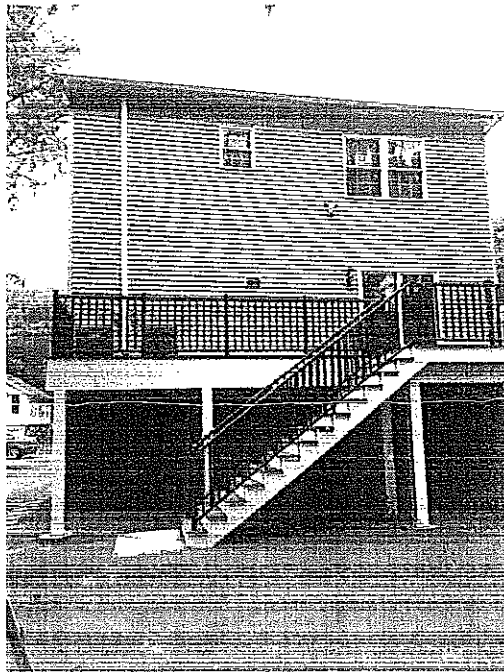
