

**BOROUGH OF OAKLAND
ORDINANCE NO. 18- CODE-769**

**AN ORDINANCE AMENDING THE REVISED GENERAL
ORDINANCES OF THE BOROUGH OF OAKLAND
CHAPTER VII "TRAFFIC", SECTION 7-39 "CONTROL OF
THE MOVEMENT AND THE PARKING OF TRAFFIC ON
PUBLIC AND PRIVATE PROPERTY", TO ADD A NEW
SUBSECTION TO SECTION 7-39.3 "REGULATION FOR
THE MOVEMENT AND PARKING OF TRAFFIC AND ALL
OTHER PRIVATE PROPERTY" SECTION 7-39.3g
OAKLAND CROSSROADS**

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Oakland as follows:

Section 1. Chapter 7 "Traffic" Section 7-39 of the Revised General Ordinances of the Borough of Oakland is hereby amended and supplemented by the addition of a new section "g" to Section 7-39.3 "Regulation for the Movement and Parking of Traffic and all other Private Property".

Section 7-39.3g Oakland Crossroads

- a. Drawing of Oakland Crossroads. Reference to streets and roads as set forth herein shall be as shown on the drawing entitled, "Title 39 Plan", Oakland Crossroads, Interstate Shopping Center, New Jersey State Highway No. 202, Oakland, New Jersey prepared by Bertin Engineering, dated January 12, 2018.
- b. General Parking.
 1. All vehicles must park in designated areas and between the lines provided.
 2. No person shall stop or stand a vehicle upon any of the streets or parts of streets described below:

Entrance "A" and "B"	Both	All	Entire Length
Exit "A"	Both	All	Entire Length
- c. Through Street and Stop Intersections.

1. Through streets. The following streets or parts of streets are hereby designated as through streets. Stop signs shall be installed on the near right side of each street intersecting the Through street except where Yield signs are provided for in the designation:

Names of Street	Limits
Exit "A"	From Road "B" to US Route 202
Road "B"	From Entrance & Exit "A" to Aisle "B"
Road "C"	From Aisle "B" to Aisle "E"
Road "A"	From West Oakland Avenue to Aisle "D"

2. Stop Intersections. The following described intersections are hereby designated as stop intersections. Stop signs shall be installed as provided therein.

Aisle "D" and Road "A"	Aisle "D"

Aisle "A" and Exit "A"	Aisle "A"
Aisle "E" and Road "H"	Aisle "E"
Road "H" and Aisle "E:	Road "H"
Road "F" and Aisle "A"	Road "F"

- d. One-way streets. The following described streets or parts of streets are hereby designated as one-way streets in the direction indicated:

Name of Street	Direction	Limits
Entrance "A"	West	Entire Length
Entrance "B"	East	Entire Length
Exit "A"	South	Entire Length
Road "H"	West	Entire Length
Road "E"	South	Entire Length
Road "F"	South	Entire Length
Road "G"	North	Entire Length
Road "D"	West	Entire Length

- e. Speed Limits.

1. The speed limit for both directions of traffic in the parking lot(s) shall be 15 m.p.h.
2. The speed limit for both directions for travel on the following roadways are:

Name of Roadway	Miles Per Hour	Limits
All Roads "A", "B", "C"		

"D", "E", "F", "G", "H" 15 Entire Length

Aisles "A", "B", "C", "D", "E" 15 Entire Length

3. Regulatory and warning signs shall be erected and maintained to effect the above designated speed limits authorized by the Department of Transportation.
- f. Tow-away. Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grassy area, pedestrian walkway, or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner's or operator's expense.
- g. Signage. All signs, posts, or other necessary materials shall be installed and paid for by the applicant. All signing shall conform to the current Manual on Uniform Traffic Control Devices, pursuant to N.J.S.A. 39:4-183.27.
- h. Penalty. Unless another penalty is expressly provided by New Jersey Statute, every person convicted of a violation of this section or any supplement thereto shall be liable to a penalty of not more than \$200 or imprisonment for a term not exceeding 15 days or both.


Section 2. All other provisions of Chapter VII, "Traffic" of the Revised General Ordinances of the Borough of Oakland are hereby ratified and confirmed.

Section 3. Should any part, portion or provision of this ordinance be held unconstitutional or invalid, such decision shall not affect the validity of this ordinance as a whole, or any other part thereof.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 5. This ordinance shall take effect immediately upon publication and final passage according to law.
