BOROUGH OF OAKLAND ORDINANCE NO. 19-CODE-784

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 2-16 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF OAKLAND ENTITLED "CABLE TV AND COMMUNICATIONS COMMISSION" SECTION 2-16.2 AND SECTION 2-16.3.

WHEREAS, the Cable TV and Communications Commission has recommended a revision to the membership of the commission to allow for a non-voting junior member between the ages of 13 and 18 years who is a Borough resident; and

WHEREAS, the Mayor and Council have reviewed the suggested revision and find amending the Ordinance to be in the best interest of the citizens of the Borough of Oakland.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Oakland as follows:

SECTION I

A. Chapter 2, Section 16.2 - Establishment; Membership.

There is hereby established the Borough of Oakland Cable TV and Communications Commission. The membership shall consist of seven (7) members, two (2) alternate members, and one (1) non-voting junior member between the age of 13 and 18 years of age, all of whom shall be residents of the Borough, but none of whom may, contemporaneously, be members of the Governing Body, and/or full-time employees of the Borough.

B. Chapter 2, Section 16.3 - Appointments; Terms.

The Mayor shall nominate and with the advice and consent of the Borough Council appoint the members of the Commission, who shall serve for a period of three (3) years, except the respective terms of office for the originally appointed members shall be as follows:

- 1. Three (3) members shall serve for terms of three (3) years;
- 2. Two (2) members shall serve for terms of two (2) years;
- 3. Two (2) members shall serve for terms of one (1) year.

4. One (1) junior member between the age of 13 and 18 years shall serve for a term of one (1) year. The junior member may serve multiple one-year terms until such time as the junior member attains the age of 18.

The term of each member, except for the initial term, shall begin on the first day of January, and each members shall continue in office until his/her successor shall be appointed.

SECTION II

All other parts, portions and provisions of Chapter 2-16 of the Code of the Borough of Oakland are hereby ratified and confirmed, except in the event of an inconsistency with the foregoing. In the event of any such inconsistency, the terms and provisions of Section I hereof shall be deemed to govern.

SECTION III

Should any part, portion or provision of this Ordinance be held unconstitutional or invalid, such decision shall not affect the validity of this Ordinance as a whole, or any other part thereof.

SECTION IV

This Ordinance shall take effect immediately upon publication and final passage according to law.
