MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MAYOR'S REPORT:

Mayor Schwager advised that the Library exterior is being painted. She advised that New Jersey Monthly Magazine ranked Oakland 15th in top places to live in New Jersey. Oakland was ranked #1 for young families because of schools and recreation programs. Mayor Schwager advised that Oakland Municipal Alliance will hold a luncheon for Seniors on August 29th at 12 noon. The topic of discussion will be possible side effects of medications and drug interactions. Mayor Schwager advised that schools will open on September 4th and she asked residents to drive carefully.

RESOLUTION 13-213 APPROVE OPEN SPACE GRANT SUBMITTAL On motion of Councilman Visconti, seconded by Councilman Jensen, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, the Bergen County Open Space, Recreation, Farmland & Historic Preservation Trust Fund ("County Trust Fund") provides grants to municipal governments and to nonprofit organizations for assistance in the acquisition of lands for open space conservation purposes and/or outdoor recreation facilities; and

WHEREAS, the Borough of Oakland desires to further the public interest by obtaining a grant of \$1,453,905 from the County Trust Fund to fund the following project: Flood Buyout Program-Roosevelt Boulevard, Phase I; and

WHEREAS, the governing body has reviewed the County Trust Fund Program Statement, the County Program Open Space Policy and Procedures Manual, and the open space application and instructions and desires to make an application for such a grant and provide application information and furnish such documents as may be required; and

WHEREAS, as part of the application process, the governing body has held a public hearing on August 28, 2013, to receive comments prior to the submission of said application(s); and

WHEREAS, the County of Bergen shall determine whether the application is complete and in conformance with the scope and intent of the County Trust Fund; and

WHEREAS, the applicant is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statutes, and is wiling to enter into an agreement with the County of Bergen for the above named project(s); and

WHEREAS, if the applicant is successful in acquiring said project through the use of a County Trust Fund Grant, then the applicant will permanently preserve said project for open space conservation and/or outdoor recreation purposes through a recorded deed of easement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Oakland:

- 1. That it is hereby authorized to submit the above completed project application to the County by this year's deadline established by the County; and
- 2. That, in the event of a County Trust Fund award that may be less than the grant amount requested above, the applicant has, or will secure, the balance of funding necessary to complete the project; and
- 3. That the applicant agrees to comply with all applicable federal, state, and local laws, rules and regulations in its performance of the project; and
- 4. That this resolution shall take effect immediately.

Councilman Pignatelli questioned item 2. If the County only grants the Borough \$453,000, are we committed for an additional \$1 million in funding? Mr. Kunze responded it is only if the Council decides to move forward with the project. The Council is not obligated to accept the grant.

WORK SESSION:

ENGINEERING PROPOSAL-BACKSTOP PROJECT

Mr. Kunze advised that the Borough had applied to the County for grants for the Recreation Backstop project and have received two grant awards. This contract would be for Engineering for the project. He explained that the Borough would need to bid the work because it is over the threshold. Councilman Pignatelli questioned where the money was coming from. Mr. Kunze responded there was a capital budget established for the project. Councilman Jensen asked if the construction inspection was a not to exceed amount. Mr. Kunze responded that both engineering and construction inspection are not to exceed amounts. A resolution will be listed on the next agenda.

NJDOT 2014 GRANT APPLICATION

Mr. Kunze advised that this application would be for Monhegan Avenue and Lakeside Boulevard which are in need of resurfacing. These roads would make good candidates for funding from the NJDOT. Borough Engineer Rebecca Mejia advised that is a connector roadway so it is an enticing project to NJDOT.

POLICE ACCREDITATION BID

Mr. Kunze advised that this project has been a long standing goal for the Police Department. The Police Department will be judged on over 100 different criteria and policies. This would reflect the professionalism of the Department. This will also allow the Borough to save on liability insurance premiums. This is a labor intensive process. One bid was received in the amount of \$39,000. The Borough has a \$25,000 grant from the JIF for the project. Councilman Pignatelli advised this is an excellent program. It was proposed several years ago. He likes the fact that the operating procedure manual will be redone and everyone needs to sign off on that manual. He advised this process benefits the town in many ways. Mr. Kunze advised that the project will take one year to complete. A resolution will be listed on the next agenda.

NEW BUSINESS:

Mr. Kunze advised he was notified today by Borough Engineer Kevin Boswell that Bergen County wants to pave Franklin Avenue in Oakland this year. The Borough has to undertake the ADA curb cut work but we will be reimbursed by the County. Councilman Visconti commented that the Borough has to pay for Engineering costs. Mr. Kunze responded that the County expanded the reimbursements to include the costs for the curb cuts. Mr. Kunze advised that OEM Coordinator Roy Bauberger filed a grant through FEMA. There is no match requirement. A resolution will be listed for the next meeting to confirm the grant application submittal.

Mayor Schwager advised that this is the first year the Borough had a summer intern program. We hope to continue it next summer.

COUNCIL REPORTS:

Councilman Visconti: The Park Committee meeting has been moved to September 3rd at 8 pm. He advised that the Committee is looking for a recording secretary. Councilman Visconti spoke about the NJ Monthly Magazine article. He thinks the people of Oakland have known for a long time how great Oakland is and now other people are finding out. Councilman Visconti spoke about the lights at the Recreation field. This has been a revolving project. Councilman Visconti had many of the same questions that Mr. Monaco has had. Some of the bulbs are fused to the fixtures. The Borough has waited to do this project and now it is necessary. He explained that years ago it was acceptable to let one vendor do everything but now the Borough needs to have a competitive bid and we need specifications to go out to bid. He explained that the Borough is looking at energy efficient lamps so it would benefit the town. Mr. Kunze advised that Musco Lighting was consulted when the Borough got the original estimate for the project. We did plan to do the project in three phases. However, the system has really deteriorated. We have had to rent lights to keep the programs going at night. It is time for an overall upgrade. Councilman Pignatelli commented that there will be savings on the Borough's electric bills which will help toward the cost of the project.

Councilman Pignatelli: The Police Department had 958 calls in July. The Municipal Alliance will hold a luncheon at the Senior Center on August 29th on effects of drugs and interactions. The Bergen County Senior picnic will take place Tuesday September 17th from 10 am to 3 pm.

Councilman Jensen: No report.

Councilwoman Coira: The Recreation winter sports signups are posted on the Recreation website. The Shade Tree Committee will meet Tuesday at 7 pm.

Mayor Schwager thanked the Park Committee for changing the date of the meeting due to the Jewish holiday.
