WORK SESSION:

BERGEN COUNTY PARK IMPROVEMENT GRANT APPLICATION: Mr. Kunze advised that the deadline to apply for this grant is October 13th. The Recreation Commission would like to request \$ 50,000 for purchase of a bandshell for Great Oak Park. The grant would require a \$ 50,000 match. Park Committee Chairman Mike Guadagnino commented that things are moving along in the Park. They are close to having the great lawn developed which they need to raise money for and then the bandshell can be put in. There should be enough money in the Recreation Trust for the match but he hopes to do fundraising as well. Mr. Kunze advised tha the Borough filed a notice of intent to apply for this grant. The formal application deadline is October 13th. The Mayor and Council will need to adopt a resolution to endorse the grant application.

Councilman Kulmala asked if this is portable. Mr. Gaudagnino responded it is a fixed structure. He believes it will get a lot of usage. Councilman Visconti advised that the Borough has nothing to lose by applying for the grant. Councilman Talamini asked if the bandshell will have electricity. Mr. Guadagnino advised they will have electric run for the bandshell. Councilman Visconti advised that they are trying to raise money and also see what money can be gotten through grants.

SIGNS ON BOROUGH PROPERTY:

At the last meeting, a Borough resident and representative from the Family Reach Foundation asked if signs can be put on any Borough property other than at Bush Plaza. Mr. Kunze explained that the Borough's Code does not permit off-premise signs except at Bush Plaza. In 2010, the Mayor and Council decided to only allow temporary signs at Bush Plaza. Mr. Chewcaskie explained that Bush Plaza is the only location in which these types of signs are permitted. Most municipalities do not allow signs on Borough property or in the right of way. The Mayor and Council can regulate that but it could be problematic. The other issue with the Borough's Code is that it is limited in regards to temporary signs. The Code would need to be amended to allow these temporary signs, The question is whether the Mayor and Council want to allow signs other than at Bush Plaza. Mr. Kunze explained that when the Mayor and Council amended the ordinance in 2010, Bush Plaza was the compromise because they didn't want the signs on Borough property. Mr. Chewcaskie will prepare a draft ordinance but he does not recommend allowing signs on Borough property.

Councilman Jensen commented that he does not see a definition for temporary signs. Mr. Chewcaskie explained about political signs and signs for events. Councilman Jensen commented that he has seen real estate signs up for over a year. He questioned when the temporary period ends. Councilman Visconti asked if there is any other location besides Bush Plaza that would be acceptable for public service signs. Councilman Biale commented that when he was on the Council years ago, he made an attempt to replace the sign at Rotary Park with an electronic sign. He feels that an electronic sign should be put at the Veterans Park and Oak Street intersection. Councilman Visconti advised that he attended a meeting last week and there were three small electronic signs offered to the Borough. He asked the Council for an acceptable place to put these electronic signs and suggested maybe the Recreation Field as well as Bush Plaza.

The Borough attorney will prepare a draft ordinance for discussion at the next meeting.

BOSWELL PROPOSAL FOR LSRP SERVICES:

Mr. Kunze advised that Boswell is trying to wrap up the environmental issues at Great Oak Park. The only outstanding area of concern is some pesticide contamination in one area of the property. Additional testing is needed to determine the extent of remediation. Boswell's cost for this additional work is \$ 1,300 and they anticipate the lab costs will be about \$ 2,000. This is the last remaining work item left. A resolution to amend the contract will be listed on the next agenda.

PERSONNEL POLICIES UPDATE:

The Borough is required by the Municipal Excess Liability Joint Insurance Fund to updated its personnel policies on a bi-annual basis. There are changes required in the Anti-Discrimination Policy and ADA policy, Communication Media Policy, Employee Dating Policy and Proof of Employability section.

Councilman Visconti commented that in the past, volunteers have taken action on behalf of the Borough. He asked what the JIF thinks of that. Mr. Kunze advised that there is a clause in the personnel policies that applies to employees and volunteers. The Mayor and Council have also discussed writing a Code of Conduct for volunteers.

A resolution to adopt the personnel policies will be listed on the next agenda.

CONTRACT AMENDMENT S & L ARCHITECTURE:

This is the final bill from S & L Architecture in regards to the DPW project. It is for services rendered last year in relation to two site visits and the punch list used in completing the project. The bill is for \$ 1954 and would close out their services in the project. A resolution authorizing the contract amendment would be listed on the next agenda.

COUNCIL REPORTS:

Councilwoman Coira: The winter sports sign up information is listed on the Recreation website. On Saturday September 17th, the Indian Hills Boys and Girls soccer teams will hold a soccer clinic.

Councilman Jensen: The Planning Board will meet October 13th at 7 pm at the Senior Center. He explained that there were members of the public who showed up wanting to speak about the Wawa application. They left because they couldn't speak about the application. Councilman Jensen explained that the public does have a right to ask questions of the presenters.

Councilman Visconti: There was a Flood Commission meeting Monday night. The river restoration project had a kickoff meeting five weeks ago. We are expecting designs to be submitted soon. The Park Committee meeting was cancelled for this week. The Library project should be ready to go out to bid in a few weeks. There will be a Water and Sewer Committee meeting on Friday.

Councilman Biale: The Senior Center will host a barbershop quartet tomorrow. On September 22nd, there will be signups for flu shot clinic which will be held on October 6th. The Bergen County Surrogate will speak on September 23rd at 1 pm. The Senior Club will have entertainment on September 22nd. The NBC show George to the Rescue did renovations on Councilman Biale's neighbor's house. The show is tentatively scheduled to air on October 26th on Channel 4. The 15 communities involved in the Municipal Pipeline Group are going to be proactive because they heard that Pilgrim Pipeline will be making application to the DEP soon.

Councilman Kulmala: The Public Safety Committee will be meeting. Six electronic speed signs have been installed on Seminole Ave., Yawpo Ave., and Pawnee Ave. He thanked the Police Department for their work on getting these signs. Councilman Kulmala advised that Senator Cardinale and Assemblyman Auth came to Oakland to discuss Allerman Brook and the damage due to the work stoppage. They were taken to Patriots Way Bridge as well. He explained that our State representatives work with the Borough. Councilman Kulmala advised that OEM coordinator Roy Bauberger has been doing work clearing the river of trees to prevent further log jams in high water. The OEM members have also received swiftreach training.

Councilman Talamini: The schools are open so drive safely. He and the Mayor met with the Superintendent of Schools, some Board of Education members and the School Business Administrator about the possibility of moving the school election to November. They are going to send a survey to the residents in October to ask their opinion.

Councilman Biale advised that the crew is back working at Allerman Brook.
