RESOLUTION 16-216 AUTHORIZE AGREEMENT WITH NORTHWEST BERGEN COUNTY UTILITIES AUTHORITY-TV INSPECTION

WHEREAS, the Borough requires, at various times, television inspection of sanitary and storm water systems; and

WHEREAS, the Borough requires, at various times, jetting services of sanitary and storm water systems; and

WHEREAS, the Superintendent of the Department of Public Works and the Borough Administrator have reviewed the proposal of Northwest Bergen County Utilities Authority (NBCUA) to provide such services on an as-needed basis; and

WHEREAS, the Borough Attorney has reviewed the Inter-local Service Agreement forwarded to the Borough by the Executive Director of the NBCUA; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor of the Borough of Oakland is hereby authorized and directed to execute the Inter-local Service Agreement for the provision of sanitary sewer cleaning for the Borough of Oakland; and

BE IT FURTHER RESOLVED that Oakland will pay to NBCUA the sum of 51 cents (\$.51) per linear foot in 2017 and the sum of 52 cents (\$.52) per linear foot in 2018, and an equipment charge of \$500 per day, for such services, and

BE IT FURTHER RESOLVED that a copy of this Resolution and the Contract with NBCUA shall be maintained in the Borough Clerk's office for public inspection.

RESOLUTION 16-218 SUPPORTING S-2663

On motion of Councilman Biale, seconded by Councilman Visconti, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, almost all local units of government and Boards of Education in New Jersey including the Borough of Oakland secure insurance through governmental entities known as joint insurance funds (hereinafter JIFs);

WHEREAS, existing law limits JIFs to investments otherwise authorized for local governmental entities and Boards of Education;

WHEREAS, insurance mechanisms such as JIFs have different cash flow needs than local government and Boards of Education;

WHEREAS, existing law greatly limits the potential investment earning, currently less than 1% on investments of approximately \$1 billion;

WHEREAS, S-2663 and A-4234 would permit JIFs to invest in debt obligations of any governmental entity established under the laws of the State of New Jersey and federal agencies or governmental corporations;

WHEREAS, while the range of investments permitted by S-2663 and A-4234 is still very conservative, it would save the taxpayers at least \$10 million per year;

WHEREAS, S-2663 and A-4234 would also reduce interest expense for local units of government and Boards of Education by creating an additional purchaser of their bonds; and

WHEREAS, S-2663 and A-4234 would also permit JIFs to join together and create a joint investment and cash management program further increasing investment income;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Oakland that:

- 1. Legislature is urged to adopt S-2663 and A-4234
- 2. A copy of this resolution shall be sent to all area legislators as well as the Governor, Commissioner of the Department of Banking and Insurance and the Commissioner of the Department of Community Affairs

Mr. Kunze explained that this proposed agreement would facilitate the sharing of GIS Data between the Borough and County for the purpose of 'mutual aid and public safety'. Such data would be considered confidential and its distribution would be restricted, except as may be required to comply with open record laws. A resolution will be listed on the next agenda.

LIBRARY BID:

Mr. Kunze advised there were 15 bidders. He explained these bids need a lot of review. The Governing Body will need to discuss this in further detail in December to give direction for introducing a bond ordinance in 2017.

DOGWOOD SCHOOL DRAINAGE BID:

Mr. Kunze advised this work is being done on the Borough's storm sewer infrastructure at Dogwood School. There were 14 bidders. Mr. Kunze explained that the alternate bid price was secured on behalf of the Board of Education. If the Board of Education wishes to proceed, we would need to pursue an Interlocal agreement and the Board of Education will pay us for their portion of the work.

PURCHASE DUMP TRUCK:

Mr. Kunze advised that the funding of \$190,000 for this piece of equipment was authorized in the 2016 capital program. We are proposing to add a five year warranty and pay for it through the snow removal trust. It will replace one of our old, worn out primary salt trucks. Finally, the

purchase itself will be through the Educational Services Commission (ESCNJ) purchasing co-op. A resolution will be listed on the next agenda.

COUNCIL REPORTS: Councilwoman Coira: No report.

Councilman Jensen: The Planning Board will meet on December 8th at 7 pm at the Senior Center.

Councilman Visconti: He advised that the estimate for the Library renovation project was \$ 1.3 million and there were a number of bids that were right around the estimate. He thanked Mr. Kunze for his work on this. There was a Park Committee meeting last night. The clean up is done. At this point, aerial photographs are needed for the LOI. Councilman Kulmala is working on getting that done.

Councilman Biale: The Seniors will hold their end of year party on December 29th at 11 am. The Surrogate's satellite office is now at the Senior Citizens Center. The Borough requested LED lights from Rockland Electric. He will follow up with Rockland to see if they have done the installation. The construction on the exit ramp from 287 should be done by the end of the month. Councilman Biale commented that we need to get help from the DOT to get sidewalks from the north end of town. He wished everyone a Happy Thanksgiving.

Councilman Kulmala: He thanked OCC for their work on the Crossroads newsletter. The final print newsletter was mailed out. The newsletter will be on the new website in the future. West Oakland Avenue was paved. The Fire Department will have a new Fire Chief, Dave Hutsebaut, next year.

Councilman Talamini: There will be a minimum day for the schools on Wednesday and schools will be closed Thursday and Friday. The Board of Health met tonight and will meet again on December 20th. The Public Events Committee will hold the Tree and Menorah Lighting on December 4th at 5:00 pm. The next meeting of the Public Events Committee will be held December 12th at 7 pm. He wished everyone a Happy Thanksgiving.
