Mr. Chewcaskie advised that the public hearing and final adoption for this ordinance and Ordinance 16-Code-747 Amend Sign Ordinance were carried to tonight because the Planning Board had carried their review to their December meeting. Based on the letter received from the Planning Board, they are recommending the ordinances not be adopted so amendments can be made. Mr. Chewcaskie suggested tabling the ordinance.

MOTION TO TABLE:

On motion of Councilman Biale, seconded by Councilman Kulmala, the final adoption of Ordinance 16-Code-746 be tabled.

FINAL PUBLIC HEARING: ORDINANCE NO. 16-CODE-747 AMEND SIGN ORDINANCE-TABLED

Mr. Chewcaskie advised that this ordinance should be tabled based on the Planning Board recommendation.

MOTION TO TABLE:

On motion of Councilman Biale, seconded by Councilman Talamini, the final adoption of Ordinance 16-Code-747 be tabled.

ROLL CALL: Yeas, Councilmembers Biale, Coira, Kulmala, Talamini, Visconti. Nay, Councilman Jensen.

Mr. Chewcaskie advised that these ordinances would have to be reintroduced in 2017.

WORK SESSION:

LIBRARY PROJECT:

Councilman Visconti advised that a few years ago, the Borough hired an architect and did an extensive study of work to be done at the Library. The bid documents were prepared with two alternates. We received 15 bids and 1 bid was withdrawn. The low bid was \$1.346 million

including the two alternates. The base bid was work that was unfinished from the original project and work on the original section of the Library. Alternate 1 is for the removal and replacement of the exisiting storefront and automatic doors at the entrance vestibule. Alternate 2 is for the renovation of the existing Adult area in the basement of the new section of the Library for community meeting space. Alternates 1 and 2 are not essential but would make the Library nice for future use. He is asking the Council what they want to do so funding can be put into place.

Mr. Kunze advised the Mayor and Council that they can award Alternate 1 or Alternate 1 and 2 but they cannot award only Alternate 2 according to the bidding laws. The Library is becoming more about programs and meeting space. He explained that whatever the Mayor and Council decide to move forward with, a bond ordinance will be prepared for introduction. Councilman Visconti questioned how much funding is already on hand. Mr. Kunze responded that there is approximately \$ 300,000. Councilman Visconti advised that the original estimate for the project was \$ 1.3 million. He advised that with construction, a contignecy must be planned for.

Councilman Biale asked if the contractor has been vetted. Mr. Chewcaskie advised that the architect has checked references and recommended that they were satisfactory. Councilwoman Coira felt that the project should move forward because the Library is an asset to the community. She recommended that the project should be awarded for the base bid and both alternates. Councilman Jensen agreed that the entire project should be done. Councilman Visconti is in favor of doing the entire project. He advised that Library Director Peter Havel is an asset to the community. Councilman Biale agred to move forward with the entire project. Councilman Kulmala commented that the Library has been evesore and half of it cannot even be used. The Library has changed focus and will become a community school. He agreed to do the entire project. Councilman Talamini agreed to do the entire project. He asked if there will be any down time for the Library. Councilman Visconti advised that the work will be phased. He advised that there will be a meeting held on January 10th with a construction manager. Councilman Kulmala asked if there will be an impact for the Valley Middle School students who use the Library after school. Councilman Visconti advised that part of the design is to create a young adult space. He advised that the work will first be done in the old section of the Library. He explained that by the time the project is awarded and gets started, it will probably be spring.

Mr. Kunze will work on the bond ordinance which will be introduced in January.

COUNCIL REPORTS:

Councilwoman Coira: Recreation is holding sign ups for girls volleyball program which will run from January 24th to March 24th. The Recreation Commission is starting a new girls basketball program.

Councilman Jensen: No report.

Councilman Visconti: The Flood Commission held their meeting. The river restoration project needs approval from the State. We have acquired additional boulders for the project. The Park Committee held their meeting and will be moving forward with fundraising in the next few weeks. He thanked Councilman Kulmala for taking pictures of the area for the LOI. The Water and Sewer Committee met and there was further discussion of sewers.

Councilman Biale: He and the Mayor attended the Senior Club holiday party. The Seniors will hold their end of the year celebration on December 29th at 11 am. The project at the 287 exit ramp is now completed. Councilman Biale advised it has been 10 months since meeting with Rockland Electric about the free LED lights and we still have not received the lights we were

promised for 2016. He advised that someone needs to contact Rockland and get them to move forward. He wished everyone a Merry Christmas and Happy New Year.

Councilman Kulmala: He advised that the new website is wonderful. It is easy to navigate. Residents can submit service requests online. Residents can also subscribe to news alerts. He explained that the Borough is trying to improve communications with the residents. Councilman Kulmala advised that the Fire Department fought two fires recently-one at the Oakland Diner and one on Yawpo Avenue. They did a wonderful job. He reminded residents to shovel around fire hydrants. He thanked the Fire Department for bringing Santa around last Saturday. Councilman Kulmala advised that Bergen County will be the first to use the new FEMA emergency alert system. He wished everyone a Merry Christmas and Happy New Year.

Councilman Talamini: He advised that the Public Events Committee needs more members. The schools will be closed for break. The Board of Education wants to wait for the Commission study on the school election before making a decision whether to move the election. The Board of Health instituted a new fee schedule for septic reviews. Councilman Talamini thanked Councilman Jensen for his time on the Council. He explained that it is an important job and people do not realize the time and effort involved.

On motion of Councilman Biale, seconded by Councilwoman Coira, this portion of the meeting be opened for public discussion.

Ryan Schwertfeger, 58 Andrew Avenue, thanked Councilman Jensen for his service. He congratulated Councilman-elect Knapp. He advised that the new website looks nice. He advised that progress is being made with the dog park and fundraising will begin. He thanked Mr. Kunze and Mr. Chewcaskie for their help regarding the fundraising.

Brian Tully, 26 Calumet Avenue, thanked Councilman Jensen for his service. He asked if there is any news on dispatch. Mayor Schwager advised that a meeting was held to discuss technology.

On motion of Councilman Biale, seconded by Councilman Talamini, this portion of the meeting be closed to public discussion.
