## WORK SESSION:

### SUSTAINABLE LAND USE PLEDGE:

Mr. Kunze explained that in 2011, the Borough adopted by resolution committing the Borough to consider certain factors and take certain actions regarding planning and development that are consistent with smart growth land use principles. Our 2011 resolution was based on the model resolution from Sustainable Jersey. In order to receive points from Sustainable Jersey, we must readopt this resolution. The resolution will be listed on the next agenda.

### PROPOSAL BY AGNOLI ENGINEERING:

Mr. Kunze advised that earlier this year, the Borough was officially notified that it was accepted into the FEMA Community Rating System with a rating of 7. Generally, this will result in a 15% reduction in flood insurance premiums for our homeowners. In order to remain qualified in the program, annual updates are required. This year, FEMA set a deadline of October 15<sup>th</sup>. Agnoli Engineering submitted a proposal to assist with the necessary update. The contract would be not to exceed \$ 5,000.

### APPRAISAL FOR SANDY BEACH PROPERTY:

The Land Conservancy solicited proposals on our behalf to prepare a Green Acres compliant appraisal of the Sandy Beach property. This appraisal is required for our grant application to Bergen County. A contract will be awarded to Joshua Mackoff, LLC for a price of \$ 2,500.

## **COUNCIL REPORTS:**

Councilman Biale: The Senior Center has portable air conditioning units. The August calendar will be coming out tomorrow. Councilman Biale attended the ceremony on Cardinal Drive in commemoration of Lt. Joseph Silva. Councilman Talamini commented that it was a great ceremony.

Councilman Visconti: No report.

Councilwoman Coira: No report.

Councilman Knapp: There was another incident on Rt. 287 in the same place. He commented that the Borough needs to push DOT to do something. Mr. Kunze advised that after the last meeting, he reached out to DOT and is still waiting for a call back. He will reach out to them again. He doesn't know if maybe we should get the legislators involved. Councilman Visconti recommended that we cite the incidents that have occurred.

Councilman Talamini: No report. Councilman Biale questioned if the Board of Education has done anything about school election. Councilman Talamini responded they are still waiting from the report from the State. Councilman Biale advised that if the Board of Education doesn't come back with a decision, he will make a motion for the Council to decide.

Mr. Kunze advised that the Ramapo Indian Hills Board of Education has decided to use their extra aid to reduce the tax levy. Once Bergen County gets their new certificate, they can give us a tax rate.
