MAYORS REPORT:

AUTHORIZE AGREEMENT WITH NORTHWEST BERGEN COUNTY UTILITIES AUTHORITY FOR SEWER TREATMENT PLANT DECOMMISSIONING PROJECT

WHEREAS, this agreement made this 22nd day of June 2022, by and between Northwest Bergen County Utilities Authority, a body politic and corporate, with offices at 30 Wyckoff Avenue, Waldwick, N.J. 07463, ("the AUTHORITY"), and the Borough of Oakland, a municipal corporation of the State of New Jersey, with offices at One Municipal Plaza, Oakland, N.J. 07436, ("the BOROUGH"); and

WHEREAS, the Borough of Oakland presently operates three (3) sewage treatment plants in the Borough of Oakland, which are scheduled to be decommissioned and converted into pump stations; and

WHEREAS, the Borough is constructing sanitary sewer force mains together with fittings and piping to permit certain properties located in the Borough of Oakland to connect into the Authority's sanitary sewage collection system in Franklin Lakes, New Jersey; and

WHEREAS, the Borough intends to construct pump stations and required sewer lines to convey wastewater flow from the Borough of Oakland's three (3) treatment plants to the District Sewer System for the treatment of the wastewater, all in accordance with the terms and provisions of the agreement; and

WHEREAS, the Borough has determined that it is in the best interest of the Borough to enter into an agreement with the Northwest Bergen County Utilities Authority in order to execute the Sewer Treatment Plant Decommissioning Project;
