OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Pignatelli, this portion of the meeting be opened for public discussion.

Frank Monaco, 60 Thackeray, questioned the mail-in ballot application he received. Mr. Chewcaskie responded it seems to have been sent by a political organization and as long as Mr. Monaco doesn't submit the application, he will not receive a mail-in ballot. Mr. Monaco spoke about the crossing guard at Ramapo Valley Road and West Oakland Avenue letting traffic build up because the kids are being crossed on a green light. Mayor Schwager responded she will speak to the Police Captain about this issue. Mr. Monaco also commented on the danger of people not crossing at the crosswalk. He asked about the Stream House. Mayor Schwager responded that we will be able to disassemble the Stream House.

Mayor Schwager advised that the State does not want it rebuilt as a replica. Councilman Biale advised that the State came to Oakland and toured the Stream House building. She thanked Councilman Pignatelli and Councilman Talamini for being a part of the Public Events Committeee.

Frank Monaco, 60 Thackeray, commented that any historic items should be put at the Library because people go to the Library.

Marisol Kozlovski, 19 Barnard Drive, commented that there should be a corssing guard at Franklin Avenue and Rutgers. Ms. Kozlovski advised that she has been a presenter at the Van Allen House for the annual visits by Oakland 2nd graders. It saddens her that the decision has been made to disassemble the Stream House. Mayor Schwager advised that our goal is to make a museum where the Stream House sits. Ms. Kozlovski responded that the foundation should be kept. She advised that several years ago, the roof was leaking during a presentation to the 2nd graders. Now there is mold. The mold needs to be remediated. Mr. Kunze responded that he and DPW Superintendent Marcucilli were not aware of the mold. He will follow up with the DPW to see if there are remedial steps that can be taken. Councilman Kulmala questioned if the roof was still leaking. If so, the DPW should put a tarp over the roof. Mr. Kunze responded that he thought there was temporary patching done on the roof but he will talk to DPW.

WHEREAS, the new law requires the County Prosecutor of each county to designate an Animal Cruelty Prosecutor, and will allow such Prosecutor to investigate, prosecute, and /or take other legal action as appropriate for violations of the Animal Cruelty laws of the State; and

WHEREAS, consistent with N.J.S.A. 4:22-14.1, each municipal Governing Body with a police department is required to designate at least (1) Municipal Humane Law Enforcement Officer who shall be responsible for animal welfare within the jurisdiction of the municipality, and who will enforce and abide by the animal cruelty laws of the state and ordinances of the municipality; and

WHEREAS, Police Captain Keith Sanzari has recommended to the Governing Body that Officer Donald Harvey serve as the municipality's Municipal Humane Law Enforcement Officer;

heretofore introduced, does now pass on first reading, and that said ordinance be further considered for final passage at a meeting to be held on the 7th day of November, 2018, at 7:30 P.M., or as soon thereafter as the matter can be reached, at the regular meeting place of the Borough Council, and that at such time and place all persons interested be given an opportunity to be heard concerning said ordinance, and that the Borough Clerk is hereby authorized and directed to publish said ordinance according to law with a notice of its introduction and passage on first reading and of the time and place when and where said ordinance will be further considered for final passage.

FINAL PUBLIC HEARING: ORDINANCE NO. 18-CODE-767 PROHIBIT RETAIL MARIJUANA ESTABLISHMENTS

The Clerk was directed to take from the table Ordinance No. 18-Code-767 and read by title for its final hearing.

The Clerk then read by title an Ordinance entitled "AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF OAKLAND CHAPTER 59, ARTICLE VII, SECTION 59-45, ENTITLED "REGULATIONS APPLICABLE TO ALL ZONES" BY ADDING SECTION "J".

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Pignatelli, seconded by Councilman Kulmala, this portion of the meeting be open for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

Mame Schwartzfisher, 187 West Oakland, asked if marijuana can be sold in town. Mr. Chewcaskie advised this ordinance is preemptive. It would prohibit business marijuana activites. It does not prohibit a licensed medical dispensary. Ms. Schwartzfisher asked if the Borough would be getting tax dollars for the sale. Mr. Chewcaskie responded that it was his understanding a municipality would only benefit from retail sales which this ordinance prohibits.

CLOSED FOR PUBLIC DISCUSSION:

On motion of Councilman Pignatelli, seconded by Councilman Biale, this portion of the meeting be closed to public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

On motion of Councilman Pignatelli, seconded by Councilman Knapp, the following resolution be introduced, adopted and duly passed on a roll call vote.

BE IT RESOLVED that an Ordinance entitled, An Ordinance Amending The Revised General Ordinances Of The Borough Of Oakland Chapter 59, Article Vii, Section 59-45, Entitled "Regulations Applicable To All Zones" By Adding Section "J", be adopted;

BE IT FURTHER RESOLVED that the Borough Clerk be and she is hereby directed to cause said Ordinance to be published by title in The Record in the manner provided by law.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

WORK SESSION:

AMEND ORDINANCE-ACCESSORY STRUCTURES:

Mr. Chewcaskie advised that we currently have an ordinance to regulate the use of POD's. The Planning Board was made aware that POD's are being used as permanent structures. The Planning Board is requesting the ordinance to be amended so that the permanent use of POD's is not an accessory structure. Councilman Kulmala asked if we are tightening the ordinance on accessory structures. Mr. Chewcaskie confirmed we are tightening the zoning ordinance so that a POD is temporary. This ordinance will be introduced on November 7th.

AMEND SALARY ORDINANCE:

Mr. Kunze explained that the Salary ordinance needs to be amended to include the Information Technology Technician position for the Police Department. This ordinance will be introduced on November 7th.

OLD BUSINESS:

Councilman Kulmala asked for an update on the Patriot's Way Bridge. Borough Engineer John Yakimik advised that the plans are being reviewed by the DOT. He is expecting comments back by mid-November. Once the comments are received, the plans will be revised. It may be ready to go out to bid on January.

Mayor Schwager asked about the road paving in Ramapo River Reserve. Mr. Yakimik advised that tomorrow is the last day of paving.

Councilman Pignatelli commented that a resident came to a previous meeting complaining about a dangerous tree on State property by her house. The resident paid to have the tree taken down. Councilman Pignatelli asked if we can get the State to reimburse the resident. Mr. Yakimik will speak to his contact. Mayor Schwager complimented Mr. Yakimik on being very responsive.

Councilman Kulmala asked the status of the Recreation bathrooms and the demolition of the Roosevelt properties. Mr. Kunze is waiting for final comments from the architect so we can go to bid for the Recreation bathrooms. Mr. Kunze met with Construction Official Dan Hagberg and Mr. Yakimik to discuss the scope of demolition so the bids can be advertised.

COUNCIL REPORTS:

Councilman Knapp: He advised that James Construction is going to clear the Great Lawn at Great Oak Park. The First Aid Squad had 70 calls in September for 140 man hours. Year-to-date they have had 698 calls for 1386 man hours. The Fire Department had 39 calls for 445 man hours. Year-to-date they have responded to 341 calls for 6850 hours. The Fire Department had three members graduate the Fire Academy. The Police Department has responded to 15153 calls for the year-to-date. They have been doing safety checks at the schools. The Police Department does child safety seat inspections. Office Coleman is certified as a Field Training Officer. Sgt. Broek also attended the training as a Field Training Officer. Lt. Keenan attended a leadership program.

Councilman Levy: The Flood Commission did not meet this month. They need two new members in January. The Shade Tree Commission is discussing an arborist to work with the Borough.

Councilman Pignatelli: No report.

Councilman Biale: The Seniors will have a musical performance on November 1st from a DooWop group. November 15th will be bingo at the Senior Center and November 29th will be Movie Day. The DPW completed fire hydrant flushing. Fourteen hydrants were replaced and ten were repaired. DeBlock is doing an outstanding job keeping the sewer treatment plants functional. Councilman Biale reminded residents that leaves and grass must be put in biodegradable bags or containers for pick up. The DPW asked residents to remove leaves from storm drains for the upcoming storm. The DPW has backyard compost bins available for purchase for \$60. The DPW is working on a list of locations for next year's allocation of LED lights. Meetings are being held with vendors for an electronic bulletin board.

Councilman Kulmala: The OCC is looking for volunteers for the tv committee. They are looking for photos and videos from residents to use. Recreation now has lightning detection on Truman and Wells fields.

Councilman Talamini: The Halloween Parade will be held Saturday at 10 am. The event will be held indoors at Valley Middle School in the event of rain. It is a great event. The kids are in costumes, there are pumpkins and crafts as well as refreshments. If the event is outside, there will be a blow up maze. He asked residents to please volunteer for the Public Events Committee. The schools will have a minimum day on Halloween. He asked everyone to be careful of the children on Halloween. The Library Grand Opening was a really nice event. The Levines were honored. The Library looks great. Mayor Schwager advised that the downstairs area of the Library is a perfect meeting place for local organizations.

Mayor Schwager advised that Ramapo Valley Road will be repaved November 8th, 9th and 10th. They had to wait until the pavement settled in order to pave the road.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Pignatelli, seconded by Councilman Levy, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

Mame Schwartzfisher, 187 West Oakland Ave, commented that Gerri Schrier worked very hard for the children's area of the Library.

Marisol Kozlovski, 19 Barnard Way, asked about streets closing in the college section on Halloween. Mayor Schwager responded that this is being done at the request of the Traffic Officer. Ms. Kozlovski commented that people are being directed to park at OLPH but the rain date for their trunk or treat is Halloween.

Councilman Biale commented that it is getting darker earlier and there are a lot of people out walking and not wearing something light and bright and it is dangerous.

Carol Peterson, 195 Seminole Ave, advised that the Borough has been certified at the Bronze level by Sustainable Jersey. She advised that residents took advantage of the Styrofoam recycling event in Glen Rock. Oakland has been approved for a Hub grant so it looks like we will be able to do our own recycling program for Styrofoam.

On motion of Councilman Pignatelli, seconded by Councilman Kulmala, this portion of the meeting be closed to public discussion.
