MEETING ANNOUNCEMENT: Mayor Schwager announced that this meeting is being held in accordance with the Open Public Meetings Law, duly announced, advertised and posted in the Municipal Building. The meeting will adjourn at 10:00 p.m. unless a majority of the Councilmembers that are present vote to extend the time.

MAYOR'S REPORT:

Mayor Schwager thanked the Oakland Public Events Committee for a great Halloween Parade and Trick or Trunk. Mayor Schwager announced that Borough facilities will be closed on Thursday November 11, 2021 for Veteran's Day. Mayor Schwager added that there is a Veteran's Day Ceremony on November 11, 2021 at 10:45 a.m. in Veteran's Park. Mayor Schwager reported that there is garbage collection on November 11, 2021. Mayor Schwager announced that Oakland's water is safe to drink, and the Borough is below the federal standards. A mailer was sent to all residents with the information. The Clerk then read by title Ordinance No. 21-Code-863 entitled: "AN ORDINANCE TO AMEND, SUPPLEMENT AND REVISE THE CODE OF THE BOROUGH OF OAKLAND, LAND USE, CHAPTER 59 ENTITLED "LAND USE AND ZONING"

On motion of Councilman Biale, seconded by Councilman Pignatelli, the following resolution be introduced, adopted and duly passed on roll call vote.

BE IT RESOLVED that an Ordinance entitled, An Ordinance to Amend, Supplement And Revise The Code of The Borough Of Oakland, Land Use, Chapter 59 Entitled "Land Use And Zoning", be introduced;

That said Ordinance be considered for final adoption at a meeting on December 20, 2021 at the Municipal Court/Council Chambers, 10 Lawlor Drive, Oakland, New Jersey at 7:30 P.M.

That said Ordinance be published in full in The Record on or before December 6, 2021 together with notice of this introduction and of the time and place for further consideration for final passage, and that the Clerk post a copy of said Ordinance in the Municipal Building and make copies available to the public.

ROLL CALL: All yeas, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck.

Councilman Van Eck stated that the I-4 Zone from the Breweries and Distilleries Ordinance is missing in the ordinance. Mayor Schwager asked the Borough Clerk to list the various zones in the next meeting packet. The Borough Attorney stated it would be a substantive change and the ordinance must be amended on the floor.

On motion of Councilman Van Eck, and Seconded by Councilman Pignatelli, Ordinance No. 21-CODE-863 was amended on the floor to amend section 4-D to add in breweries and distilleries as permitted uses based on the ordinances at this time.

On motion of Councilman Van Eck, seconded by Councilman Pignatelli, Ordinance No. 21-CODE-863 be introduced as amended.

ROLL CALL: All yeas, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck.

WORK SESSION:

SHADE TREE ORDINANCE:

Councilman Van Eck opened up discussion on the changes to the proposed Shade Tree Ordinance. Councilman Kulmala thanked the Commissioners for working hard on the proposed ordinandee. There was a discussion on lot sizes and septic systems and how that effects tree replacements and mitigation. Councilman Pignatelli suggested removing the appeal process to the Governing Body based on past experience. The decision would be final with the Commission. Section 1-C will be removed from the ordinance. Ms. Krause expressed that impervious surfaces are a problem for stormwater runoff. Councilman Pignatelli asked if pool installations are exempt. Mr. Clark stated that pools are an accessory structure and not reflected in the ordinance. Councilman Van Eck hopes to see the recommended changes on the next agenda for introduction. Borough Attorney Nylema Nabbie will work with Councilman Van Eck to capture the changes as discussed. Mayor Schwager added that the proposed Streetscape Plan will be sent to the Shade Tree Commission for comment and review. If any of the Council Members have additional thoughts, they are invited to contact Councilman Van Eck before the next meeting.

ENGINEERING SERVICES 2022 ROAD PROGRAM:

Borough Administrator Richard Kunze reported that the Borough is preparing for next year's road resurfacing program and Boswell Engineering provided a cost estimate to prepare the design specifications. Councilman Biale expressed concerns that the current-year contractor used base level mix for high-level mix driveways. Borough Engineer John Yakimik responded that the situation will be fixed by the contractor. Mr. Yakimik requested a new schedule for Seminole Avenue and Glen Grey Road and it will be distributed once available. Mr. Yakimik explained that the contractor has been back-logged due to having been awarded a large number of bids in North Jersey. Councilman Van Eck asked if the Borough could use a different mix of asphalt to expand the lifespan of our roads. Councilman Van Eck added that it seems like the asphalt used currently crumbles instead of cracking, and asked if anything could be done about that. Mr. Yakimik added that the NJDOT grants limit the Borough on the type of mix that can be used. Boswell Engineering will look into the different mixes as they move to prepare the final specifications for review.

NEW BUSINESS:

Mayor Schwager expressed concerns about a motor home sitting in the old Oakland Drugs parking lot. Mr. Kunze responded that the Borough is working on the matter with Code Enforcement.

Mayor Schwager brought forth the idea of an Architectural Review Board. Mayor Schwager will provide further information for the next meeting.

Councilman Van Eck stated that the Borough is moving forward with the 'Past Mayor's reframing project and an unveiling date will be announced in the near future.

Councilman Van Eck asked for an update on the Fiber Loop Project. Mr. Kunze added that the final responses from the utilities are pending and hopeful for project completion by the end of the year.

Mayor Schwager has been in contact with Congressman Gottheimer regarding Allerman Brook. Mr. Kunze updated the Governing Body as to the progress of pursuing grant programs to fund the soil stabilization project. Follow up meetings are scheduled for the near future with both agencies involved.

Mayor Schwager asked for an update on the pending funding for Patriot's Way Bridge through the Infrastructure Bill. Mr. Kunze said that the status is unknown and the Borough is following up with the Congressman's Office.

OLD BUSINESS:

COUNCIL REPORTS:

Councilman Van Eck stated that the Recreation Commission is working on an Eagle Scout Project to update the Danny D'Elia Building. The Pee-Wee Football Program is hosting a Championship Game against Ramsey on November 13, 2021. The Communications Commission is always looking for volunteers for the TV Committee and Borough Newsletter. Councilman Van Eck added that the OCC is looking into a TV sponsor program. The next OCC Meeting is January 24, 2021. Councilman Van Eck added that the DPW is awaiting a final schedule for the road program, and the LED sign cabinet design is progressing. Councilman Van Eck wished the public a Happy Veteran's Day.

Councilman Kulmala stated that there is an upcoming Eagle Scout Project to address underbrush around the Great Oak Tree in Great Oak Park. Councilman Kulmala added that the Planning Board is in the process of discussing a Streetscape Plan that includes trees and lighting to uniformly beautify and enhance the Central Business District. The Downtown Development Resolution will be brought forth to the Governing Body and Planning Board in the near future.

Councilman Pignatelli added that the Board of Health hosted a successful Rabies Clinic. Househouse Hazardous Waste Collection is November 13, 2021 at the BCUA. Councilman Pignatelli added that the Environmental Commission met and discussed open space and future plans for projects. Councilman Pignatelli reported that the Sustainable Oakland Green Team is meeting with local business owners to discuss the plastic bag ban going into effect in 2022. Councilman Pignatelli encouraged the public to attend the PFAS Information Session on November 22, 2021. Councilman Pignatelli added that the Senior Center hosted a successful 30th Anniversary Luncheon. Councilman Pignatelli wished the public a Happy Veteran's Day, and encouraged the public to attend the Veterans Day Ceremony on November 11, 2021.

Councilman Biale reported that the Borough will be sending out a letter to the residents on Island Terrace to seek interest in public water. BIDS will be received in November for the Sewer Decommissioning Project. It was reported that the Interior renovations of the Van Allen House are almost complete and a rendering for the Stream House is pending. Councilman Biale encouraged the public to attend the PFAS Information Session on November 22, 2021. Councilman Biale congratulated all of those that ran for Borough Council in the election.

Councilman Talamini reported that there is a Finance Committee Meeting on December 1, 2021. Councilman Talamini congratulated the Public Events Committee on a successful Halloween event. Councilman Talamini congratulated the 11U Gold Baseball Team in their Championship win. Councilman Talamini thanked all of the Election Candidates for putting their name forth and running. Councilman Talamini wished the public a Happy Veteran's Day.

Councilman Slasinski reminded residents that rooms are available to rent at the Oakland Public Library. The Oakland Public Library has passes to the Museum of Natural History to those interested.

Councilman Biale reported that the traffic light at Franklin Avenue and Ramapo Valley Road is out of sync and the Borough Engineer John Yakimik will reach out to the County of Bergen on behalf of the Borough to find a solution. Councilman Van Eck asked to contact the County Representative again. Mr. Yakimik will reach out.

On motion of Councilman Biale, seconded by Councilman Kulmala, this portion of the meeting be opened for public comment.
