REGULAR MEETING OF THE MAYOR AND COUNCIL HELD AT THE MUNICIPAL COURT /COUNCIL CHAMBERS 10 LAWLOR DRIVE, OAKLAND, NEW JERSEY WEDNESDAY DECEMBER 19, 2018

MEETING CALLED TO ORDER: By Mayor Schwager at 7:30 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Knapp, Kulmala, Levy, Talamini. Absent: Councilman Pignatelli. Also Present: Lisa M. Duncan, Borough Clerk; Michael Carelli, Assistant to the Administrator; David Young, CFO.

SALUTE TO THE FLAG:

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MOTION TO EXCUSE ABSENCE:

On motion of Councilman Kulmala, seconded by Councilman Levy, the absence of Councilman Pignatelli be excused.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy.

Councilman Talamini entered at 7:33 pm.

MAYOR'S REPORT:

Mayor Schwager advised that Oakland was more festive this season thanks to Chopper Russo and Mike Rose who chaired the Holiday Lights Committee. Forty-eight homes registered this year. The judging will take place tomorrow night and prizes will be awarded. Mayor Schwager gave an update on the Patriot's Way Bridge. The State is doing emergency repairs. Additional work needs to be done so the timeline for completion has been extended. The anticipated opening of the bridge is January 14th. They are waiting for the decking material to arrive on January 7th before work can be completed. Mayor Schwager attended a ceremony last week at Ramapo College honoring Chopper Russo as one of Congressman Gottheimer's Hometown Heroes. Last year's winner was Mike Guadagnino, Chairman of the Recreation Commission and Park Committee. On December 12th, Officers Martin and Fitzgerald graduated the Police Academy.

RESOLUTION 18-358 HIRE POLICE OFFICER

On motion of Councilman Knapp, seconded by Councilman Biale, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, the Mayor and Council of the Borough of Oakland has determined the need to authorize the hiring of a police officer for the Oakland Police Department based on a vacancy and the current table of organization; and

WHEREAS, the Police Captain has recommended the appointment of Brandon L. VanDerVeen pending the completion of the necessary pre-employment testing and background checks:

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Oakland that Brandon VanDerVeen be and is hereby appointed as a police officer for the Borough of Oakland, which appointment is effective as of December 20, 2018, and being made in accordance with the New Jersey Department of Personnel Certification of Eligibles for Appointment List, and his salary shall be \$40,289 for the Academy step in accordance with the current PBA contract.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Talamini.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Levy, seconded by Councilman Biale, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Talamini.

Frank Monaco, 60 Thackeray, wished everyone a Merry Christmas and Happy New Year. He asked how much the cost is for the bridge. Borough Engineer John Yakimik responded that so far, the cost has been \$ 1. Councilman Levy advised that the State is doing the emergency repairs at their cost.

Michael Pritchard, 23 Calumet Ave, saw an article in the paper that Oakland lost an appeal in Court regarding the Bi-County property. He spoke about the potable water and the watershed being protected by Federal laws. Mr. Pritchard spoke of the Highlands Preservation Act. Oakland is in the Federal Highlands Preservation Act. Mayor Schwager thanked Mr. Pritchard for doing research on this issue. Councilman Biale advised that no one is starting development at this time. The Mayor and Council are in constant discussion with our attorney who is well-versed in land use law.

Dave Richardson, 320 Ramapo Valley Road, advised that the County came to repair the crosswalk on Ramapo Valley Road by Vet's Park. The County said it has been 17 years since Ramapo Valley Road was paved. Mayor Schwager advised that the Borough is at the mercy of the County but we will keep contacting the County. Mr. Richardson advised that the lights are on at the Recreation fields when they are not being used. Mayor Schwager responded that Councilman Kulmala will follow up with the Recreation Commission.

Frank Monaco, 60 Thackeray, commented that Ramapo Valley Road is a Federal, State, County and Municipal Road. Mayor Schwager responded that the road is under the control of the County for maintenance.

Jack Lynch, 14 First Street, asked the status of the abandoned houses on Roosevelt. Borough Engineer Yakimik responded that the Borough Administrator is putting together bid documents. Mr. Lynch advised that the houses have been abandoned for three years and it looks terrible. Councilman Kulmala advised that he had spoken to the Borough Administrator and the project will go out to bid in mid-January. Mr. Lynch expressed concern that when the houses are knocked down, it will become a mud field. Mayor Schwager advised she will speak to Mr. Kunze and update Mr. Lynch with a timeline.

Councilman Kulmala wants new Christmas decorations on the poles in the downtown for next year from 287 to past the Police Station.

COUNCIL REPORTS:

Councilman Talamini: The Public Events Committee needs members. The schools have a minimum day on Friday and then will be closed until January 2nd. He wished everyone Happy Holidays.

Councilman Kulmala: Recreation winter sports are underway. Volleyball signups will be held in January. Recreation will be doing online registration and online bill pay. It will be done on a trial basis for baseball and softball registrations. Councilman Kulmala thanked Fred Birks for all his years of service to the OCC. He wished everyone a Merry Christmas and a Happy New Year.

Councilman Biale: The Oakland Senior Club will hold their holiday party at the Senior Center tomorrow at 12:00. There will be a lunch buffet and entertainment. Bingo will be held December 27th. The Senior Center will be closing January to March to upgrade the Fire Suppression system. He wished all the Seniors a Merry Christmas and a Happy Healthy New Year. Yard Waste collection has ended. The LED light projects is ongoing. We have upgraded 50 fixtures since 2016 along the school routes and intersections. The Police have identified poorly lit spots for the 2019 allottment of LED lights. Christmas trees will be collected for the entire month of January. Councilman Biale wanted to wish his next door neighbor Mikayla a Merry Christmas and Happy New Year.

Councilman Levy: The Shade Tree Commission has advised that ash trees are diseased and should be taken down. The Flood Commission will meet January to March at Borough Hall since the Senior Center will be closed. The Flood Commission is looking for two new members.

Councilman Knapp: The Police Detectives participated in a a knockout opiods discussion. Emergency services participated in the Touch a Truck event in November. For the month of November, the Police Department responded to 220 motor vehicle stops, 66 ambulance calls, 25 Fire calls and 48 motor vehicle crashes. Councilman Knapp congratulated the newly sworn-in officer. The Municipal Alliance met December 10th. They fund many projects including the 8th grade dance and the LEAD program. The First Aid Squad responded to 61 calls in November for 122 manhours. Year-to-date they have responded to 846 calls for a total of 15,000 hours donated. The Fire Department responded to 25 calls in November for a total of 162 hours. Year-to-date, the Fire Department has responded to 415 calls for 8,039 hours. Councilman Knapp wished everyone Happy Holidays and a safe New Year.
