# MOVE TO EXECUTIVE SESSION:

On motion of Councilman Biale, seconded by Councilman Talamini, the following resolution be introduced, adopted and duly passed on roll call vote:

WHEREAS, Section 8 of the Open Public Meetings Act, Chapter 231, P.L. 1975, (N.J.S.A. 10:4-12) permits the exclusion of the public from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances presently exist,

NOW THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Oakland, County of Bergen, State of New Jersey, as follows:

1. The public shall be excluded from discussion of action upon the hereinafter-specified subject matter.

2. The general nature of the subject matter to be discussed is as follows: Easement Acquisition

MEETING CALLED TO ORDER: By Mayor Schwager at 7:30 pm.

ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck. Absent: None. Also Present: Michael Carelli, Deputy Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney; John Yakimik, Borough Engineer.

## MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced that this meeting is being held in accordance with the Open Public Meetings Law, duly announced, advertised and posted in the Municipal Building. The meeting will adjourn at 10:00 pm unless a majority of the Councilmembers that are present vote to extend the time.

## SPECIAL PRESENTATION:

A representative from U.S. Congressman Josh Gottheimer's Office presented a proclamation to Councilman John P. Biale for his many years of service to the Borough of Oakland. The proclamation was read by Deputy Chief of Staff Cheryl Krause. Mayor Linda H. Schwager then presented a proclamation from the Mayor and Council to Councilman John P. Biale. A third proclamation was presented by Mayor Linda H. Schwager from the District 39 Legislators of the State of New Jersey. Councilman John P. Biale expressed his gratitude and thanks to the residents of Oakland and the Governing Body for their support during his years of service. Councilman Biale noted accomplishments such as dismantling of the Stream House, the LED Sign, and sidewalks on the north end of Ramapo Valley Road. Councilman Biale wished Steven Saliani the best of luck.

## MAYOR'S REPORT:

Mayor Schwager congratulated Oakland resident Elizabeth Llorente on receiving the Hometown Hero Award from Congressman Josh Gottheimer. Mayor Schwager added that the 2022 Borough of Oakland Calendar and Information Guide has been mailed to all Oakland residents and businesses and residents should be receiving them in the next few days. Mayor Schwager added that the COVID-19 Testing Center at the Oakland Senior Center has been backed up and asked residents to be patient due to the rise of tests. Mayor Schwager wished all a Happy and Healthy New Year.

## OPENED FOR PUBLIC COMMENT:

On motion of Councilman Biale, seconded by Councilman Talamini, this portion of the meeting be opened for public comment.

ROLL CALL: All yeas, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck.

Chopper Russo of 58 Minnehaha Boulevard stated that the Memorial Day Parade has been passed on to the Oakland Public Events Committee. The American Legion Post Commander has stepped down for 2022. Mr. Russo invited the public to contact the Public Events Committee should they be interested in helping coordinate the Memorial Day Parade. Mr. Russo thanked Michael Carelli for his work on the Borough Calendar.

Riley Zook of 33 Crosby Lane expressed concern about the Ramapo-Indian Hills High School Student Mask Policy. Mr. Zook distributed masks that the students receive in School and noted that on the front of the box it states that the masks do not protect one from virus'. Mayor Schwager added that Mr. Zook should attend a Board of Education Meeting in the near future to bring forth his concerns as the Borough does not have control over Board of Education policies.

Helen Majustick of 824 Ramapo Valley Road asked if the new cannabis ordinance calls for retail in Oakland, and asked if a cost analysis was done to determine how much revenue the Borough would take in.

On motion of Councilman Biale, seconded by Councilman Talamini, this portion of the meeting be closed to public comment.

### APPROVAL OF MINUTES: DECEMBER 8, 2021

On motion of Councilman Biale, seconded by Councilman Pignatelli, the minutes from the Mayor and Council meeting of December 8, 2021 be approved.

ROLL CALL: All yeas, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck.

### APPROVAL OF MINUTES: DECEMBER 8, 2021 EXECUTIVE SESSION

On motion of Councilman Biale, seconded by Councilman Pignatelli, the minutes from the Mayor and Council Executive Session of December 8, 2021 be approved.

ROLL CALL: All yeas, Councilmembers Biale, Kulmala, Pignatelli, Slasinski, Talamini, Van Eck.

### ZONING BOARD APPEAL:

Councilman Eric Kulmala recused himself from the proceedings and stated that the Mayor was more involved in this matter than she should have been. The Borough Attorney Brian Chewcaskie stated that there was a formal appeal by a resident regarding a Zoning Board of Adjustment Approval of a Use Variance to Ellahi Fuel of 357 Ramapo Valley Road, Oakland, N.J. 07436. Mr. Chewcaskie added that the Borough Clerk Lisa M. Duncan obtained and distributed all of the documentation from the Board of Adjustment Application. Mr. Chewcaskie added that 5 official transcripts from the previous Board hearings were obtained and distributed to the Governing Body. Mr. Chewcaskie added that the Governing Body is to not take testimony, but rather review and to evaluate the evidence brought forth from the previous hearings and testimonies. Mayor Schwager stated that she has no vote in the matter and the Governing Body is reviewing the appeal based upon the transcripts and evidence provided. Mayor Schwager added that a use variance goes with the land, and the Borough has no authority if the business sells in the future. Mayor Schwager added that in order to receive the use variance, the applicant had to demonstrate that the use variance is beneficial to the public than what is permissible under the Master Plan. Mayor Schwager added that the Planning Board started a Streetscape Committee in hopes of improving the Central Business District, and in her opinion, the use variance takes away part of that streetscape progress. Mayor Schwager read aloud an official excerpt by Chairman Richard Lepre from the transcripts of the Board of Adjustment Hearing on this matter.

Councilman Grant Van Eck expressed his concerns over the location of the business, and felt that the industrial area is better suited. Councilman Van Eck thanked Tire Tech Auto for their generosity to the community. However, he struggled to understand how the Board of Adjustment came to their conclusions of approval as he feels it is counter to the Master Plan and overall streetscape of Ramapo Valley Road.

Councilman Pignatelli added that he reviewed the official transcripts as well as Mr. Cascio's letter regarding his summation of Ellahi's presentation. Councilman Pignatelli added that the Master Plan states specifically, "automotive related issues should be relegated to other business zones. Therefore, approval would be in conflict with the Planning Board's recommendations." Councilman Pignatelli added that there appears to be a theme repeated throughout this process when deciding when a use variance should be granted, and that is reviewing positive and negative criteria for the variance. Councilman Pignatelli added that he paid attention to statements made by both members of the Board and by the Borough Professionals during the testimony. Councilman Pignatelli added that Mr. Lepre stated, "The question is do you or don't you believe that this particular applicant has met the positive and negative. It is not taking me to the point where I believe that the positive criteria has been satisfied." Councilman Pignatelli added that another Board Member stated, "I would like to help but it is in the wrong place." Councilman Pignatelli stated that he placed a great deal of weight on the testimony that the Borough professionals gave. Councilman Pignatelli read aloud a statement from Borough Engineer John Yakimik, "Nothing was provided considering a future scenario with the widening of Terhune Street." Councilman Pignatelli expressed major concern since this is one of the options to ease congestion along Ramapo Valley Road. Councilman Pignatelli also read aloud a comment from Borough Engineer John Yakimik, "Part of the circulation plan is the connection of Terhune Street to West Oakland Avenue, which is a viable and reasonable future item. Expansion of Terhune Street would comporomise angular parking at the site." Councilman Pignatelli expressed concerns over the Borough Engineer's comments. Councilman Pignatelli stated that he was disturbed over the fact that three Board Members had a negative opinion regarding the approval, but when it came for the time to vote, only one member voted no. Councilman Pignatelli concluded that after much consideration, he is voting yes to reverse the Board's decision to grant the use variance.

Councilman John P. Biale expressed concerns over the Board of Adjustment Board Members' statements during testimony and ultimate votes at the end of the hearing. Councilman Biale read statements from Chairman Richard Lepre and Borough Engineer John Yakimik which echoed Councilman Pignatelli's comments. Councilman Biale explained that the Master Plan dictates how the Central Business District should be built. Councilman Biale added that the applicant is a good neighbor to the Oakland community, but an automotive repair shop is not an ideal for the center of the Downtown.

Councilman Talamini explained that if Ellahi's plan was not counter to the Master Plan, he would not have to go before the Board of Adjustment in the first place, and that is why the Board is there. Councilman Talamini stated that the Governing Body appoints Board members and they should trust those that are appointed to make decisions. Councilman Talamini expressed confusion to the Board members final votes given their testimonies and statements during the hearings. Councilman Talamini added that the site would improve the appearance of the Oakland Drugs property in the short term, and can see where the applicant is coming from as the building has been vacant and run down for years.

Councilman Slasinski echoed Councilman Talamini's statement and added that Mr. Elahi has been a good neighbor. Councilman Slasinski expressed confusion over the Board of Adjustment members' final votes. Councilman Slasinski added that the Borough is trying to beautify the Downtown and this is counter to the Master Plan.

Mayor Schwager read aloud the opinion of the Borough Traffic Officer during the use variance application hearing. Mayor Schwager addressed Councilman Kulmala's comments and added that she does have a special interest because an automotive garage is not suited for the center of Downtown Oakland. Mayor Schwager added that she drives through town everyday and noted the excess of trucks last year in the Oakland Drugs parking lot. Mayor Schwager concluded that she read all of the documents and was shocked at the Board's conclusion.

Councilman Talamini asked whether the Governing Bodies decision is final in the matter. Borough Attorney Brian Chewcaskie responded that four of five present members of the Governing Body are required to take appropriate action.

WHEREAS, the Borough simultaneously secured a protective order providing Oakland immunity from all exclusionary zoning lawsuits while it pursues approval of its HEFSP, which is still in full force and effect; and

WHEREAS, the Court also appointed Elizabeth McManus, PP, AICP as the Special Court Master (hereinafter the "Court Master"), as is customary in Mount Laurel matters adjudicated in the courts; and

WHEREAS, with assistance from the Court Master, Oakland and Fair Share Housing Center (hereinafter "FSHC") engaged in good faith negotiations, which resulted in the entering into a Settlement Agreement between the Borough and FSHC on August 11, 2020; and

WHEREAS, a fairness hearing was held on December 1, 2020, at which time the FSHC Settlement Agreement was approved, and said approval was later memorialized by an Order entered by the Court on December 16, 2020; and

WHEREAS, as per the terms of the August 11, 2020 FSHC Settlement Agreement and the Court's December 16, 2020 Order, the Borough's planner prepared a HEFSP, which was reviewed by the Planning Board; and

WHEREAS, the HEFSP has been amended, which amended HEFSP was reviewed by the Planning Board and is attached hereto as Exhibit A; and

WHEREAS, upon notice duly provided pursuant to <u>N.J.S.A.</u> 40:55D-13, the Planning Board held a public hearing on the amended HEFSP on December 9, 2021 and adopted the amended HEFSP on that same day; and

WHEREAS, the Borough Council of Oakland wishes to endorse the amended HEFSP.

Councilman Pignatelli stated that he would like to make it a priority to install Electric Vehicle Charging Stations in the Central Business District in anticipation of all of the Federal Funding coming through New Jersey. Borough Administrator Richard Kunze added that Michael Carelli is working with the Sustainable Oakland Green Team researching potential types of chargers and pricing. Councilman Pignatelli made it a point to have a presentation to the Borough Council in February 2022.

## OLD BUSINESS:

Councilman Pignatelli would like to hold another Traffic Study Meeting with the Borough Professionals and further research the bypass route at Terhune Street. The Borough Administrator and Borough Engineer will schedule a meeting in the near future.

Councilman Van Eck asked the status of the new Council frames. It was determined that an uncovering ceremony be held at the Oath of Office Meeting on January 2, 2022 and the Past Mayors and their families be invited for the uncovering.

Councilman Talamini asked about the status of Phase III of the Floodplain Buyout Program. Borough Administrator Richard Kunze advised that we are awaiting final appraisals. Councilman Kulmala asked on the status of the demolition of the homes on Roosevelt Boulevard. Borough Administrator Richard Kunze advised that the Borough will be out to public bidding soon, and will work with the Fire Department for use for field training.

Councilman Biale asked the status of the Allerman Brook project. Borough Administrator Richard Kunze advised that the Borough is proceeding with two funding opportunities through FEMA and the Department of Agriculture.

Councilman Kulmala asked the status of the Federal Funding for Patriot's Way Bridge. Mayor Linda H. Schwager advised that she is meeting with U.S. Congressman Josh Gottheimer tomorrow about the funding on site.

#### COUNCIL REPORTS:

The Communications Commission is seeking new members for 2022. Councilman Van Eck advised that the Shade Tree Commission is working on final amendments to the proposed ordinance.

Councilman Kulmala congratulated Councilman Biale for his many years of service to the community. Councilman Kulmala advised that the Planning Board of hearing a subdivision of 363 Ramapo Valley Road, Oakland, N.J. 07436, and the Board reviewing the Cannabis ordinance. Councilman Kulmala thanked all of the Committees and First Responders for a great 2021.

Councilman Pignatelli congratulated Councilman Biale for his years of service and accomplishments. Councilman Pignatelli read the call totals for the First Aid Squad. Councilman Pignatelli encouraged the public to get their flu shots and COVID-19 vaccinations.

Councilman Slasinski congratulated Councilman Biale for his many years of service to the community. Councilman Slasinski added that the Library is reminding the public about renting of shared spaces and digital library is available online.

Councilman Talamini congratulated Councilman Biale for his years of service and giving his everything to the community. Councilman Talamini thanked the Public Events Committee for a successful Christmas Tree and Menorah Lighting Ceremony.

Councilman Biale thanked all the Borough Council Members for their kind words. The North end Sidewalks project is proceeding shortly and working on easements. The signal box at the LED

Bids were received for the Sewer Decommissioning Project, with the apparent low bidder being higher than the Borough Engineer's Estimate. The Iroquois Pump Station Project bid will be awarded in late January. The Patriot's Way Bridge remains safe for pedestrian and vehicular traffic.
