MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MAYOR'S REPORT:

The Public Events Committee did a super job for the Tree and Menorah Lighting on December 2nd. She thanked Councilman Pignatelli for being Master of Ceremonies. There was food and entertainment and everyone had a good time. On the day after Thanksgiving, Mayor Schwager, Chopper Russo and a handful of people decorated Oakland's tree for the Van Saun Park Winter Wonderland. She commented that one of the other towns had handmade ornaments. We will have Oakland children make the ornaments for next year's tree. Mayor Schwager congratulated Chopper Russo who received Congressman Gottheimer's Hometown Hero award. There will be a ceremony on December 14th at Ramapo College's Trustee Pavillion. Chopper Russo and Mike Rose are co-chairs for the Holiday Decorating Committee. The deadline to enter the house decorating contest is December 20th. Mayor Schwager advised that there are a lot of openings on various Boards, Commissions and Committees such as Planning Board, Flood Commission, Communications Commission and Public Events Committee.

OCC Chairman Ryan Schwertfeger explained that the OCC wanted the logo to reflect Oakland by using an Oak tree. The proposed logo is the same font and colors as the Borough's website. Councilman Talamini advised that he showed this logo to people and they didn't see the O because of the oak tree. They thought it said Ackland. Councilman Biale asked if there are other models of the logo. Mr. Schwertfeger advised that there are other versions which are similar except for the size of the oak tree. He thanked the Shop Rite and all the vendors. The Public Events Committee needs members.

Councilman Kulmala: The OCC is doing wonderful work. They still need volunteers for the tv committee and the newsletter. Recreation winter sports are ready to start their season. There will be signups for baseball and volleyball by the beginning of the new year. The new netting is going up at the Recreation field. There was a pre-bid meeting on December 3rd for the Recreation bathroom project. The bids will be opened December 18th.

Councilman Biale: The Bergen County Clerk will speak at the Oakland Senior Center regarding the County discount cards. The Seniors will have a presentation on December 14th from Merrill Lynch regarding Estate planning. The Seniors Holiday Party will be held December 20th. The

Senior Center will be closing from January to March for the installation of the new fire suppression system. He thanked Councilman Knapp for his donation of a painting done by Fran Kendall to the Senior Center. The final days of yard waste pick up will be Monday December 10th and Tuesday December 11th. The DPW has advised that Christmas trees will be picked up on a random basis through the month of January. The DPW asked residents to clear leaves from storm drains on their property. This will alleviate ponding and dangerous icing issues.

Councilman Pignatelli: He was not able to attend the Board of Health meeting. He did attend the Environmental Commission meeting. They are looking at a program through ANJEC for a self-examination and rating checklist. Councilman Pignatelli thanked the entertainers for the Tree and Menorah Lighting ceremony and he thanked Chopper Russo and Mike Kozak for all their hard work.

Councilman Levy: The Shade Tree Commission has advised that all Ash trees are diseased. They are working with the County to see if they can remove the trees by the County road. Mayor Schwager asked if an announcement can be put on Facebook with pictures of an Ash tree so residents know what it looks like. Councilman Levy advised that the Flood Commission will need two new members in January. The Flood Commission will meet at Borough Hall from January to March while the Senior Center is closed.

Councilman Knapp: The Fire Department will be bringing Santa around town on December 15th. It is a rain or shine event. The Fire Department will collect toys for the PBA toy drive. The clearing of Great Oak Park continues. The next meeting of the Park Committee will be December 18th. He asked residents to please clear snow and debris from fire hydrants.

Councilman Biale advised that the Knights of Columbus will present donation checks tonight to the Oakland Fire Department, PBA, First Aid Squad and the Paterson PBA.
