INTRODUCTION: ORDINANCE NO. 20-CODE-818 COMMUNITY GARDEN FEE Discussion ensued over how many plots were available. Councilman Van Eck stated that some plots are year-round and asked why the price was not higher for these plots. He questioned the Borough's expense to maintain this going forward because he wants to ensure the fee is a reasonable amount. Mr. Kunze advised that this should generate enough revenue for operating costs and ongoing maintenance. Councilman Pignatelli thinks the only cost is for water. Mr. Young advised that the Borough's expenses are for water and capital costs to replace the fence in the future. Councilman Van Eck thinks the year round plots should have a fee of \$ 75. Mr. Chewcaskie advised that the Council should introduce the ordinance. If there is not a satisfactory response to Councilman Van Eck's questions, it does not have to be adopted. Otherwise, this ordinance will have to wait until January.

The Clerk was directed to take from table Ordinance No. 20-Code-818 and read by title for its first reading.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Pignatelli, Talamini, Van Eck.

WORK SESSION:

2021 CALENDAR:

Michael Carelli, Assistant to the Administrator, advised that this year the calendar will be a little different format. It is more concise and easier to read. This year we have decided to combine the calendar with the Recycling newsletter to save paper and save cost. Councilman Kulmala advised the public that the Oath of Office meeting will be Wednesday January 6th. He commented the calendar looks terrific. Councilman Talamini asked the cost. Mr. Carelli responded that he has collected \$ 9,000 in advertising fees and the calendar cost is \$ 5,600.

BOSWELL PROPOSAL-STORMWATER POLLUTION PREVENTION PLAN

Mr. Kunze advised that earlier this year, the DEP enacted changes to the stormwater management regulations. It affects two areas. One is land use and the Council will see a draft ordinance based on the model ordinance by the first meeting in January. It has be adopted by early March. The other element is how permit requirements will change. The Borough is required to have a plan and our plan needs updating. Borough Engineer John Yakimik advised that the DEP is going to require additional items in the plan. The cost to the Borough is for Boswell's work on the plan. This will also require additional record keeping by the DPW and more public notifications. He spoke of the need to map outfalls and stormwater management facilities and estimating runoff. Mr. Yakimik advised that the plan must be updated by March 2021.

Mr. Yakimik spoke about the municipality's responsibility to map and locate private stormwater management systems and report them to the DEP. Councilman Kulmala asked if there will be a cost to the Borough for these private systems. Mr. Yakimik responded it will fall on the municipality eventually to inspect these systems. Councilman Kulmala stated this is another unfunded mandate by the State. Mr. Kunze responded that the State would say it doesn't meet the requirement to be an unfunded mandate because this is a regulation not a law. Councilman Talamini asked if the fees can be pushed to the private owners. Mr. Yakimik responded that we should be able to. He stated the zoning officer would send a letter stating the private entity must maintain their system and they would have to set up an escrow if the services of the Borough Engineer was required. Councilman Pignatelli advised that if the stormwater basins are not maintained, vegetation grows and impedes the flow of water. Mr. Yakimik advised that the Borough has this situation at the storm basin on West Oakland Ave. Mr. Kunze advised that a resolution will be listed on the next agenda.

FEE WAIVER FOR OUTDOOR DINING BUILDING PERMITS:

Mr. Kunze advised there are different requirements for outdoor canopies and tents for winter due to snow load. A building permit is required or an operation plan must be submitted. The Borough received request from a restaurant to waive the building permit fee. He asked if the Council wants to support the restaurants and waive the building permit fee. He reminded the Council they can only waive the Borough fee not the State fee. The cost will vary by location based on the value of construction. The current request is for a fee of \$ 200. Mr. Kunze also

advised that the current outdoor dining resolution expires at the end of the year. If the Council wishes to extend it, a resolution must be done on the next agenda. Councilman Knapp advised that the Governing Body all support the businesses so he would make a motion to waive the fee. Councilman Talamini asked what the largest fee would be. Mr. Kunze commented that Cenzino's fee is \$ 200 so you can judge by the size of the structure. Councilman Talamini asked if it should be capped at \$ 1000. Mayor Schwager stated the Council has to talk about extending outdoor dining. Councilman Biale suggested extending outdoor dining to the end of the first quarter of 2021. Mr. Kunze advised a resolution can be done at the next meeting. Mr. Chewcaskie advised it must be ratified and confirmed at the Reorganization meeting as well. The Council consented.

NEW BUSINESS:

Councilman Talamini asked the CFO to discuss the bond sale. Mr. Young advised that the Borough conducted a bond sale and 8 bids were received. The Governing Body has been given a full report from the Bond Counsel. The net interest rate is 1.578%. The cash will be here tomorrow.

Councilman Van Eck stated a number of municipalities have adopted ordinances for breweries and wineries. He will bring this idea up to the Planning Board to allow this type of business in different zones. He thinks it would be good for this type of business to come to Oakland. Mayor Schwager asked about the liquor license. Mr. Chewcaskie responded that certain licenses are issued by the State. A brew pub which served food would require a liquor license. A brewery would be issued a State license. Councilman Van Eck advised that this industry has exploded in the past ten years. Councilman Biale felt the size of the brewery should be limited. Mr. Chewcaskie advised this would be permitted by zoning ordinance.

COUNCIL REPORTS:

Councilman Van Eck: He congratulated Ryan Schwertfeger for being named Hometown Hero by Congressman Gottheimer. Ryan will receive his award December 15th. Planning Board will meet tomorrow and will memorialize the Oakland Diner application. Shade Tree Commission met Monday. They are looking into a number of things including a revised tree ordinance. Recreation has been quiet. Since the Governor pushed back ice hockey, the roller hockey program grew as a result. The OCC has openings for volunteers. They are working on installing equipment in the tv control room. Oakland TV will incorporate local original music as background for the bulletin board. The next meeting of the OCC will be January 11th at 7:30 pm.

Councilman Talamini: The schools thanked Recreation for their cooperation in regards to the use of the facilities for winter sports. There are Covid cases at all schools. Heights and Dogwood will go virtual until December 23rd. Manito goes back to school tomorrow after two weeks of virtual. Valley Middle school and Indian Hills are hybrid. The Covid cases were not school related and were probably from Thanksgiving. The Library has seen people coming in wearing masks but then take them off while they are inside the Library. If this continues to happen, the Library will have to close sections to the public becaue people are not following CDC guidelines. Councilman Talamini thanked Mr. Young and the Finance Department for their hard work preparing for the bond sale. Councilman Talamini advised that a speed sign was put in front of his house five years ago and it does slow people down. He suggested the Borough could get grants for more signs for Glen Gray.

Councilman Pignatelli: There is a vacancy on the Environmental Commission. Anyone interested should contact secretary Michael Carelli to fill out a Citizen Leadership form. The Board of Health will meet December 15th.

Councilman Kulmala; The Shade Tree Commission is still looking for two members. They are still working on the Adopt a Tree program. They are seeking RFQ's for tree pruning.

Councilman Knapp: Spoke of fundraisers for the Dog Park. On Monday December 21st, Oakland Diner will donate 20% of sales to the Dog Park. Chocolate Etc. is donating 10% of proceeds on Saturday February 6, 2021.

Councilman Biale: The Senior Center is working on winter hours until February 26th. They are open Monday to Friday from 9 to 2 pm. There is a mix of in-person, zoom and hybrid programs. Pre-registration is required for in-person programs. The Book Club will begin with a hybrid format. The first meeting will be December 16th. Line Dancing has been postponed to January. Ipads are available for Senior Center members to borrow in the Senior Center only. Weekly shopping trips have resumed. There is a new Books to Go program weekly on Tuesdays where Library materials will be delivered and picked up. Councilman Biale congratulated Senior Center Director Arielle Preciado on the birth of her baby girl on Thanksgiving Day. The DPW advised that yard waste pick up program is over as of December 8th. It will begin again in April. Christmas trees will be collected curbside during January. The 2020 Road resurfacing program is complete and they are working on the list for the 2021 program. The quarry will limit production in the winter so residents should report potholes now to the DPW. There was a productive meeting today with representatives from the three different sewer areas. There will be another meeting next week. The Stream House is completely gone and the contractor is covering the foundation with roof material. Councilman Biale will talk to members of the Oakland Historical Society to discuss plans to replace the Stream House.
