### MAYOR'S REPORT:

The Mayor reported that:

April 5<sup>th</sup> to 29<sup>th</sup> is the Annual Art Show Exhibit displayed at the Library. Reception will be held on Saturday, April 14<sup>th</sup> from 1pm to 4pm.

April 24<sup>th</sup> the Senior Center will Celebrate Josefine Berkowicz's 103rd birthday and selected Goodwill Ambassador, Angelo Chiusano.

June 2018 eligible NJ residents will receive new Medicare cards in the mail.

April 21st Oakland will sponsor a town wide cleanup between 9:00am – 12:00pm.

Rain date April 22<sup>nd</sup>. Lunch will be served at Steward Park. She thanked Copper Russo for covering the expense of advertising the event by flyer.

April 29<sup>th</sup> Van Saun Park will offer free admission for Autism Awareness month. May 12<sup>th</sup> the Borough will sponsor a Paper Shredding Event for all residents between 9:00am to 1:00pm.

Mayor Schwager expressed her gratitude to the Japanese Day School for inviting her to their opening ceremony.

#### PROCLAMATION: SIKH AWARENESS MONTH

Mayor Schwager welcomed members of the Guru Nanak Mission and congratulated them on the grand opening of their new temple. She read a proclamation in honor of Sikh Awareness Month. She invited any of the members to come up and share some background on their heritage.

#### RESOLUTION 18-182 APPROVE SIDEBAR AGREEMENT WITH PBA

WHEREAS, the Oakland PBA Local No. 164, (hereinafter "the Union") is the local union representative for all patrol officers, sergeants, lieutenants and captains of the Borough of Oakland Police Department; and

WHEREAS, the Borough of Oakland and the Union entered into a sidebar agreement on January 11, 2007 setting forth the distribution schedule for dispatching services overtime; and

WHEREAS, the parties' have negotiated a new overtime distribution schedule for dispatching services as set forth in the attached sidebar agreement; and

WHEREAS, the newly negotiated and agreed to sidebar agreement for overtime distribution for dispatching services shall repeal and replace the prior January 11, 2007 sidebar agreement; and

WHEREAS, the Union ratified and executed the new sidebar agreement on March 26, 2018; and

WHEREAS, the Borough of Oakland is desirous of ratifying and executing the sidebar agreement; and

NOW, THEREFORE BE IT RESOLVED that the Borough Council of the Borough of Oakland hereby ratifies the sidebar agreement between the Borough of Oakland and PBA Local No. 164 which repeals and replaces the January 11, 2007 sidebar agreement setting forth the distribution of overtime for dispatching services and further authorizes the Mayor to execute the sidebar agreement on behalf of the Borough.

#### **RECREATION BUDGET:**

Mr. Michael Guadagnino, Recreation Commissioner, and Mr. Neil Malmud, Treasurer, gave an overview of their 2018 budget to the Council. Mr. Malmud explained that due to a decline in enrollment, there will be a reduction in their budget of 6%. In addition, there will be a decrease in the wages for Summer Counselors due to entry level hires. They're in the process of implementing online registration and payments and this year, Recreation will offer an option to extend summer camp for an additional two weeks into August.

Mr. Malmud discussed upcoming events and additions to Veteran's Park such as a 9/11 monument display containing a piece of the steel from the World Trade Center. He explained that improvements need to be made to the golf field, field safety nets and the roller hockey rink. A discussion ensued concerning the use of grant money and the help of the Council's Grant Committee.

Councilman Kulmala and Councilman Talamini expressed their appreciation for the dedication and hard work that goes into Recreation Program.

## RESOLUTION 18-186 SUPPORT FOR CDBG FUNDING

On motion of Councilman Knapp, seconded by Councilman Biale, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, since 1974, the United States Congress, through the Community Development Block Grant Program, supported the future welfare of the Nation and the well-being of its citizens through maintaining viable urban communities as social, economic and political entities; and

WHEREAS, said Program has been and continues to be a critical affordable housing, community and revitalization tool for families and communities across the nation; and

WHEREAS, the President's Fiscal Year 2018 budget proposes the total elimination of the Community Development Block Grant Program; and

WHEREAS, the broad spectrum of activities, including homeownership opportunities; elimination of slum and blight; housing rehabilitation; improvement to public facilities and infrastructure, such as roads, water and sewer systems, libraries, fire stations, and community centers; and public services, such as employment training, child care, transportation services, services for senior citizens, the disabled and youth; business development and job creation will no longer be able to be undertaken; and

WHEREAS, such action will no longer enable cities, counties and states to meet their community development, affordable housing and economic development needs; and

NOW, THEREFORE, BE IT RESOLVED that the Governing Body of the Borough of Oakland hereby requests your help to fight to save the Community Development Block Grant Program and maintain this vital program within the U.S. Department of Housing and Urban Development at a funding level no less than formula funding in Fiscal Year 2017.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the entire New Jersey Congressional Delegation, the Unites States Senate Committees on Appropriations and Budget and House Committees on Appropriations and Budget.

RESOLUTION 18-187 OPPOSE PROPOSED GUIDELINES FOR BEEKEEPERS On motion of Councilman Knapp, seconded by Councilman Biale, the following resolution be introduced, adopted and duly passed by roll call vote:

WHEREAS, the New Jersey Department of Agriculture has published new beekeeping regulations in the New Jersey Register; and

WHEREAS, these new regulations include a section on Apiary Standards which states that bee colony density will be regulated as follows: on a residential lot of less than one-quarter acre where agriculture has not otherwise been determined as permitted new (not already in existence) hives are not permitted; on a residential lot of less than one-quarter acre where hives are in existence as of July 31, 2015, the hobbyist beekeeper may seek a waiver; on a residential lot of one-quarter acres to less than five acres, a person wishing to keep bees as a hobbyist may seek a waiver to keep two hives per lot; and

WHEREAS, these new regulations also include a section on Location of Hives, which requires that all hives must be located at least 10 feet from any property line and at least 25 feet from any roadside, sidewalk, or path and 85 feet from any public place including playgrounds,

sports fields, schools or churches, unless permission is granted for educational or research purposes, as well as establishing a Flyway Barrier at least six feet in height consisting of a solid wall, fence, or dense vegetation parallel to the property line and extending 10 feet beyond the colony in each direction; and

WHEREAS, these new regulations ignore key best management practices for beekeeping, and would be difficult for the vast majority of New Jersey Municipalities to enforce; and

WHEREAS, the New Jersey Beekeepers Association has notified the Mayor and Council of the Borough of Oakland that if these new regulations are adopted, several beekeepers in the Borough of Oakland will immediately be in violation of the new regulations; and

WHEREAS, the Borough of Oakland believes that bees, and Oakland residents who are beekeepers, are beneficial to the Borough and that those residents in the Borough of Oakland who are currently beekeepers as hobbyists should be able to continue to have bee hives.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Oakland that the Mayor and Council of the Borough of Oakland wish to go on record with the New Jersey Department of Agriculture that the Borough of Oakland is opposed to the new beekeeping regulations which would have a detrimental effect on beekeeping in the Borough of Oakland as well as throughout New Jersey and urges the New Jersey State League of Municipalities to work toward creating legislation with straightforward regulations based on fact, science and best management practices which will protect both beekeepers and non-beekeepers within the State of New Jersey.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be provided to the New Jersey State League of Municipalities, the New Jersey Beekeepers Association; and the Borough of Oakland's legislative team urging them to oppose the adoption of the new beekeeping regulations as proposed by the New Jersey Department of Agriculture.

WHEREAS, a sustainable community seeks to optimize quality of life for its residents by ensuring that its environmental, economic and social objectives are balanced and mutually supportive; and

WHEREAS, the Borough of Oakland strives to save tax dollars, assure clean land, air and water, improve working and living environments; and

WHEREAS, the Oakland Environmental Commission is a participating member of the Association of New Jersey Environmental Commissions (ANJEC); and

WHEREAS, The Oakland Environmental Commission would like to have a formal trail guide made with diagrams to help explain the geology and ecology of Stewart Woods Park. The guide will correspond to the 9 stations already marked along the trail; and

WHEREAS, the ANJEC small grant of \$1500 to support projects that advance local open space stewardship, and help to raise the profile of the environmental commission in the community through publicity and public participation or collaboration with local groups on the project.

THEREFORE, the Borough of Oakland has determined that the Borough should apply for the aforementioned Grant in the amount of \$ 1500;

THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Oakland, State of New Jersey, authorize the submission of the aforementioned ANJEC Grant Application for Open Space Stewardship Projects.

#### WORK SESSION:

### ORDINANCE REGULATING CHICKENS:

Mr. Chewcaskie described the current ordinance and discussed plans to amend it. He referenced two sample ordinances from West Milford and Totowa. He advised that the West Milford ordinance best describes what Council intended by allowing no more than 6 hens on less than a half-acre of property and housing for the chickens would need to comply with the zoning requirements. Council discussed which department should regulate and enforce the housing of chickens. The consensus was that the Health Department should be the one to issue permits, enforce and regulate housing chickens due to health and sanitary reasons. Mr. Kunze informed Council that he would distribute the ordinance to the appropriate departments and get their feedback.

#### **NEW BUSINESS:**

Mr. Kunze informed Council that next month there will be two resolutions for Open Space for the Green Acres Project Agreement and The Land Conservancy for Land Conservation Agreement.

Councilman Kulmala questioned the viability of supplying dumpsters for residents to drop off their comingled recycling. A discussion ensued concerning the recycling center in Franklin Lakes and a possible financial benefit to the town if Oakland had its own. Mr. Kunze responded that there may be in issue with space. Mayor Schwager suggested that there be a discussion with Franklin Lakes, Anthony Marcucilli and Eugene McMahon on the possibilities.

### COUNCIL REPORTS:

Councilman Knapp reported that April 8<sup>th</sup> -14<sup>th</sup> is National Public Safety Telecommunicator's Week. He read a tribute to telecommunicators. He expressed that Telecommunicators should be appreciated for such a job intensive position.

Councilman Levy reported that Shade Tree met last week, April 3<sup>rd</sup>. They plan to have an Arbor Day Program April 27<sup>th</sup>. Flood Commission had a meeting last Monday, April 9<sup>th</sup> and two of the members are retiring and stressed a need for volunteers. In addition, anyone is interested in

lowering their insurance cost should contact the Flood Commission. Station Park Committee met Tuesday, April 10<sup>th</sup>.

Councilman Pignatelli reported that the County is sponsoring a Hazardous Waste Collection Event in Mahwah on Saturday, May 12<sup>th</sup> and July 21<sup>st</sup>, Paramus on Sunday, April 15<sup>th</sup>, June 24<sup>th</sup> and October 14 to dispose of things like paint and motor oil. Saturday, April 14<sup>th</sup> at 9:00 a.m. they plan to clean up and spread woodchips at Stewart Wood Park and Saturday, April 21<sup>st</sup> is the Town Cleanup from 9:00 a.m. to 1:00 p.m. Meet up place will be Valley Middle School. At the Environmental Commission meeting they discussed the Sandy Beach property.

Councilman Biale reported that the Annual Art Show Exhibit will be displayed at the Library between April 5<sup>th</sup> to 29<sup>th</sup> and a reception will be held on Saturday, April 14<sup>th</sup> from 1:00 p.m. to 4:00 p.m. April 24<sup>th</sup> at the Senior Center there will be a celebration for Josefine Berkowicz's 103rd birthday and Angelo Chiusano is being selected as the Goodwill Ambassador. He thanked Sue Trentecoste and Anthony Marcucilli on their efforts arranging for the installation of LED lighting for street lights throughout the town and with the help of future grants, hopefully more LED lights can be installed.

Councilman Kulmala reported that at the last Library meeting they discussed improvements involving alternate entrances and HVAC unit. At the Communications meeting, they discussed the use of Twitter. Communication Commission can use more volunteers. There is a Water/Sewer meeting scheduled April 20<sup>th</sup> at 8:30 a.m.

Councilman Talamini reported Public Events still needs volunteers and thanked Chopper Russo for advertising, at his expense, flyers for the Town Cleanup. At the Public Events meeting they discussed things they would like to improve for the next Easter Egg Hunt. Spring Break was cut short this and students will return to school Thursday.

## OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Knapp, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli, Talamini.

Mr. Eric Kamm, 9 Greene Way, informed Council that the Environmental Commission had a positive meeting discussing that they are in favor of the town acquiring Sandy Beach property and the possible uses for the property. He went on to suggest the different uses for the property.

Mr. Steve Saliani, 5 Saratoga Way, expressed that he supports what Eric Kamm expressed and believes that acquiring Sandy Beach would give the children an opportunity for more field space.

Mr. Chewcaskie informed Mr. Kamm and Mr. Saliani that someone from the Council will be reaching out for further communication concerning the property.

Mr. Michael Guadagnino expressed that he too is in favor of the acquisition of Sandy Beach for reclaiming Green Space and turning it into sport fields for soccer, baseball, softball and lacrosse. A great project may possibly be an indoor facility.

Councilman Pignatelli expressed that the Borough is fortunate to have up to 30 percent Green Space and that the space would be a prime opportunity to add fields for different sports. He assured them that they are working on the acquisition.

Mr. Deter Kamm, 8 Hopi Court, expressed that he too favors the plan for the Borough to acquire the property.

Mayor Schwager informed the public that work behind the scene is being conducted and they will report back when they have an answer.
