WHEREAS, while it is commendable that legislation is being considered to provide additional compensation to Firefighters with cancer, S-716 as currently written, without responsible amendments, will prove to be very expensive to municipalities and taxpayers, and

WHEREAS, while it is also commendable that the statute of limitations is being extended for claims involving sexual abuse, S-477 as currently written would eliminated the statute of limitations entirely leaving officials and volunteers with the near impossible task of defending a claim that is decades old.

WHEREAS, under current law family members can already collect substantial compensation for actual losses such as medical bills, lost income as well as loss of companionship.

WHEREAS, without appropriate amendments, the combined impact of these bills would devastate local government insurance budgets at a time when the local taxpayers are being squeezed because of changes in the Federal Tax code.

"BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS IN, BY AND FOR THE BOROUGH OF OAKLAND, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUME OF \$2,995,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS"

Heretofore introduced, does now pass on first reading, and that said ordinance be further considered for final passage at a meeting to be held on the 25th day of July, 2018, at 7:30 pm, or as soon thereafter as the matter can be reached, at the regular meeting place of the Borough Council, and that at such time and place all persons interested be given an opportunity to be heard concerning said ordinance, and that the Borough Clerk is hereby authorized and directed to publish said ordinance according to law with a notice of its introduction and passage the first reading and of the time and place when and where said ordinance will be further considered for final passage.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Levy, Pignatelli.

INTRODUCTION: ORDINANCE NO. 18-CODE-772 amend

The Clerk was directed to take from table Ordinance No. 18-Code-772 and read by title for its first reading.

The Clerk then read by title Ordinance No. 18-Code-772 entitled: "AN ORDINANCE TO AMEND, SUPPLEMENT AND REVISE THE CODE OF THE BOROUGH OF

OAKLAND, CHAPTER 59 ENTITLED "LAND USE AND ZONING, ARTICLE VII, "ZONING", TO ESTABLISH A CONDITIONAL USE IN THE INDUSTRIAL-1 ZONE"

On motion of Councilman Levy, seconded by Councilman Biale, the following resolution be introduced, adopted and duly passed on roll call vote.

BE IT RESOLVED that an Ordinance entitled, An Ordinance To Amend, Supplement And Revise The Code Of The Borough Of Oakland, Chapter 59 Entitled "Land Use And Zoning, Article VII, "Zoning", To Establish A Conditional Use In The Industrial-1 Zone, be introduced:

That said Ordinance be considered for final adoption at a meeting on August 22, 2018 at the Municipal Court/Council Chambers, 10 Lawlor Drive, Oakland, New Jersey at 7:30 P.M.

That said Ordinance be published in full in The Record on or before August 10, 2018 together with notice of this introduction and of the time and place for further consideration for final passage, and that the Clerk post a copy of said Ordinance in the Municipal Building and make copies available to the public.

Councilman Pignatelli commented that he is not in favor of billboards in town but the Attorney advised that we currently prohibit billboards and that is unconstitutional. If we do not allow at least one zone that allows billboards, the town can be sued so he will have to vote for this ordinance. Mayor Schwager advised that this ordinance is part of a consent agreement. Councilman Biale advised that as part of the agreement, the Borough will be allowed to use the billboard for emergency signage. Mayor Schwager advised that the zone that would allow billboards will be on Route 287. Councilman Pignatelli explained that there will be restrictions such as setback requirements for the billboards.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Levy, Pignatelli.

NEW BUSINESS:

Councilman Levy advised that he sat with members of the DOT to discuss the mitigation of traffic in town. He advised that we are never going to get rid of all the traffic. However, there are things that can be done to mitigate such as the possibility of a no left turn from Ramapo Valley Road onto Yawpo Avenue. He spoke about the possibility of getting the County and State traffic lights to "talk" to each other. He will be meeting with Captain Sanzari, Traffic Officer Fiore and Councilman Knapp to discuss what we can do in town. Councilman Pignatelli would also like to be at the meeting. Mayor Schwager would like to be there as well. Councilman Pignatelli had suggested a couple of months ago that the Borough needs a good traffic study done.

COUNCIL REPORTS:

Councilman Knapp: No report.

Councilman Levy: The Planning Board will meet tomorrow at 7 pm at the Senior Center.

Councilman Pignatelli: He advised that 35 people signed up at the carnival to participate in Green Team programs. The Green Team wants an ordinance banning plastic bags. Mayor Schwager responded that we should wait to hear what happens with the legislation which is on

the Governor's desk. Councilman Pignatelli advised that residents should go on the website and sign up to receive the town news. He stated that some residents are concerned about an elevated level contained in the water quality report. He advised that the element was only elevated in Well 5 which is a test well. It is not in our drinking water. The Environmental Commission would like to review the Water Quality Report before it is issued. Mr. Kunze asked what Environmental Commission review would accomplish. The requirements of the Consumer Confidence Report are defined. The EPA requires us to monitor various chemicals but there are no requirements for them. They are monitored so the EPA can see if they need to establish a standard. The Borough reports the results of testing to the DEP and any exceedences are noted by the DEP. Councilman Biale advised that Oakland water is fine to drink. There are stringent detailed reports that go to the DEP weekly so anything would be flagged immediately. Councilman Pignatelli commented that the Green Team was asking about the chicken ordinance. He was told that Mr. Kunze had referred that ordinance to the Board of Health for review and comment. Councilman Pignatelli advised that Boswell is doing a developability study on the Sandy Beach property.

Councilman Biale: The Senior Club will hold their annual picnic tomorrow at 1 pm. Bingo will take place on July 19th. The Senior will take a trip to the Sands Casino on August 2nd. There will be a movie day at the Senior Center on August 2nd for anyone who doesn't go on the trip. Councilman Biale congratulated the new Senior Center Director and has heard good reports from the Seniors. The DPW has put in a work order to Rockland Electric to change our 2018 allocation of LED lights. He read Orange and Rockland's suggestions on things to do to keep costs down from air conditioning. The Water & Sewer Committee will hold an important meeting on August 14th at the NWBCUA to discuss terms of an agreement for a new sewer system. Councilman Biale is happy about the renaming of the Post Office.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Pignatelli, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Levy, Pignatelli.
