ROLL CALL: Mayor Schwager called the meeting to order and the Clerk called the roll. Present: Mayor Schwager, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli. Absent: Councilman Talamini. Also Present: Lisa M. Duncan, Borough Clerk; Richard Kunze, Borough Administrator; Brian Chewcaskie, Borough Attorney.

MOMENT OF SILENCE:

MEETING ANNOUNCEMENT: Mayor Schwager announced this meeting is being held in accordance with the Open Public Meetings Law duly announced and included in the schedule of regular meetings.

MOTION TO EXCUSE ABSENCE.

MAYOR'S REPORT:

Mayor Schwager received a letter claiming she was ignoring a resident's email. She did not realize that the emails sent through the website were going into her junk email. She apologized to anyone who tried to email through the website. The resident asked why we were ignoring the sidewalk at the Ramapo River Reserve. Mayor Schwager advised that we hired a contractor but he did not submit all the proper paperwork yet. Once he does, the sidewalk will be done. Another resident complained about the traffic in the middle of town. Mayor Schwager thought that the timing on the lights could be adjusted to help traffic but it has not helped. She will have a meeting with the Public Safety Committee, the Police Captain and the Traffic Officer to discuss ways to mitigate traffic. Mayor Schwager advised that a resident in Ramapo Park complained about issues with the roads. She contacted Senator Cardinale and Assembly Auth since that is State property. Assembly Auth said he would go inspect the site and get back to the Mayor. Representatives from the Borough went to Trenton yesterday to meet with the DEP regarding sewers. The biggest issue is our treatment plants.

PRESENTATION BY COLUMBIA BANK:

Brian Gargano, Branch Manager at Columbia Bank, advised that Councilman Levy contacted him regarding a donation for the Roller Hockey Rink. Mr. Gargano presented Recreation Chairman Mike Guadagnino and Commissioners Vivan King and Sandra Coira with a check for \$25,000 for the renovation of the Roller Hockey Rink. Mr. Guadagnino thanked Columbia Bank and Councilman Levy. He thanked Vivian King for all her work as Roller Hockey Commissioner. Mayor Schwager thanked Columbia Bank as well. She advised that the Borough also received a check from the County for the project. Councilman Levy thanked John Yakimik from Boswell for cutting his fee to get this done. Mr. Yakimik advised that the re-bids will be received tomorrow. He is hoping the Borough will make out favorably with the bid tomorrow.

ENVIRONMENTAL COMMISSION UPDATE:

David Blanke, Chairman of the Environmental Commission, advised that the Environmental Commission's mission is to protect natural resources and educate residents. The Commisison is going to do a monthly sustainable tip. He spoke about food waste of 1 lb per person per day. That has a huge environmental impact because it ends up in a landfill and generates methane gas. Mr. Blanke advised that residents can compost their waste. There are bins for sale at the DPW. He explained the process to make compost and showed a sample of the soil that is generated. Councilman Kulmala sked how long it would take a family of 4 to fill the compost bin. Mr. Blanke responded he got his bin 6 months ago and it is about ¼ full. Councilman Knapp asked what is special about the bin. Mr. Blanke responded it is contained and it aerates. Mr. Blanke advised that there is an open seat on the Environmental Commission. Councilman Pignatelli advised that the Environmental Commission members have a tremendous amount of good ideas. Councilman Pignatelli composts leaves and greens. He advised that the University of Colorado has developed an enzyme that can decompose plastic. He advised that there is 9 million metric ton of plastic dumped in the ocean.

All funds taken in at the event are donated to the Mission of Honor which is an organization that gives military funerals to veterans whose remains are abandoned.

WHHEREAS, the Borough Administrator and First Aid Chief are satisfied that the procurement conducted by HGAC and the contract awarded to Bay Head Investments, Inc, d/b/a VCI Emergency Vehicle Specialists with the associated documentation submitted by both HGAC and VCI Emergency Vehicle Specialists are compliant with the guidance in LFN 2012-10; and

WHEREAS, the Borough of Oakland published a notice in the July 26, 2019 edition of the Bergen record and posted a notice on <u>www.oakland-nj.org</u> of its intent to award a contract to Bay Head Investments, Inc., d/b/a as VCI Emergency Vehicle Specialists for a new Ford F450 Model 623 Ambulance; and

WORK SESSION:

TOWING ORDINANCE:

Mr. Kunze advised that the Police Department has been working with the Borough Attorney for some time to amend the towing ordinance. Captain Sanzari has provided a memo detailing the changes. All fees are being replaced with the State towing rates. Our rates will automatically adjust when the State's fees are adjusted. Mr. Chewcaskie advised that there was an appellate decision last year regarding towing fees. This ordinance is designed to agree with the current standards. Councilman Kulmala asked if this covers 287. Mr. Chewcaskie stated it depends who calls. If the State Police call, then it will be a State tower.

ORDINANCE TO REGULATE GENERATORS:

Mr. Chewcaskie advised that this issue was brought up at the last meeting by Councilman Talamini who was aware that certain utility companies were allowing customers to use generators in non-emergency situations. The question is whether the Borough wants to enact an ordinance regulating generators in non-emergency situations. Mayor Schwager thinks more research is required. Councilman Kulmala asked for an example. Mr. Chewcaske stated that Councilman Talamini heard some companies are encouraging generator owners to come off the power grid by using the generators to power the house. Mr. Chewcaskie hasn't found evidence of that in this part of the State. Mr. Kunze will follow up with our agencies to see if this is an issue. He advised that the noice ordinance needs to be updated.

AMEND FEE ORDINANCE:

Mr. Kunze advised that the Borough created a street banner program and a town calendar. Both have fees associated and those fees must be established by ordinance. An ordinance will be introduced at the next meeting.

PROPOSAL FOR REMOVAL OF STREAM HOUSE:

Mr. Kunze advised that Connolly & Hickey met with the DEP to ascertain what permits are required for the removal of the Stream House. They have provided a proposal to cover the remainder of the design services and to handle bidding and project management services. This expense will come out of the capital ordinance. Councilman Pignatelli asked if we have already paid them to do the application and if this amount is excessive. Mr. Kunze responded that this proposal is for bid services and project oversight as well as design. A resolution will be listed on the next agenda.

NEW BUSINESS:

Mayor Schwager warned residents about a new P.S.E. & G. scam alert.

COUNCIL REPORTS:

Councilman Biale: The Senior Center summer movie is held on Mondays at 1:30 pm. The movie for August 19th will be Hidden Figures. There will be a line dancing lesson at the Senior Center on Friday August 23rd at 2 pm. There will be a seminar on the 10 Warning Signs of Alzheimers on August 15th. Name that Tune will be held August 21st at 1 pm. There is a new Arthritis Fitness Class which will be held on Fridays at 12:45. The fall trip to Paper Mill Playhouse will be held Thursday October 3rd. Rockland Electric has hired a contractor to check utility poles.

Mayor Schwager asked residents to call or email to report potholes. Mr. Kunze responded that there is also a service request function on the website to report potholes. Councilman Kulmala commented that it is a very efficient way to handle reporting of potholes.

Councilman Kulmala: Football is underway and soccer will start soon. There will be a bid opening tomorrow for the Roller Hockey improvements project. The OCC is looking for volunteers for the TV Committee. The new bulletin board is up and running. The OCC is looking for volunteers to show the OLPH mass.

Mayor Schwager advised that any other religious affiliation has the right to put their service on Channel 77 as well. Councilman Kulmala agreed that the channel is for the residents.

Councilman Pignatelli: There is no Board of Health meeting in August. The Environmental Commission thanked Councilman Levy for attending the last meeting and explaining the Allerman Brook project. The Environmental Commission had planted trees next to the brook in Great Oak Park with funding from the Roots for Rivers grant. Someone vandalized some of the trees by running over them with an ATV. These trees are starting to sprout and grow. The trees are important to shade the water for trout. The Green Team meets next week.

Councilman Levy: There is no Flood Commission meeting in August and there was no quorum for the Shade Tree Commission. The Flood Commission will meet the second Monday of September at 7:30 pm at Borough Hall. The Shade Tree Commission meets the first Monday of the month at 7 pm at Borough Hall. The Capital Projects ad-hoc committee will meet August 23rd at 10 am.

Councilman Knapp: There is an upcoming Public Safety meeting to be held at the Police Department. Councilman Knapp is trying to come up with a flag policy to standardize when the flags can be put at half-mast.

OPENED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Levy, this portion of the meeting be opened for public discussion.

ROLL CALL: All yeas, Councilmembers Biale, Knapp, Kulmala, Levy, Pignatelli.

Ryan Schwertfeger, 58 Andrew and Chairman of the Communications Commission, reiterated that the invitation stands to all houses of worship to air their services on Channel 77.

Dennis Bruger, Franklin Lakes, advised that his daughter lives on Lakeshore and was affected by Allerman Brook. He thanked everyone for helping to alleviate the situation with Allerman Brook. Councilman Levy advised a resolution was passed tonight for an emergency authorization to continue the work in Allerman Brook on the emergency permit. Mr. Bruger asked about the research done by Mr. Pritchard that he spoke at the last meeting about. Councilman Levy advised we are going to the DOT to try to get them to take some responsibility.

CLOSED FOR PUBLIC DISCUSSION:

On motion of Councilman Biale, seconded by Councilman Pignatelli, this portion of the meeting be closed to public discussion.
