Mayor Schwager informed Council that she and Councilman Biale met with the representatives of the Historical Society to discuss the position of both the Borough and the Historical Society Committee as referenced in a written agreement. Currently, they are working on funding for an emergency generator for the Senior Center through a CDBG grant. The Senior Center will be hosting Bingo on April 18th and instructional golf swing class on April 17th and April 24th. A program called Crafts and Coffee will be held every Tuesday. Starting May 7th there will be a weekly Walking Club during May and June for seniors and each week a special guest will be invited to join. Between April 1st through April 14th road surfacing for the 2018 Road Program will come to its completion. Check the list of roads affected on the DPW website. Also, you can report potholes and the location of through the DPW website. Thanks to DPW for repainting and replacing furniture at the Senior Center. A Water/Sewer meeting will be held this Friday at 9:00 a.m.

Councilman Pignatelli reported that he attended a Board of Health Meeting April 16th. The Green Team is sponsoring a Styrofoam collection on April 28th. A hazardous waste Collection will be held at Campgaw in Mahwah on May 11th, July 20th and September 14th.

Councilman Levy reported that the Flood Commission did not meet on April 8th. Shade Tree Commission is working on amending the tree ordinance. There is a Planning Board meeting tomorrow night at 7:00 p.m.

Councilman Knapp reported that there was a Public Safety Committee meeting April 8th. He praised DPW for their hard work to clean up and seed the Great Oak Lawn. This project is near completion and soon after, they can work on adding the Band Shell. A discussion ensued concerning lawn care and adding a berm around the lawn. Councilman Knapp thanked the entire fire department for their participation with practice fire drills on the homes on Roosevelt.
